11 programs, ensure that afterschool programs have the resources they need to provide the  
12 highest quality programs, to support existing afterschool programs in their efforts to expand or  
13 improve, to help launch new afterschool programs in areas of the country where there are not  
14 enough programs, and to ensure all children have access to quality, affordable afterschool  
15 programs by 2010; and

16 WHEREAS, On October 12, in a day of national activity, Lights On Afterschool will  
17 spotlight innovative, high quality afterschool programs available to communities across the  
18 country; and

19 WHEREAS, The San Francisco Unified School District, the YMCA, the Beacon  
20 Centers/SF Beacon Initiative, 21<sup>st</sup> Century Learning Centers and many other local groups are  
21 participating to make this advocacy event a success in San Francisco; and

22 WHEREAS, This event is a project of the Afterschool Alliance, sponsored by  
23 JCPenney, and co-hosted by the National Community Education Association; now, therefore,


