3 **Ordinance authorizing settlement of the lawsuit filed by Morton Weisberg against the**  
4 **City and County of San Francisco for \$50,000; the lawsuit was filed on December 23,**  
5 **2020, in San Francisco Superior, Case No. CGC-20-588596; entitled Morton Weisberg v.**  
6 **Gabriel Arteaga and City and County of San Francisco; the lawsuit involves alleged**  
7 **personal injuries from being struck by a City vehicle.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Morton Weisberg v. Gabriel Arteaga  
12 and City and County of San Francisco, San Francisco Superior Court, Case No. CGC-20-  
13 588596, by the payment of \$50,000. The lawsuit involves alleged personal injuries from being  
14 struck by a City vehicle.

15 Section 2. The above-named action was filed in San Francisco Superior Court on  
16 December 23, 2020, and the following parties were named in the lawsuit: Morton Weisberg,  
17 Plaintiff; Gabriel Arteaga, City and County of San Francisco, Defendants.
