10 Commission adopted Resolution No. 18-0074 on March 20, 2018, awarding the Terminal 2
11 Casual Dining Food & Beverage Concession Lease No. 6 to SSP America, Inc.; and

12 WHEREAS, The Terminal 2 Casual Dining Food & Beverage Concession Lease No. 6
13 has a term of ten years, and an initial minimum annual guarantee of \$250,000.00; now,
14 therefore, be it

15 RESOLVED, That this Board of Supervisors hereby approves the Terminal 2 Casual
16 Dining Food & Beverage Concession Lease No. 6, a copy of which is on file with the Clerk of
17 the Board of Supervisors in File No. 180602; and, be it

18 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by
19 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
20 inclusion into the official file.




