3 **Resolution approving the 2006/07 Community Development Block Grant (CDBG)**  
4 **Program; authorizing the Mayor, on behalf of the City and County of San Francisco, to**  
5 **apply for, accept, and expend the City's 2006/07 Community Development Block Grant**  
6 **from the U.S. Department of Housing and Urban Development (HUD) together with**  
7 **Program Income, totaling \$25,151,655; and approving an Expenditure Schedule.**

9 WHEREAS, Under Title I of the Housing and Community Development Act of 1974, as  
10 amended, and related Federal Regulations, the City and County of San Francisco is eligible to  
11 apply for and receive a Community Development Block Grant (CDBG); and,

12 WHEREAS, The City and County of San Francisco anticipates receiving \$21,869,337  
13 in 2006/07 CDBG Program funds from HUD and approximately \$3,282,318 in 2006/07  
14 program income from previous CDBG grants, for a combined total of approximately  
15 \$25,151,655; and,

16 WHEREAS, The Citizen's Committee on Community Development (CCCD) has  
17 reviewed applications and prepared recommendations for fiscal year 2006/2007 CDBG and  
18 program income funding as set forth in a recommended Expenditure Schedule, a copy of  
19 which is located in Board File No. 060409; and,

20 WHEREAS, An Environmental Review Record has been prepared by the Mayor's  
21 Office of Community Development (MOCD) and approved by the Certifying Officer for the  
22 proposed projects and activities set forth in the Expenditure Schedule with the National  
23 Environmental Policy Act (NEPA) and other applicable statutes and authorities, in particular  
24 those cited in 24 CFR Part 58 §§5 and 6, a copy of which is located in Board File No.

25 060409; and,

1 WHEREAS, The Certifying Officer shall follow the procedural provisions of NEPA to  
2 confirm that all projects funded under the CDBG Program are in compliance with applicable  
3 federal regulations and requirements; now, therefore, be it

4 RESOLVED, That the Mayor of the City and County of San Francisco is hereby  
5 authorized to apply for, accept, and expend the City's 2006 CDBG entitlement from HUD, and  
6 to accept and expend an estimated \$3,282,313 in program income generated by MOCD, the  
7 Mayor's Office of Housing and the San Francisco Redevelopment Agency, all in accordance  
8 with the Expenditure Schedule; and, be it

9 FURTHER RESOLVED, That the Board of Supervisors does hereby approve the  
10 Expenditure Schedule for recipient agencies and departments; and, be it

11 FURTHER RESOLVED, That the Mayor is hereby authorized to enter into and execute  
12 agreements between the City and County of San Francisco and various agencies and  
13 departments as more particularly set forth in the Expenditure Schedule; and, be it

14 FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation  
15 and certifications as may be requested or required by HUD, and to take such additional  
16 actions as may be required to apply for, accept and expend the 2006/07 CDBG funds  
17 consistent with this Resolution; and, be it


18 FURTHER RESOLVED, That all actions heretofore taken by the officers of the City






