

1 [Urging GGNRA to delay leash enforcement]
2 Resolution requesting the National Park Service to delay
3 enforcing, in the San Francisco parks situated in the
4 GGNRA, 36 C.F.R. 2.15, requiring pets to be on leash in
5 national parks, until the ANPR process has been completed.
6

7 WHEREAS, In 1975, the City and County of San Francisco
8 transferred Fort Funston and other City-owned park lands to
9 the federal government to be included in the Golden Gate
10 National Recreation Area (GGNRA), to be administered by the
11 National Park Service (NPS); and,

12 WHEREAS, The statute creating the GGNRA (16 U.S.C.
13 Section 460bb) specifically states that the GGNRA was
14 established to provide for the maintenance of needed
15 recreational open space necessary to the urban environment
16 and planning and requires that the Secretary of the
17 Interior "utilize the resources in a manner which will
18 provide for recreation and educational opportunities
19 consistent with sound principles of land use planning and
20 management;" and,

21 WHEREAS, Former Charter section 7.403-1(a), as
22 approved by the voters, required that the deed transferring
23 any City-owned park lands to the NPS include the

1 restriction that said lands were to be reserved by the Park
2 Service "in perpetuity for recreation or park purposes with
3 a right of reversion upon breach of said restriction;" and,

4 WHEREAS, When Fort Funston and other City-owned parks
5 were transferred to the federal government, a federal
6 regulation existed requiring all pets to be on leash in
7 federal parks, yet the NPS chose not to enforce this
8 regulation in the San Francisco City parks; and,

9 WHEREAS, In April 1978, the GGNRA stated its position
10 that "the ordinary guidelines outlined in the Code of
11 Federal regulations do not really apply in an urban area,"
12 and that "people and their animals have been visiting the
13 park for too long to apply an all-inclusive arbitrary
14 policy;" and,

15 WHEREAS, The Superintendent of the GGNRA in the spirit
16 of this statement developed a draft pet policy and
17 submitted it to the GGNRA Advisory Committee for further
18 review and public hearings; and,

19 WHEREAS, In September of 1978, after extensive public
20 hearings and public surveys, the Advisory Commission
21 proposed guidelines for a pet policy for the San Francisco
22 Unit of the GGNRA, designating Fort Funston, Lands End,

1 Ocean Beach, Fort Miley, Baker Beach, and Crissy Field for
2 continued off-leash recreation; and,

3
4 WHEREAS, On October 6, 1978, GGNRA General
5 Superintendent Lynn Thompson accepted these designations
6 with the following comment: "As you know, the Advisory
7 Commission approved the proposed guidelines for a pet
8 policy in the San Francisco Unit of the GGNRA at their
9 September 27 meeting," and she continued "We are accepting
10 in total the Commissions recommendations for each of these
11 areas;" and,

12 WHEREAS, On February 24, 1979, the GGNRA finalized the
13 pet policy for both San Francisco and Marin County,
14 establishing areas where pets could be exercised off-leash;
15 and,

16 WHEREAS, In 1982, the 1979 Pet Policy was
17 incorporated into the GGNRA Natural Resources Management
18 Plan as Appendix C; and,

19 WHEREAS, On July 8, 1992, NPS Western Regional Director
20 Stanley Albright assured U.S. Senator John Seymour that "there
21 is no change in the 1979 Pet Policy which provides the visitor
22 of walking one's dog off leash"; and,

1 WHEREAS, By letter dated July 8, 1992, Western Regional
2 Director Stanley Albright also assured U.S. Senator Cranston
3 that there would be no change in the 1979 Pet Policy; and,

4 WHEREAS, On February 5, 1999, Pacific Western Regional
5 Director John Reynolds assured U.S. Senator Dianne Feinstein
6 that the "GGNRA has adopted a pet policy that is more liberal
7 than the regulations enforced at other national park sites
8 throughout the United States, where pets are required to be
9 leashed at all times and are, for the most part, excluded from
10 all but developed areas," and the letter continued

11 "[The] GGNRA has, with the assistance of the park's Advisory
12 Commission, established a pet policy that allows some
13 opportunity for visitors to enjoy a few designated areas... as
14 voice control areas where pets are allowed off-leash;" and,

15 WHEREAS, On March 19, 1999, GGNRA Superintendent Brian
16 O'Neill stated to U.S. Congresswoman Nancy Pelosi, the "GGNRA
17 has adopted a pet policy that is more liberal than pet
18 regulations at other national park sites throughout the
19 country... Certain areas of the park have been designated as
20 voice control areas where pets are permitted off-leash;" and,

21 WHEREAS, In November of 2000, the GGNRA Advisory Committee
22 attempted to revoke the 1979 Pet Policy, but failed due to a
23 point of order; and,

24 WHEREAS, On January 23, 2001, over 1,500 people attended
25 the GGNRA Advisory Committee meeting to protest revocation of

1 the 1979 Pet Policy, Nine San Francisco supervisors spoke, and
2 both Senator Speier and Assemblyman Shelly sent letters to be
3 read by their representatives; and,

4 WHEREAS, The Advisory Committee recommended that the GGNRA
5 hold meetings with stakeholder groups within the next 120 days
6 to resolve the issue, and to not change leash enforcement for
7 this period; and,

8 WHEREAS, The Advisory Committee at this meeting did not
9 vote on the Pet Policy; and,

10 WHEREAS, Rather than hold stakeholder meetings, the GGNRA
11 received permission from Washington for a more formal process
12 called Advance Notice of Proposed Rulemaking (ANPR), but this
13 process has not begun; and,

14 WHEREAS, In November, 2001, the GGNRA began to aggressively
15 enforce the leash requirement at Fort Funston, sending teams of
16 law enforcement rangers for 2 to 3 hour segments, and issuing
17 tickets for walking dogs off-leash without initiating the ANPR
18 process in good faith with the public; and,

19 WHEREAS, Off-leash recreational users believe that off-
20 leash recreation is legal at Fort Funston, and they agreed to go
21 through the ANPR process and further rulemaking in order to
22 obtain a special rule for the GGNRA that specifically recognizes
23 that off-leash dog-walking is permissible in certain GGNRA
24 parks; and,

1 WHEREAS, The Board of Supervisors of the City and County of
2 San Francisco finds that the recent enforcement of 36 C.F.R.
3 2.15 is in contravention to the representations made to the
4 public at the Citizens Advisory Committee meeting on January 23,
5 2001; now, therefore, be it

6 RESOLVED That the Board of Supervisors of the City and
7 County of San Francisco hereby requests the National Park
8 Service not to enforce, in the GGNRA parks which were donated to
9 the federal government by the City and County of San Francisco,
10 36 C.F.R. 2.15, which requires that all pets be on leash in
11 federal parks, until the ANPR process has been satisfactorily
12 completed; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors of the City
14 and County of San Francisco hereby requests the NPS to advise
15 the Board as to the status of the ANPR process; and, be it

16 FURTHER RESOLVED, That the Clerk of the Board of
17 Supervisors shall send copies of this resolution to the offices
18 of United States Senator Dianne Feinstein, United States Senator
19 Barbara Boxer, Congresswoman Nancy Pelosi, Congressman Tom
20 Lantos, State Senator John Burton, State Senator Jackie Speier,
21 Assemblywoman Carole Migden, Assemblyman Kevin Shelley, GGNRA
22 Superintendent Brian O'Neill and the National Parks Service.
