

1 [Accept and Expend Grant - Retroactive - California Office of Traffic Safety - Alcohol and
2 Drug Impaired Driver Vertical Prosecution Program - \$420,000]

3 **Resolution retroactively authorizing the Office of the District Attorney to accept and**
4 **expend a grant in the amount of \$420,000 from the California Office of Traffic Safety,**
5 **for the grant period of October 1, 2025, through September 30, 2026, to support the**
6 **Alcohol and Drug Impaired Driver Vertical Prosecution Program activities and**
7 **services.**

9 WHEREAS, The Administrative Code requires City departments to obtain Board of
10 Supervisors' approval to accept and expend grant funds in the amount of \$100,000 or more
11 (Section 10.170 et seq.); and

12 WHEREAS, Through the Office of the District Attorney's Alcohol and Drug Impaired
13 Driver Vertical Prosecution Program, there will be a specialized prosecutor assigned to
14 address needs related to processing efficiency and complexity of alcohol and drug impaired
15 cases; and

16 WHEREAS, The Driving Under the Influence (DUI) prosecution team will handle
17 cases throughout each step of the criminal process. Prosecution team members will work
18 to increase the capabilities of the team and the office by obtaining and delivering
19 specialized training. Team members will share information with peers and law enforcement
20 personnel throughout the county and across the state. The office will accomplish these
21 objectives to prevent impaired driving and reduce alcohol and drug-involved traffic fatalities
22 and injuries; and

23 WHEREAS, The grant does not require an amendment to the Annual Salary
24 Ordinance (ASO) Amendment; and

1 WHEREAS, The grant includes indirect costs of \$35,410; now, therefore, be it
2 RESOLVED, That the Board of Supervisors hereby retroactively authorizes the
3 Office of the District Attorney to accept and expend, on behalf of the City and County of
4 San Francisco, a grant from the California Office of Traffic Safety to carry out the activities
5 and services to support the Alcohol and Drug Impaired Driver Vertical Prosecution
6 Program; and, be it
7 FURTHER RESOLVED, That should the Office of the District Attorney receive less
8 money than the awarded amount of \$420,000 that the Board of Supervisors hereby
9 approves the acceptance and expenditure by the Office of the District Attorney of the
10 reduced money.

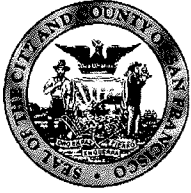
