### **David C. Goldman**

David C. Goldman has over 30 years of experience as a teacher and political activist in the Bay Area. He has taught all levels of high school mathematics, including calculus and finance to Bay Area high school students for 34 years. Mr. Goldman was the Head of the Mathematics Department at St. Josephs-Notre Dame High School in Alameda, California before becoming Director of the Advanced Placement Mathematics Program at Redwood High School in Larkspur, California, where he taught for 24 years. His political activism began as a student at University of Chicago and Stanford University where Mr. Goldman was a founding member of several LGBT organizations, including The Gay People's Union at Stanford. He served as the first Vice President of the Harvey Milk Club from (1977-1979) and was a founding member of the San Francisco Gay Men's Chorus (1978-1982). Mr. Goldman began working on the issue of medical cannabis more than twenty years ago. In 2007 he was appointed to serve on San Francisco's Medical Cannabis Working Group as a representative of the San Francisco Chapter of Americans for Safe Access. The Working Group was established to advise the Board of Supervisors in policy matters related to medical cannabis; he serves on the Core leadership group of the San Francisco Chapter of Americans for Safe Access. Since the early 1980s, Mr. Goldman has been actively working with medical cannabis advocacy groups including The Green Cross, the Cannabis Action Network, and the Marijuana Policy Project. He is also a long-term member of Cal-NORML.

My name is Shona Gochenaur and I have been a patient advocate and organizer for ten years. During this time I have worked on over fifteen pieces of cannabis related legislation including a state senate bill. I've also worked with John Conyers Jr. of the Congressional Judiciary Committee to communicate with the DEA chief. Most recently, I have been shepherding the Medical Cannabis Task Force Legislation for the last four years and am thrilled that it is coming to fruition.

Though I am currently the executive director of Axis of Love SF, I previously led ASA SF during the development of S.F. Health Article 33, also known as the 2005 MCD Act. I then went on to establish Axis as the nation's first independent patient advocacy group focusing on low income and disabled patients. Axis of Love serves these vulnerable members of society by providing low income patients with clean, safe, effective medicine free of charge, and also by offering reduced rates to veterans and elders. Our program includes harm reduction support groups with peer leadership that offer fellowship as well as compassion and a healthy meal. Our broad mission includes daily support through educational and social services so that we may offer our members the ability and opportunity to exercise a voice influencing local, state, and national government.

By developing our membership into effective community organizers and spokespersons, Axis of Love successfully blocked a price hike of the state medical cannabis ID card program, defined compassionate care for low income patients on the local level, has offered medical cannabis prisoner support to Ed Rosenthal, Steve Kubby, and Steph Landa, and held a media event that was not only nationally televised by CNN, but globally broadcast in Europe, India, Russia, and Africa.

I would take great pride in continuing to serve my community as a member of the Medical Cannabis Task Force.

I, Mary Schroeder, am applying for Seat #4 on the Medical Cannabis Task Force as a representative from a hospice and residential care facility. I work as Program Director at Maitri Compassionate Care Residential Facility for Persons with advanced HIV/AIDS. Maitri has an emphasis on hospice and end of life care. In my capacity as Program Director at Maitri, I coordinate the compassionate care Medical Cannabis program. The Medical Cannabis program requires that I serve as liaison with the Medical Cannabis provider and residents at Maitri. I educate residents regarding Maitri's internal policies for use of Medical Cannabis and I enforce those policies as well.

I have worked with people living with HIV/AIDS since 1988. During that time I served as Treatment Educator at Mission Neighborhood Health Center's (MNHC) HIV clinic. As Treatment Educator I referred clients to Medical Cannabis clinical research trials, predominantly the ground-breaking in-patient trial at San Francisco General Hospital. As Health Educator at the San Mateo County AIDS clinics, I also educated and referred clients to clinical trials of Medical Cannabis. In my positions at Mission Neighborhood Health Center and the San Mateo County AIDS clinics, I facilitated Medical Provider authorization for the use of Medical Cannabis.

My work has familiarized me with the medical benefits and various limitations of Cannabis. My current professional role qualifies me for the seat designation, and my work experience has directly involved the intersection of illness and health and Medical Cannabis. ## Biography of Applicant

My name is Raymond Gamley – I am the Director of The Divinity Tree Coop at 958 Geary St. The Dispensary was formed in 2005 by Charles Pappas, my friend since 1970, and a great influence in my life. Charley sustained a catastrophic spinal cord injury in 1973; this obviously dictated a new way of life for Charley, and shortly after Charley moved to Berkeley because of its' progressive views regarding wheelchair-bound people, I joined him to help, in essence, reorient his life.

There is much I could say about the 35 years we have lived in the Bay Area, but since the question at hand is the medical use of Cannabis, I will relate our initial use in that matter. Charley suffered spasms that would uncontrollably affect his limbs and torso, making what should have been a facile task for someone in a wheelchair become an arduous one. And these spasms had increased to dozens per hour at times. When someone suggested Cannabis, Charley felt it was something he should pursue, and thankfully, the Cannabis decreased the spasms to a few dozen a day – a very dramatic decrease by anyone's standards.

Through the years Charley and I both became increasingly interested in the medical benefits of Cannabis, and even more so in the tremendous potential of this plant, as well as it's cousin, industrial hemp, which could create a new industry for farmers, practically overnight. By the way, the United States imports approx. 15 billion dollars of hemp each year from China, as well as another five billion from Canada, who represents the largest lobbyists against the legalization of hemp in our country.

But medical Cannabis is what concerns us. There is such potential in this lightly researched field. I would be honored to be granted a seat on this Task Force, and I can assure you I would do all I can to bring you the latest research on this front, regardless of outcome. These are such important times regarding medical cannabis – we all must do our best to understand the possible benefits of this "new" medicine and implement its' promise and progress.

And, of course, being the director of an MCD, I would do all I could to help the City understand the workings of a dispensary. I think that there is much that can be done by dispensaries to provide only the highest grade medicine – and, though counterintuitive, it seems quite possible to lower the cost of this medicine at the same time. I also feel the MCDs' could give back to our communities in a variety of ways, my own favorite would be to establish a Scholarship fund to benefit low income children wanting to pursue their education on the collegiate level.

An addendum: if there is an occasion that I could not attend a meeting, Charles would be thrilled to take my chair. We would have liked to have been co-chairs for the seat, but it is very difficult at times for Charles to get places early in his day.

I would like to thank you for your consideration for the National Policy Organization seat on the San Francisco Medical Cannabis Task Force.

I am blessed to have been born, raised, and educated in San Francisco. As a life long resident of the Mission District, I have gotten to experience a bi-lingual education, and had the opportunity participate in variety of diverse events; from dancing in Carnival to participating in peace marches.

Unhappy with my life circumstances as a teenager, I chose to take the California High School Proficiency Exam at the age of 15, and jumped from an academic high school to full time student at SF City College. I graduated with my associates degree, and transfer credits a week after my 19<sup>th</sup> birthday. A few months later I was in a car accident which left me on a quest to self healing. After visiting dozens of professionals, and sampling even more prescription drugs, I found that medical cannabis was the best way to manage my fibromyalgia symptoms without life altering side effects.

## Patrick D. Goggin - Bio

While majoring in History at U.C. Santa Barbara during the winter quarter of 1989, Patrick Goggin was deeply moved by an upper division class he took -- the History of Wilderness and Civilization. The following quarter, he interned for U.S. Representative Mel Levine, researching and writing a paper on the California offshore oil-drilling controversy and the drilling moratorium spearheaded by Rep. Levine earlier in the decade.

After graduating in 1990 with a B.A. in History, Mr. Goggin attended Lewis and Clark Law School in Portland, Or. in fall 1992. There, he specialized in environmental law obtaining his Environmental Law Certificate along with his J.D. in December 1995. During fall 1994, Mr. Goggin performed an externship in Washington, D.C, with the Department of Justice, Civil Division, Torts Branch, Aviation and Admiralty Section. There, he assisted in litigation seeking compensation from responsible parties for oil and toxics spills under the Oil Pollution Act of 1990.

In June 1996, Mr. Goggin was admitted to the California State Bar. Immediately thereafter, he went into private practice with his father, handling a modest caseload of criminal defense and civil matters until June 2001. In 1997, representing a property owner and a swimmer, they filed suit against two (2) water districts seeking federal (Clean Water Act) and state remedies (*Morris-Smith, et al. v. Moulton Niguel Water District, et al.*) for their repeated raw sewage discharges into the most coli form polluted creek in the state, Aliso Creek. After the water districts made significant upgrades to their systems (estimated at \$1.5 million) the district court dismissed the action. Attempting to seek over \$200,000 in attorney fees, Mr. Goggin successfully argued at the hearing on the motion to defeat it. The court issued a published Order Denying Defendants' Motion for Attorney Fees, 44 F.Supp.2d 1084 (C.D. Cal.) 1999. Additionally, Mr. Goggin prepared the briefs on appeal in this case as well as conducting oral arguments before the Ninth Circuit Court of Appeals panel in Pasadena in 2000.

In late 2001, as local counsel and on behalf of the Hemp Industries Association (HIA), Mr. Goggin filed a petition in the Ninth Circuit against the Drug Enforcement Administration challenging its proposed rules that would have banned the human



consumption of industrial hemp food (seed and oil) and body care products. HIA prevailed in two (2) separate matters, including two published decisions (see HIA v. DEA I cite; *Hemp Indus. Ass'n v. DEA*, 357 F.3d 1012 (9<sup>th</sup> Cir. 2004)) and won its motion for attorney fees.

Between 2005 and 2007, Mr. Goggin served as California counsel for HIA and Vote Hemp (the industry's lobbying arm) shepherding AB 1147 (2005/6) and AB 684 (2007) (California Industrial Hemp Farming Act—co-authored by Assemblymen Mark Leno (D-San Francisco) and Chuck DeVore (R-Orange County)) through the state legislature; both bills made it through the legislature only to be vetoed by the Governor.

In the summer of 2005 Mr. Goggin began working in the medical cannabis area - first advocating for reasonable MCDC regulations. Between 2006 and 2010 he has successfully assisted all four of his San Francisco MCDC clients to obtaining final permits.

I have been living in San Francisco since 1995. In 2005 I started working on cultivation projects for low income patients as a trimmer. Then I learned other skills involved in cultivation such as cloning, planting, irrigation, the ability to have a pesticide free garden, and the final stage of curing the dried medicine for consumption. I have passed on this knowledge to other low income cultivators as a peer. My perspective is that I am one of them.

Though I am often cultivating, I have been actively involved in MOOC (Marijuana Oversight Offense Committee) since its first seating, working on behalf of low income patients in San Francisco. Also, I have been a patient board member of Axis of Love SF since the first meetings. One of the programs I have created for low income patients with Axis of Love is a chess club. I have worked with ASA SF on events and membership meetings since 2006. I have been engaged and following NORML since 1979 when I was living in New York. I am a member of the Harvey Milk LGBT Democratic Club and a voting member of the cannabis caucus for the last four years.

Volunteer activities that are not cannabis related include helping organize the annual Harvey Milk fundraising dinner for the last three years. I have also qualified for the Harvey Milk PAC in 2010. Also, I volunteered to entertain at the Bernal Heights Festival making balloons, and dressing as a clown. I have done this at UCSF daycare and at the SF Pride Parade. ## **Bio – Stewart Rhoads**

Advancing cannabis cultivation technique has been the focus of my professional and academic efforts since I got involved with the medical cannabis movement in the Spring of 2000. At the outset my primary concerns were cleanliness, grade, and variety of strains (cannabinoid profiles), yielding results considered desirable by patients consuming the medicine. Though my efforts were met with success, it soon became apparent that cannabis “farming” was quite sophisticated. A course sequence intended to educate the professional grade cultivator and researcher needed to draw on the disciplines of Physics, Chemistry, Mathematics, and Biology. Furthermore, it seemed that the future development of cannabis based medicines would increasingly rely on chemical analysis, extraction, and synthesis. Pursuing a degree in Chemistry appeared to serve the demands of my present endeavors, while affording new opportunities as the legalization of medical cannabis unfolded.

---

From Autumn 2002 through Spring 2005 I continued to reside in S.F, operate and cultivate for the Northstar Patient Collective (NPC), also in SF, and attend Stanford University, graduating with a 3.2 GPA (within the major) and a B.S. in Chemistry. Since then I have continued independent academic study on the topics of electrical conduction, thermodynamics, and plant physiology.

Upon graduation, I renewed my relationship with Steve and Cathy Smith of HopeNet to become one of their most consistent compassionate providers of free medicine. Their leadership role in the SF patient community inspired me to realize that breaking cannabis related law is only palliative, and that true progress will occur by shaping and implementing cannabis law on the municipal, county, state, and federal level. In the wake of legal decisions forbidding solvent based cannabis chemistry, with the interest of preserving my ability to engage in constructive political efforts, and in the hope of insulating the patients and operators in my circle from enforcement related harm, I renounced my previous desire to pursue achievements in cannabinoid extraction, isolation, and compounding, and will continue to refrain from such involvement until therapeutic usage of cannabis is legal by federal law.

When the Medical Cannabis Working Group (MCWG) invited cultivators to participate in the conversation, it presented me with a significant quandary. Medical cannabis cultivators currently suffer from raids, property seizure, and prosecution even in the progressive, trend-setting City and County of San Francisco. Having made every effort to operate responsibly, I had, and to this date have never had an encounter with law enforcement. Employing a quiet, conservative approach to cultivation was partly a function of my mild-mannered nature, yet was also consequential of the persistent fear that I would lose my educational opportunity from '02-'05. Living the bizarre juxtaposition of being an honest, high achieving, compassionate “criminal” was formative. The opportunity to involve myself in a formal political process was too great to resist though, so in July of 2009 I began attending MCWG meetings.

As the current chair of the Cultivation Subcommittee (SOC), I am totally committed to the development of sensible policy regarding cultivation. The SOC has prepared the following endorsement of my capabilities:

"Stewart Rhoads has earned the full and undivided support of the subcommittee because he possesses strong leadership skills. Stewart is a consensus builder who exhibits well developed analytical ability and a willingness to listen to differing viewpoints as well as the capacity to identify common ground to build on. He has proven himself to us without reservation as the person best equipped to represent the cultivation community as a whole. Stewart is an accomplished cultivator with bona fides in the community of compassionate caregivers. He has a degree in chemistry from Stanford University and brings a refreshingly bright and positive perspective to the set of problems and difficulties particular to the cultivator in the City of San Francisco. We enthusiastically support him for the 'MCD cultivator' seat on the task force to represent the SF Medical Cannabis Cultivation Community."

In addition, the MCWG has voted to recommend me for the Medical Cannabis Dispensary Cultivator position with 71% in favor.

---

As of March 2010, the SOC has held weekly meetings since late December, and is already hard at work addressing the issues of the City and County of San Francisco in relation to the medical cannabis cultivation community. The Cultivation Safety Guidelines, co-authored by Steve Smith and I, have been improved by feedback received from the Department of Building Inspection and are currently circulating in the MCWG so as to further assist in their development. I hope that these guidelines may initiate a dialogue between city government and the cultivation community so as to advance the cause of public safety and invite cultivators to view the City as an entity they may cooperate with, without fear of reprisal. Other projects of ours include the facilitation of Marijuana Offense Oversight Committee business, as well as participation in cultivation regulation discussions in the City of Berkeley. By continuing to invest in relationships with formal bodies in and outside of SF, and by partnering with Axis of Love as one of the foremost patient advocacy organizations in SF, we hope to contribute a wealth of experience and breadth of perspective that will effectively promote the interests of patients, MCDs, and cultivators, all of whom are indispensable participants in advancing the cause of medical cannabis.

In conclusion, I sincerely hope to combine my communication skills, replete knowledge of the political history of medical cannabis, and established relationships in the community with a thorough technical understanding of cultivation and its legal implications to further the development of sound policy. I am qualified for Seat #12 of the Medical Cannabis Task Force after more than 40 years of activism in drug treatment and the marijuana movement.

I have been a member of Supervisor David Campos's Medical Cannabis Working group since its inception, helping set up this Task Force. I also participated in the various medical marijuana working groups led by D.A. Terence Hallinan, Supervisor Mark Leno, and Supervisor Ross Mirkarimi, to bring about local MCD regulations.

When I was 11, I founded the 1<sup>st</sup> Alateen program in San Antonio. I helped found the San Antonio Free Clinic in the early 1970's. I was the Director of Press Relations for the National Free Clinic Council in 1971-72. I moved to Washington, DC, where I worked for the National Coordinating Council on Drug Education.

I moved to San Francisco in 1972 to work on Proposition 19, which would have legalized marijuana. I have worked on marijuana law reform every day since then. In the 1980s I worked on Jack Herer's initiatives and I was on the small committee of activists who drafted Proposition 215.

I have been a member of the Board of Directors of California NORML from 1978-1989 and 2004-present. I am also a member of the advisory board of Patients Out of Time, the national organization that helps the Federal IND patients and advocates for medical cannabis use.

I was on the San Francisco Drug Abuse Advisory Board for 7 years, and helped make harm reduction strategies (bleach outreach, needle exchange, etc.) part of City policy. I was Co-founder and President of Aids Prevention Action Network, a group of seven needle exchanges, in the 1990s.

- (5) Develop and make recommendations regarding medical cannabis cultivation, production and baking guidelines for medical cannabis dispensaries.
- (6) Develop and make recommendations regarding cultivation and distribution of medical cannabis by individual patients, caregivers or small collectives that may fall outside the definition of a medical cannabis dispensary under the City's Health Code.
- (7) Develop and make recommendations regarding the cultivation of medical cannabis, particularly in residential dwellings, that may violate the City's Planning Code or applicable San Francisco or California Building Code requirements.
- (8) Develop and make recommendations regarding the taxation of medical cannabis lawfully dispensed or cultivated in the City and County.

Report: During each year of its operation the Task Force shall submit to the Board of Supervisors an annual report summarizing its recommendations.
