

1 [Bay Trail - Grant Acceptance]
2 AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS (DPW) TO ACCEPT AND
3 EXPEND A GRANT FROM THE ASSOCIATION OF BAY AREA GOVERNMENTS (ABAG)
4 FOR IMPROVEMENTS TO THE BAY TRAIL, APPROVING THE ABAG BAY TRAIL GRANT
5 CONTRACT, AUTHORIZING THE DIRECTOR OF DPW TO EXECUTE THE BAY TRAIL
6 GRANT CONTRACT, MAKING FINDINGS OF CONFORMITY OF THE BAY TRAIL
7 IMPROVEMENTS WITH THE GENERAL PLAN, AND URGING ALL RELEVANT CITY
8 DEPARTMENTS, AGENCIES, AND COMMISSIONS TO MOVE EXPEDITIOUSLY IN
9 APPROVING ANY BAY TRAIL IMPROVEMENTS RELATED TO THIS ABAG GRANT.
10 WHEREAS, The Bay Trail is a 510-mile hiking, bicycling, and recreational trail that circles San
11 Francisco Bay; and,
12 WHEREAS, The Bay Trail provides a unique opportunity to San Francisco and visitors
13 to view and enjoy the scenery of San Francisco and San Francisco Bay; and,
14 WHEREAS, The Association of Bay Area Governments (ABAG) administers grant
15 programs to improve and implement segments of the Bay Trail; and,
16 WHEREAS, The Department of Public Works has applied for and ABAG has provided
17 a grant in the amount of TWO HUNDRED THIRTY-SIX THOUSAND THREE HUNDRED
18 TWENTY-EIGHT DOLLARS (\$ 236,328.00) to San Francisco to improve a portion of the Bay
19 Trail as shown on a plan on file with the Clerk of the Board of Supervisors in file No.
20 990173; and,
21 WHEREAS, The Department of Public Works desires to accept the ABAG Bay Trail
22 grant by entering into a contract with ABAG so that the Department may coordinate with other
23 City agencies, departments, and commissions to implement portions of the Bay Trail in San
24 Francisco; and,

1 WHEREAS, The Department of Public Works urges the Board of Supervisors to accept
2 the ABAG grant on behalf of the City and County of San Francisco by approving the ABAG
3 Bay Trail contract, which is herein by reference and on file with the Clerk of the Board of
4 Supervisors in file No. 990173; and,

5 WHEREAS, The contract contemplates the City and County of San Francisco
6 indemnifying ABAG and the Bay Trail for any claims related to the Bay Trail improvements to
7 be funded through the grant; and,

8 WHEREAS, The Planning Department has determined that the Bay Trail improvements
9 that would be funded by this grant are in conformity with the General Plan and Eight Priority
10 Policies. Said determination is incorporated herein by reference and on file with the Clerk of
11 the Board of Supervisors in file No. 990173; and,

12 WHEREAS, The Board of Supervisors desires that all relevant City departments,
13 agencies, and commissions move expeditiously in approving any Bay Trail improvements
14 related to this ABAG grant; now, therefore, be it

15 RESOLVED, That the Board of Supervisors authorizes the Department of Public Works
16 to accept and expend the ABAG Bay Trail grant in the amount of TWO HUNDRED THIRTY-
17 SIX THOUSAND THREE HUNDRED TWENTY-EIGHT DOLLARS (\$ 236,328.00)) on behalf
18 of the City and County of San Francisco for Bay Trail improvements; and, be it

19 FURTHER RESOLVED, That the Board of Supervisors approves the ABAG Bay Trail
20 grant contract, which is on file with the Clerk of the Board of Supervisors in file No.
21 990173; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of the
23 Department of Public Works to execute the contract on behalf of the City and County of San
24 Francisco, to accept provisions of the contract concerning indemnification of ABAG and the
25 Bay Trail, and to implement the Bay Trail improvements associated with the grant; and be it


1 FURTHER RESOLVED, That the Board of Supervisors adopts as its own the
