12 WHEREAS, The Airport Commission approved Resolution No. 14-0046, adopted
13 March 18, 2014, awarding the Boarding Area C Coffee Shop Lease to Green Beans Coffee
14 Osteria - SFO Group; now, therefore, be it

15 RESOLVED, That the Board of Supervisors hereby approves the Boarding Area C
16 Coffee Shop Lease, copies of which are contained in Board of Supervisors' File No. 140456,
17 for a ten year term with an annual rent of \$52,176 for FY2014-2015; and, be it

18 FURTHER RESOLVED, That within thirty (30) days of the lease being fully executed
19 by all parties the Airport Commission shall provide the final agreement to the Clerk of the
20 Board for inclusion into the official file.


