3 **Resolution authorizing the Department of the District Attorney of the City and County**  
4 **of San Francisco to retroactively accept and expend a grant in the amount of \$110, 000**  
5 **through the California Office of Criminal Justice Planning for the operation of a**  
6 **program entitled “Special Emphasis Victim Assistance Program: Elder Abuse.”**

8 WHEREAS, The City and County of San Francisco desires to continue a certain project  
9 designated the San Francisco Special Emphasis Victim Assistance Program: Elder Abuse, to  
10 be funded in part from funds made available through the Office of Criminal Justice Planning  
11 (OCJP); and,

12 WHEREAS, OCJP requires that the City and County of San Francisco, through the  
13 Office of the District Attorney, provide no less than a twenty-percent in-kind match for the  
14 grant; and

15 WHEREAS, All positions supported by these funds shall be coded “G” in the District  
16 Attorney’s budget; and,

17 WHEREAS, The terms of the grant prohibit inclusion of indirect costs in the grant  
18 budget; now, therefore, be it

19 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of  
20 the City and County of San Francisco to retroactively accept and expend funds from OCJP for  
21 the purposes of special emphasis victim assistance program: elder abuse; and be it

22 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
23 indirect costs in the grant budget; and be it

24 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of  
25 the City and County of San Francisco the necessary Grant Award Agreements for special



6 purpose of securing Special Emphasis Victim Assistance Program: Elder Abuse grant funds  
7 and to implement and carry out the purposes specified in the applicable grant application; and  
8 be it

9 FURTHER RESOLVED, That any liability arising out of the performance of the Grant  
10 Award Agreement, including civil court actions for damages, shall be the responsibility of the  
11 grant recipient and the authorizing agency; and be it


12 FURTHER RESOLVED, That grant funds received hereunder shall not be used to


