1 [Charter Amendment - Department, Board, Commission, and Advisory Body Updates]

3 **Describing and setting forth a proposal to the voters at an election to be held on November**
4 **3, 2026, to amend the Charter of the City and County of San Francisco by 1) requiring or**
5 **authorizing the Board of Supervisors to amend specified initiative ordinances; 2)**
6 **transferring from the Charter to the Municipal Code certain commissions and advisory**
7 **bodies, in some cases with modified functions; 3) requiring that the Commission**
8 **Streamlining Task Force be convened every ten years; 4) removing the general**
9 **requirements that boards and commissions develop and keep an annual statement of**
10 **purpose, appoint an executive secretary, and prepare an annual report; 5) changing the**
11 **membership qualifications, composition, and member selection process for certain bodies;**
12 **6) eliminating, consolidating, and changing the functions and authorities of certain bodies;**
13 **7) changing the planning and reporting schedule of the Department of Children, Youth,**
14 **and Their Families (“DCYF”) and related policy bodies, and changing the names but not**
15 **the functions of those related policy bodies; 8) specifying that elected members of the**
16 **Retirement Board, Health Service Board, and Retiree Health Care Trust Fund Board may**
17 **be removed only for official misconduct; 9) making various changes to departments’**
18 **operations and reporting requirements; 10) updating the Public Utilities Commission’s**
19 **exclusive charge over matters related to water, power, and sewer infrastructure and**
20 **services; 11) providing that the Board of Supervisors shall approve settlements or**
21 **dismissals of legal proceedings recommended by the City Attorney by resolution, rather**
22 **than by ordinance; 12) authorizing the City Administrator to conduct real estate strategic**
23 **planning and to negotiate and manage acquisitions, leases, and conveyances of City real**
24 **property; and 13) making clarifying edits, deleting obsolete language, and updating out-of-**
25 **date references in various sections.**

BOARD OF SUPERVISORS

Section 1. The Board of Supervisors hereby submits to the qualified voters of the City and County, at an election to be held on November 3, 2026, a proposal to amend the Charter of the City and County by:

(1) revising Sections 2.101, 2.104, 2.105, 2.109, 3.103, 4.100, 4.100.1, 4.102, 4.104, 4.105, 4.111, 4.112, 4.114, 4.120, 4.121, 4.123, 4.127, 4.133, 4.135, 4.136, 4.140, 5.104, 5.105, 5.106, 6.102, 8.103, 8A.101, 8A.102, 8A.103, 8A.104, 8A.105, 8A.106, 8A.107, 8A.111, 8A.113, 8B.120, 8B.121, 8B.122, 8B.123, 8B.124, 8B.125, 8B.126, 9.109, 9.114, 9.115, 9.116, 9.119, 12.100, 12.200, 12.202, 12.203; 12.204, 13.110, 15.105, 16.107, 16.108, 16.108-1, 16.114, 16.127-1, 16.128-4, 16.128-6, 16.128-7, 16.128-8, 16.128-11, 16.130, 18.100, A7.204, A8.420, A8.423, A8.425, A8.428, A8.429, F1.101, F1.102, F1.103, F1.104, F1.105, F1.106, and F1.108;

(2) deleting Sections 16.127-2, 16.127-4, 16.127-7, 16.127-8, and 16.127-12; renumbering 16.127-3 as 16.127-2, 16.127-5 as 16.127-3, 16.127-6 as 16.127-4, 16.127-9 as 16.127-5, 16.127-10 as 16.127-6, and 16.127-11 as 16.127-7, and revising renumbered 16.127-2, 16.127-3, 16.127-4, 16.127-5, 16.127-6, and 16.127-7;

(3) deleting Sections 4.103, 4.139, 4.141, 8A.100, 16.103, 16.128-13, 18.104, 18.109, 18.110, 18.112, 18.113, A8.346, A8.409-6, and D3.750-5;

(4) adding Sections 14.101.1 and 18.116;

(5) transferring the following Sections as amended to the Administrative Code: Sections 4.111, 4.120, 4.121(f), , 8B.123(b), 8B.125(c), 9.114, 9.115, 9.116, 16.107(i), 16.128-11, and F1.108;

(6) transferring Section 8A.111 as amended to Division II of the Transportation Code; and

1 (7) revising Section 3.104, if the voters also approve the measure titled “Modernizing
2 City Contracting,” at the November 3, 2026 election; all to read as follows:

8 **SEC. 2.101. TERM OF OFFICE.**

9 (a) Each member of the Board of Supervisors shall be elected at a general election and
10 shall serve a four-year term commencing at noon on the eighth day in January following election
11 and until a successor qualifies. ~~The respective terms of office of the members of the Board of~~
12 ~~Supervisors in effect on the date this Charter is adopted shall continue.~~

13 (b) No person elected or appointed as a Supervisor may serve as such for more than two
14 successive four-year terms. Any person appointed, elected, or any combination thereof to the
15 office of Supervisor to complete in excess of two years of a four-year term shall be deemed, for
16 the purpose of this section, to have served one full term. No person having served two successive
17 four-year terms may serve as a supervisor, either by election or appointment, until at least four
18 years after the expiration of the second successive term in office. Any Supervisor who resigns
19 with less than two full years remaining until the expiration of the term shall be deemed, for the
20 purposes of this section, to have served a full four-year term.

21 **SEC. 2.104. QUORUM.**

22 (a) The presence of a majority of the members of the Board of Supervisors at a
23 regular or special meeting shall constitute a quorum for the transaction of business. The term
24 “presence” shall include participation by teleconferencing or other electronic means as
25

1 authorized by state law Government Code Section 54953(b) or any successor legislation after the
2 Board of Supervisors has adopted an ordinance pursuant to subsection (c) allowing such
3 participation when the member is physically unable to attend in person, as certified by a health
4 care provider, due to the member's pregnancy, childbirth, or related condition. The Board of
5 Supervisors may also, as part of a parental leave policy adopted pursuant to subsection (c),
6 authorize a member to participate in meetings by teleconferencing or other electronic means
7 when the member is absent to care for ~~their~~*his or her* child after birth of the child, or after
8 placement of the child with the member or the member's immediate family for adoption or foster
9 care. In the absence of a quorum, a smaller number of members may compel the attendance of
10 absent members in the manner and under the penalties established by the Board of Supervisors.

11 (b) The Board of Supervisors shall act by a majority, ~~two thirds, three fourths, or~~
12 ~~other~~ vote of all members of the Board, unless a different vote threshold is provided in the
13 Charter, in state law, in a voter-adopted ordinance for purposes of amending only that voter-
14 adopted ordinance, or by motion for purposes of enacting, amending, or waiving Board rules
15 only. Each member present at a regular or special meeting shall vote "yes" or "no" when a
16 question is put, unless excused from voting by a motion adopted by a majority of the members
17 present. This provision does not limit the obligation of a member to recuse themselves from a
18 matter if their participation would violate City or state law, including but not limited to City or
19 state law pertaining to conflicts of interest.

20 (c) Notwithstanding the provisions of Charter Section 10.101, the Board of
21 Supervisors shall adopt parental leave policies for its members, including, but not limited to,
22 authorization to participate in meetings by teleconferencing or other electronic means pursuant to
23 subsection (a) and subject to the restrictions listed in that subsection.

24 25 **SEC. 2.105. ORDINANCES AND RESOLUTIONS.**

1 * * * *

2 The Board of Supervisors shall act only by written ordinance or resolution, except that it
3 may act by motion on matters over which ~~it the Board of Supervisors~~ has exclusive jurisdiction.
4 All legislative acts shall be by ordinance. An ordinance or resolution may be introduced before
5 the Board of Supervisors by a member of the Board, a committee of the Board, the Mayor, or the
6 Commission Streamlining Task Force subject to the limitations set forth in Section 4.100.1, and
7 shall be referred to and reported upon by an appropriate committee of the Board. An ordinance
8 or resolution may be prepared in committee and reported out to the full Board for action,
9 consistent with the applicable public notice laws ~~of the City~~. Except as otherwise provided in this
10 Charter, passage of an ordinance or a resolution shall require the affirmative vote of a majority of
11 the members of the Board.

12 An ordinance shall deal with only one subject matter, except that appropriations
13 ordinances may cover appropriations with respect to any number of subjects. The title of each
14 ordinance shall clearly reflect the content of the ordinance.

15 Except as otherwise provided in Section 2.107, passage of an ordinance shall require two
16 readings at separate meetings of the Board ~~of Supervisors~~, which shall be held at least five days
17 apart. If an ordinance is amended at its second reading, the ordinance shall require a further
18 reading prior to final passage. Resolutions shall require only one reading and may be passed
19 ~~adopted~~ upon introduction without reference to committee by unanimous affirmative vote of the
20 members of the Board ~~of Supervisors~~ who are present, but in no event less than a quorum.

21 Ordinances and resolutions passed by the Board may be enacted after presentment to the
22 Mayor as provided in Section 3.103. Ordinances shall take effect no sooner than 30 days after
23 enactment following the date of passage except for ordinances not subject to referendum and
24 those authorizing bonded indebtedness and lease financings, which shall take effect immediately.
25 Ordinances granting franchises shall take effect no sooner than 60 days after their enactment.

1 ~~passage~~. No ordinance granting a franchise may be passed within 90 days of its introduction.
2 Resolutions may take effect immediately after their enactment~~upon passage~~, or at such other
3 time as shall be specified in the resolutions.
4

5 **SEC. 2.109. RATES, FEES, AND SIMILAR CHARGES.**

6 Within 30 days of submission by the Mayor, the Board of Supervisors shall approve by
7 ordinance or reject any rate, fee or similar charge to be imposed by any department, official,
8 board or commission, except those rates, fees, and similar charges established by the Port or
9 Airport Commissions, or under the Refuse Collection and Disposal Ordinance No. 083~~of~~
10 ~~November 8, 1932~~, as amended.
11

12 **SEC. 3.103. PRESENTMENT OF LEGISLATION TO THE MAYOR; VETO** 13 **POWER.**

14 Any ordinance or resolution passed by the Board of Supervisors shall be promptly
15 delivered to the Mayor for consideration. If the Mayor approves the ordinance or resolution, the
16 Mayor shall sign it and it shall become enacted and take ~~effective~~ as provided in Section 2.105
17 and Section 2.107 of this Charter. If the Mayor disapproves the ordinance or resolution, the
18 Mayor shall promptly return it to the Board of Supervisors without the Mayor's signature,
19 accompanied by a statement indicating the reasons for disapproval and any recommendations
20 which the Mayor may have. Any ordinance or resolution so disapproved by the Mayor shall
21 become effective only if, subsequent to its return, it shall be passed by a vote of the Board of
22 Supervisors required by Section 2.106 of this Charter. Any ordinance or resolution shall become
23 effective, with or without the Mayor's signature, unless it is disapproved by the Mayor and
24 returned to the Board of Supervisors not more than ten days after the date the ordinance or
25 resolution was delivered to the Mayor's Office for consideration.

2 **SEC. 4.100. GENERAL.**

3 In addition to the office of the Mayor, the executive branch of the City and County shall
4 be composed of departments, appointive boards, commissions, and other units of government
5 that perform the sovereign powers of the City and County. To the extent law permits, each
6 appointive board, commission, or other unit of government of the City and County established by
7 State or Federal law shall be subject to the provisions of this Article IV and this Charter. The
8 Board of Supervisors, by ordinance, may change the name of any department, board,
9 commission, or other unit of government, including a name assigned in the Charter.

10
11 **SEC. 4.100.1. COMMISSION STREAMLINING TASK FORCE.**

12 (a) **Establishment of the Task Force.** By no earlier than January 1, 2035, and no later
13 than February 1, ~~2025~~2035, and at ten year intervals following those dates, a Commission
14 Streamlining Task Force (“Streamlining Task Force”) shall be convened for the purpose of
15 advising the Mayor and the Board of Supervisors on ways to eliminate, consolidate, or limit the
16 powers and duties of appointive boards and commissions for the more effective, efficient, and
17 economical administration of City and County government, and introducing one or more
18 ordinances to effectuate its recommendations. Once convened, The-the Streamlining Task Force
19 shall have the powers and duties set forth herein, ~~and shall expire by operation of law for a~~
20 period of 24 months after following its first meeting. The Streamlining Task Force existing at
21 the time the amendment of this Section 4.100.1 at the November 3, 2026 election goes into effect
22 shall automatically expire on January 1, 2027.

23 ~~The City Administrator shall provide administrative support to the Streamlining Task~~
24 ~~Force.~~ The Controller and the City Administrator shall provide administrative, professional, and
25 technical assistance to the Streamlining Task Force. All City and County officials, departments,

1 and other agencies, and all appointive boards and commissions, shall cooperate with the
2 Streamlining Task Force as it performs its responsibilities under this Section 4.100.1.

3 For purposes of this Section 4.100.1, an “appointive board” or “commission” includes
4 any body that meets the definition of a “legislative body,” under California Government Code
5 § 54952, as may be amended, whether denominated a “board,” “commission,” “council,”
6 “committee,” “task force,” “advisory body,” or otherwise.

7 (b) **Composition of the Streamlining Task Force.** The Streamlining Task Force shall
8 consist of five members. Seat 1 shall be held by the City Administrator or the City
9 Administrator’s designee, who must be an employee of the Office of the City Administrator. Seat
10 2 shall be held by the Controller or the Controller’s designee, who must be an employee of the
11 Office of the Controller. Seat 3 shall be held by the City Attorney or the City Attorney’s
12 designee, who must be an employee of the Office of the City Attorney. Seat 4 shall be held by a
13 representative of organized labor representing the public sector, appointed by the President of the
14 Board of Supervisors. Seat 5 shall be held by an individual with expertise in open and
15 accountable government, appointed by the Mayor. The Mayor’s appointment shall not be subject
16 to rejection by the Board of Supervisors under Charter Section 3.100(18). Members in seats 4
17 and 5 shall serve at the pleasure of their appointing authority.

18 ~~(c) **Budget and Legislative Analyst Report.** The Streamlining Task Force shall~~
19 ~~undertake a comprehensive review of the City and County’s appointive boards and commissions,~~
20 ~~including those created by voter approved ordinance. To inform that review, by no later than~~
21 ~~September 1, 2025, the Budget and Legislative Analyst shall prepare and submit to the~~
22 ~~Streamlining Task Force, the Mayor, and the Clerk of the Board of Supervisors a report that~~
23 ~~assesses for each appointive board or commission established in the Charter (1) the annual~~
24 ~~financial cost to the City to operate the body, including but not limited to the costs of City staff~~
25 ~~time spent to support, brief, meet with, develop materials for, or otherwise enable the functioning~~

1 ~~of the body; and (2) the projected financial impact of eliminating the appointive board or~~
2 ~~commission, or consolidating it with another body. The report shall also include an estimate of~~
3 ~~the average annual financial cost to the City of operating an appointive board or commission~~
4 ~~that is established by ordinance for the purpose of providing non-binding advice to City officials~~
5 ~~on a given topic.~~

6 **(dc) Streamlining Task Force Report and Recommendations.** By no earlier than
7 January 1, 2036, and no later than February 1, 2026~~2036~~, and no later than February 1 of the
8 year immediately following a year in which a subsequent Streamlining Task Force is convened,
9 the Streamlining Task Force shall prepare and submit to the Mayor and the Clerk of the Board of
10 Supervisors a report containing the Streamlining Task Force's recommendations as to which
11 existing appointive boards and commissions, if any, should be eliminated in their entirety,
12 consolidated, revised to limit their powers and/or duties, or revised to expand their powers and/or
13 duties as a result of a consolidation.

14 For each recommendation made pursuant to this subsection (dc), the Streamlining Task
15 Force shall provide a rationale; analyze whether any function(s) performed by the appointive
16 board or commission that is recommended to be eliminated, consolidated, or revised are required
17 by law or essential to the effective operation of City and County government; and identify the
18 City and County officers, departments, or other units of government that could assume
19 responsibility for any legally required or essential function(s).

20 **(ed) Effectuation of Recommendations.**

21 ~~By no later than March 1, 2026, the City Attorney shall prepare a draft Charter~~
22 ~~Amendment to implement the Streamlining Task Force's recommendations relating to~~
23 ~~commissions established in the Charter, and shall submit such draft to the Clerk of the Board of~~
24 ~~Supervisors.~~ By no later than April 1, ~~2026~~2036, and no later than April 1 of the year
25 immediately following a year in which a subsequent Streamlining Task Force is convened, the

1 Streamlining Task Force's report and recommendations ~~and the draft Charter Amendment~~ shall
2 be the subject of a hearing before the Board of Supervisors. ~~Any Supervisor(s) wishing to seek~~
3 ~~voter approval of the draft Charter Amendment, or a modified version thereof, shall be required~~
4 ~~to introduce the Charter Amendment for consideration by the Board of Supervisors, consistent~~
5 ~~with the process and deadlines set forth in the Municipal Elections Code and Board's Rules of~~
6 ~~Order at that time.~~

7 (e) During its tenure, the Streamlining Task Force shall have the authority to introduce
8 one or more ordinances to effectuate its recommendations relating to the elimination,
9 consolidation, or revision of any appointive board or commission established by ordinance, other
10 than any appointive board or commission that was established or amended by the adoption of an
11 ordinance approved by the voters and that cannot be amended or rescinded without voter
12 approval. Such ordinance(s) shall ~~be deemed enacted~~ go into effect 90 days after the date of
13 introduction unless before the expiration of the 90-day period two-thirds of all members of the
14 Board of Supervisors vote to disapprove the ordinance.

15 (f) ~~Expiration. This Section 4.100.1 shall expire by operation of law on January 31,~~
16 ~~2027, and the City Attorney shall cause it to be removed the Charter thereafter.~~

18 SEC. 4.102. BOARDS AND COMMISSIONS – POWERS AND DUTIES.

19 Unless otherwise provided in this Charter, each appointive board, commission or other
20 unit of government of the executive branch of the City and County shall:

21 1. Formulate, evaluate and approve goals, objectives, plans and programs and set
22 policies consistent with the overall objectives of the City and County, as established by the
23 Mayor and the Board of Supervisors through the adoption of City legislation;

1 ~~2. Develop and keep current an Annual Statement of Purpose outlining its areas of~~
2 ~~jurisdiction, authorities, purpose and goals, subject to review and approval by the Mayor and~~
3 ~~the Board of Supervisors;~~

4 32. After public hearing, approve applicable departmental budgets or any budget
5 modifications or fund transfers requiring the approval of the Board of Supervisors, subject to the
6 Mayor's final authority to initiate, prepare and submit the annual proposed budget on behalf of
7 the executive branch and the Board of Supervisors' authority under Section 9.103;

8 43. Recommend to the Mayor for submission to the Board of Supervisors rates, fees,
9 and similar charges with respect to appropriate items coming within their respective
10 jurisdictions;

11 54. Unless otherwise specifically provided, submit to the Mayor at least three qualified
12 applicants, and if rejected, to make additional nominations in the same manner, for the position
13 of department head, subject to appointment by the Mayor;

14 65. Remove a department head; the Mayor may recommend removal of a department
15 head to the commission, and it shall be the commission's duty to act on the Mayor's
16 recommendation by removing or retaining the department head within 30 days; failure to act on
17 the Mayor's recommendation shall constitute official misconduct;

18 76. Conduct investigations into any aspect of governmental operations within its
19 jurisdiction through the power of inquiry, and make recommendations to the Mayor or the Board
20 of Supervisors; and

21 87. Exercise such other powers and duties as shall be prescribed by the Board of
22 Supervisors; ~~and~~

23 ~~9. Appoint an executive secretary to manage the affairs and operations of the board or~~
24 ~~commission.~~

1 In furtherance of the discharge of its responsibilities, an appointive board, commission or
2 other unit of government may:

3 ~~108.~~ Hold hearings and take testimony; and

4 ~~119.~~ Retain temporary counsel for specific purposes, subject to the consent of the Mayor
5 and the City Attorney.

6 Each board or commission, relative to the affairs of its own department, shall deal with
7 administrative matters solely through the department head or ~~his or her~~ their designees, and any
8 dictation, suggestion or interference herein prohibited on the part of any member of a board or
9 commission shall constitute official misconduct; provided, however, that nothing herein
10 contained shall restrict the board or commission's powers of hearing and inquiry as provided in
11 this Charter.

14 ~~As of the operative date of this Charter and until this requirement is changed by the~~

16 ~~ordinance to prepare an annual report describing its activities, and shall file such report with~~
17 ~~the Mayor and the Clerk of the Board of Supervisors. The Annual Report can be included in the~~
18 ~~Annual Statement of Purpose as provided for in Section 4.102(2).~~

16 at the member's own request; and shall excuse a member if the member's participation would
17 violate City or state law, including but not limited to City or state law pertaining to conflicts of
18 interest.

22 GENERAL PLAN. The Commission shall periodically recommend to the Board of

3 social, economic and environmental factors. In developing their recommendations, the
4 Commission shall consult with commissions and elected officials, and shall hold public hearings
5 as part of a comprehensive planning process. The Planning Department, in consultation with
6 other departments~~and the City Administrator~~, shall periodically prepare special area,
7 neighborhood and other plans designed to carry out the General Plan, and periodically prepare
8 implementation programs and schedules which link the General Plan to the allocation of local,
9 state and federal resources. The Planning Department may make such other reports and
10 recommendations to the Mayor, Board of Supervisors and other offices and governmental units
11 as it may deem necessary to secure understanding and a systematic effectuation of the General
12 Plan.

15 **SEC. 4.111. HUMAN SERVICES COMMISSION.**

16 The Human Services Commission shall consist of five members appointed by the Mayor,
17 pursuant to Section 3.100, for four-year terms. Members may be removed by the Mayor only
18 pursuant to Section 15.105.

19 As set forth in Section 18.116 of this Charter, this Section 4.111 shall be deemed enacted
20 into ordinance on January 1, 2027, and the City Attorney shall transfer the section to the
21 Administrative Code. Thereafter, Section 4.111 (as enacted into ordinance) may be amended or
22 repealed by ordinance.

25 **SEC. 4.112. PUBLIC UTILITIES COMMISSION.**

1 (a) The Public Utilities Commission shall consist of five members appointed by the
2 Mayor, subject to confirmation by a majority of the Board of Supervisors. Each of the members
3 shall serve for a term of four years. Members may be removed by the Mayor only pursuant to
4 Section 15.505.

5 (b) One seat shall be held by a person with experience in labor representation. In
6 making appointments to the Commission, the Mayor shall consider the following desirable
7 qualifications, among other factors the Mayor deems relevant: ~~Seat 1 on the Commission shall~~
8 ~~be a member with~~ experience in environmental policy and an understanding of environmental
9 justice issues; ~~Seat 2 shall be a member with~~ experience in ratepayer or consumer advocacy; ~~Seat 3 shall be a member with~~ experience in project finance; and ~~Seat 4 shall be a member with~~
10 expertise in water systems, power systems, or public utility management; ~~and Seat 5 shall be an~~
11 ~~at-large member.~~

13 (c) ~~The respective terms of office of members of the Public Utilities Commission who~~
14 ~~old office on August 1, 2008 shall expire at noon on that date, and the members appointed~~
15 ~~pursuant to the amendments to this Section approved at the June 2008 election shall succeed to~~
16 ~~said office at that time. In order to provide for staggered terms, the members appointed to Seats~~
17 ~~2 and 4 shall serve for an initial term of two years from August 1, 2008. The remaining three~~
18 ~~members appointed to Seats 1, 3, and 5 shall serve for an initial term of four years from August~~
19 ~~1, 2008, and thereafter the terms of all members shall be four years.~~

20 —(d)—The Commission shall have charge of the construction, management, supervision,
21 maintenance, extension, operation, use, and control of all water and energy supplies and utilities
22 of the City as well as the real, personal, and financial assets, which are under the Commission's
23 jurisdiction on the operative date of this Charter, or assigned pursuant to Section 4.132.

24
25 **SEC. 4.114. PORT COMMISSION.**

1 * * * *

2 The Commission shall have the composition and organization, and the powers, duties and
3 responsibilities with respect to the Port that are set forth in the Burton Act, Statutes of 1968,
4 Chapter 1333, as amended, and in the Agreement Relating to the Transfer of the Port of San
5 Francisco from the State of California to the City and County, executed on the 24th day of
6 January 1969.

7 The Commission shall be subject to the provisions of Sections 4.101 ~~through 4.103~~ and
8 4.102 of this Charter, so far as those powers and duties are not inconsistent with the Burton Act
9 and the Transfer Agreement as they are referred to in the above paragraph.

11 **SEC. 4.120. DISABILITY AND AGING SERVICES COMMISSION.**

12 (a) The Disability and Aging Services Commission shall consist of seven members
13 appointed by the Mayor, pursuant to Section 3.100, for four-year terms. Members may be
14 removed by the Mayor. The Commission shall oversee the Department of Disability and Aging
15 Services, including the functions of the Public Guardian/Administrator, as well as carry out any
16 additional duties and functions assigned to the Commission by ordinance or pursuant to Section
17 4.132.

18 (b) As of January 15, 2020, Seat 1 on the Commission shall be held by a person who
19 is 60 years old or older; Seat 2 shall be held by a person with a disability, as defined under the
20 Americans With Disabilities Act, who is 18 years old or older; and Seat 3 shall be held by a
21 person who served in the United States military and who was discharged or released under
22 conditions other than dishonorable. Seats 4, 5, 6, and 7, shall have no required qualifications in
23 addition to those set forth in Section 4.101.

24 (c) For the purpose of calculating the terms of particular seats on the Commission,
25 Seats 1, 2, and 3 are hereby designated as the seats with terms ending on January 15, 2020.

1 Notwithstanding Charter Section 4.101.5, members in those seats who do not as of January 15,
2 2020 hold the qualifications set forth in subsection (b) respectively may no longer serve in those
3 seats.

4 As set forth in Section 18.116 of this Charter, this Section 4.120 shall be deemed enacted
5 into ordinance on January 1, 2027, and the City Attorney shall transfer the section to the
6 Administrative Code. Thereafter, Section 4.120 (as enacted into ordinance) may be amended or
7 repealed by ordinance, consistent with state and federal law.

8 9 **SEC. 4.121. BUILDING INSPECTION COMMISSION.**

10 (a) GENERAL. The Building Inspection Commission shall consist of seven members
11 nominated and appointed pursuant to this Section 4.121 and with an emphasis on seeking to
12 include members concerned with tenant safety and habitability issues. Four members shall be
13 nominated by the Mayor for a term of two years. Three members shall be nominated by the
14 President of the Board of Supervisors for a term of two years. Two of the four Mayoral
15 appointments shall each have one or more of the following qualifications: be an active, formerly
16 active, or retired structural engineer, architect, or residential builder. One of the three Board
17 President appointments shall have one or more of the following qualifications: be a residential
18 tenant or work or have worked for a non-profit housing organization.

19 (b) MEMBERS. Each nomination of the Mayor and the President of the Board of
20 Supervisors is subject to approval by the Board of Supervisors, and shall be the subject of a
21 public hearing and vote within 60 days. If the Board fails to act on the nomination within 60 days
22 of the date the nomination is transmitted to the Clerk of the Board of Supervisors, the nominee
23 shall be deemed approved. The appointment shall become effective on the date the Board adopts
24 a motion approving the nomination or after 60 days of the date the nomination is transmitted to
25 the Clerk of the Board of Supervisors. Members may be removed by the appointing officer only

1 pursuant to Section 15.105. Vacancies occurring in the offices of members, shall be nominated
2 and appointed in accordance with the appointment process specified in this paragraph.

3 (c) CODES. The Building Inspection Commission shall have responsibility for oversight
4 of the Department of Building Inspection, which shall have responsibility for the enforcement,
5 administration, and interpretation of the San Francisco Housing, Building, Existing Building,
6 Green Building, Mechanical, Electrical, and Plumbing Codes, except where this Charter
7 specifically grants that power to another department.

8 (d) INSPECTIONS AND ENFORCEMENT. The Commission shall oversee the
9 inspection and regulation of additions, alterations, and repairs in all buildings and structures
10 covered by the San Francisco Housing, Building, Existing Building, Green Building, Mechanical,
11 Electrical, and Plumbing Codes. However, nothing in this Section 4.121 shall diminish or alter
12 the jurisdiction of the Planning Commission or Department over changes of use or occupancy
13 under the Planning Code. The Commission shall ensure the provision of minimum standards to
14 safeguard life or limb, health, property, and the public welfare by regulating and controlling the
15 safe use of such buildings and structures. The Commission shall ensure the vigorous enforcement
16 of City laws mandating the provision of heat and hot water to residential tenants. The
17 Commission shall also ensure the enforcement of local, state, and federal disability access laws.
18 The Commission shall exercise all the powers and duties of boards and commissions set forth in
19 Sections 4.102, ~~4.103~~, and 4.104, and may take other actions as prescribed by ordinance. The
20 members of the Commission shall serve without compensation.

21 (e) RULES AND REGULATIONS. The Commission shall adopt rules and regulations
22 consistent with fulfilling its responsibilities under this Charter. The Commission shall also adopt
23 rules and regulations governing Commission meetings and also adopt requirements for
24 notification and mailing for Commission business. The Commission shall hold public hearings
25

on all proposed amendments to the San Francisco Building Code, Existing Building Code, Green Building Code, Electrical Code, Housing Code, Plumbing Code, and Mechanical Code.

(f) OTHER BODIES. The Commission shall constitute the Abatement Appeals Board, and shall assume all powers granted to this entity under this Charter and the San Francisco Building Code. The Commission shall appoint and may remove at its pleasure members of the ~~Board of Examiners~~, Access Appeals Commission, and Code Advisory Committee, ~~all of which~~ shall have the powers and duties ~~to the extent~~ set forth in the San Francisco Building Code.

(g) PERMITS. The Commission may reverse, affirm, or modify determinations made by the Department of Building Inspection on all permits required for a final certificate of completion. The Commission's jurisdiction under this paragraph, however, shall not extend to permits appealable to the Planning Commission or Board of Appeals. Appeals of decisions within the Commission's jurisdiction must be filed with the Commission within fifteen days of the challenged determination. The Commission's action shall be final.

As set forth in Section 18.116 of this Charter, subsection (f) of this Section 4.121 shall be deemed enacted into ordinance on January 1, 2027, and the City Attorney shall transfer the section to the Administrative Code. Thereafter, subsection (f) of this Section 4.121 may be amended or repealed by ordinance.

SEC. 4.123. YOUTH COMMISSION MEMBERSHIP; APPOINTMENT; TERMS; MEETINGS; ~~COMPENSATION~~; DIRECTOR.

~~(d) Compensation. Members of the Commission shall not be compensated, nor shall they be reimbursed for expenses.~~

(ed) Meetings. The Commission shall meet at least once a month.

1 (~~f~~e) Minutes of Meetings. The Commission shall prepare and maintain permanent
2 minutes of the actions taken during its meetings, and shall file copies with the Clerk of the Board
3 of Supervisors.

4 (~~g~~l) Bylaws. To aid in the orderly conduct of business, the Commission shall have the
5 authority to create, amend, and repeal its own code of bylaws.

7 **SEC. 4.127. POLICE DEPARTMENT.**

9 POLICE STAFFING. By no earlier than October 1 and no later than November 1 in
10 every odd-numbered calendar year, the Chief of Police shall transmit to the Police Commission a
11 report describing the department's current number of full-duty sworn officers and recommending
12 staffing levels of full-duty sworn officers in the subsequent two fiscal years. The report shall
13 include an assessment of the Police Department's overall staffing, the workload handled by the
14 department's employees, the department's public service objectives, the department's legal
15 duties, and other information the Chief of Police deems relevant to determining proper staffing
16 levels of full-duty sworn officers. The report shall evaluate and make recommendations
17 regarding staffing levels at all district stations and in all types of jobs and services performed by
18 full-duty sworn officers. By no later than ~~July~~April 1 in every odd-numbered calendar year, the
19 Police Commission shall adopt a policy prescribing the methodologies that the Chief of Police
20 may use in evaluating staffing levels, which may include consideration of factors such as
21 workload metrics, the Department's targets for levels of service, ratios between supervisory and
22 non-supervisory positions in the Department, whether particular services require a fixed number
23 of hours, and other factors the Commission determines are best practices or otherwise relevant.
24 The Chief of Police may, but is not required by this Section 4.127 to, submit staffing reports
25 regarding full-duty sworn officers to the Police Commission in even-numbered years.

4 (a) There shall be a Homelessness Oversight Commission (“Commission”) to oversee

7 programs, and services for persons experiencing homelessness in the City, including, but not
8 limited to, street outreach, homeless shelters, transitional housing, homelessness prevention, and

16 ~~deemed approved. The appointment shall become effective on the date the Board adopts a~~
17 ~~motion approving the nomination or on the 61st day after the Clerk of the Board receives notice~~
18 ~~of the nomination, whichever is earlier.~~ Seat 1 shall be held by a person who has personally
19 experienced homelessness. ~~Seat 2 shall be held by a person with significant experience providing~~
20 ~~services to or engaging in advocacy on behalf of persons experiencing homelessness. Seat 3~~
21 ~~shall be held by a person with expertise in mental health service delivery or substance use~~
22 ~~treatment. Seat 4 shall be held by a person with a record of participation in a merchants’ or~~
23 ~~small business association, or neighborhood association. In addition to the aforementioned~~
24 ~~qualifications, at least one of the Mayor’s appointees shall have experience in budgeting,~~
25 ~~finance, and auditing.~~

1 (2) Seats 5, 6, and 7 shall be appointed by the Board of Supervisors. Seat 5 shall
2 be held by a person who has personally experienced homelessness. ~~Seat 6 shall be held by a~~
3 ~~person with significant experience providing services to or engaging in advocacy on behalf of~~
4 ~~persons experiencing homelessness. Seat 7 shall be held by a person with significant experience~~
5 ~~working with homeless families with children and/or homeless youth.~~

6 (3) For all seats, the appointing authority shall consider qualifications
7 including, but not limited to, experience providing services to or engaging in advocacy on behalf
8 of persons experiencing homelessness, expertise in mental health service delivery or substance
9 use treatment, participation in a merchants' or small business association, participation in a
10 neighborhood association, experience in budgeting, finance, and auditing, and experience
11 working with homeless families with children and/or homeless youth, and shall also consider
12 ~~Section 4.101 shall apply to these appointments, with a particular emphasis on~~ diversity in
13 ethnicity, race, age, sex, gender identity, sexual orientation, and types of disabilities.

14 (c) Commission members shall serve at the pleasure of their respective appointing
15 authorities and may be removed by their appointing authorities at any time. Vacancies shall be
16 filled by the respective appointing authorities as prescribed in subsections (b)(1) and (2).

17 (d) Commissioners shall serve four-year terms, ~~beginning at noon on May 1, 2023;~~
18 ~~provided, however, the term of the initial appointees in Seats 1, 4, and 6 shall be a two-year~~
19 ~~term, expiring at noon on May 1, 2025.~~

20 (e) The Commission shall elect a Chair, Vice-Chair, and officers for other such
21 positions, if any, that it chooses to create.

22 (f) The Commission shall have the following powers and duties:

23 (1) With respect to the Department, the Commission shall exercise all of the
24 powers and duties of boards and commissions as set forth in Sections 4.102, ~~4.103~~, and 4.104,
25 including but not limited to, approving applicable departmental budgets, formulating annual and

1 long-term goals consistent with the overall objectives of the City and County, establishing
2 departmental performance standards, holding hearings and taking testimony, conducting public
3 education and outreach concerning programs and services for homeless persons in San
4 Francisco, and issues concerning homelessness, and conducting performance audits of the
5 Department to assess the efficiency and effectiveness of the Department's delivery of services to
6 persons experiencing homelessness and persons participating in programs overseen by the
7 Department, and the extent to which the Department has met the annual goals and performance
8 standards established by the Commission.

9 (2) Notwithstanding the Commission's authority to review and set policies, the
10 Commission shall not have the authority to approve, disapprove, or modify criteria used to
11 ascertain eligibility or priority for programs and/or services operated or provided by the
12 Department, where such criteria are required as a condition of the receipt of state or federal
13 funding.

14 ~~(g) The Mayor and the Board of Supervisors shall make their initial appointments to~~
15 ~~Seats 1-7, respectively, on the Commission by no later than noon, March 1, 2023. The~~
16 ~~Commission shall come into existence upon the appointment, and confirmation where required,~~
17 ~~of four members, or at noon on May 1, 2023, whichever is later. The Commission shall have its~~
18 ~~inaugural meeting within 30 days of its coming into existence.~~

20 **SEC. 4.135. HISTORIC PRESERVATION COMMISSION.**

21 * * * *

22 BUDGET, FEES, DEPARTMENT HEAD, AND STAFF. The provisions of Charter
23 subsections 4.102(~~3~~2), 4.102(~~4~~3), 4.102(~~5~~4), and 4.102(~~6~~5) shall not apply to the Historic
24 Preservation Commission. The Historic Preservation Commission may review and make
25 recommendations on the Planning Department budget and on any rates, fees, and similar charges

1 with respect to appropriate items coming within the Historic Preservation Commission's
2 jurisdiction to the department head of the Planning Department or the Planning Commission. The
3 department head of the Planning Department shall assume the powers and duties that would
4 otherwise be executed by an Historic Preservation Commission department head. The Planning
5 Department shall render staff assistance to the Historic Preservation Commission.

7 **SEC. 4.136. DEPARTMENT OF POLICE ACCOUNTABILITY.**

8 (a) There shall be under the Police Commission a Department of Police Accountability
9 ("DPA").

10 (b) The Mayor shall appoint a nominee of the Police Commission as the Director of
11 DPA, subject to confirmation by the Board of Supervisors. The Director shall serve at the
12 pleasure of the Police Commission. If the Board of Supervisors fails to act on the appointment
13 within 30 days, the appointment shall be deemed approved. In the event the office is vacant, until
14 the Mayor makes an appointment and that appointment is confirmed by the Board, the Police
15 Commission shall appoint an interim Director who shall serve at the pleasure of the Police
16 Commission. The appointment of the Director shall be exempt from the civil service
17 requirements of this Charter. The Director shall never have been ~~a uniformed member or an~~
18 employee of the Police Department. The Director shall be the appointing officer under the civil
19 service provisions of this Charter for the appointment, removal, or discipline of employees of
20 DPA.

21 (c) The Police Commission shall have the power and duty to organize, reorganize, and
22 manage DPA. Subject to the civil service provisions of this Charter, DPA shall include
23 investigators and hearing officers. The staff of DPA shall consist of no fewer than one line
24 investigator for every 150 sworn members of the Police Department. Whenever the ratio of
25 investigators to police officers specified by this subsection (c) is not met for more than 30

1 consecutive days, the Director shall have the power to hire, and the City Controller must pay,
2 temporary investigators to meet such staffing requirements. No full-time or part-time employee
3 of DPA shall have previously served as ~~a uniformed member~~ an employee of the Police
4 Department. Subject to rules of the Police Commission, the Director may appoint part-time
5 hearing officers who shall be exempt from the civil service requirements of this Charter.
6 Compensation of the hearing officers shall be at rates recommended by the Commission and
7 established by the Board of Supervisors or by contract approved by the Board of Supervisors.

8 (d) DPA shall promptly, fairly, and impartially investigate all complaints regarding
9 police use of force, misconduct, or allegations that a member of the Police Department has not
10 properly performed a duty, except those complaints which on their face clearly indicate that the
11 acts complained of were proper and those complaints lodged by other members of the Police
12 Department. DPA shall use its best efforts to conclude investigations of such complaints and, if
13 sustained, transmit the sustained complaint to the Police Department within nine months of
14 receipt thereof by DPA. If DPA is unable to conclude its investigation within such nine-month
15 period, the Director, within such nine-month period, shall inform the Chief of Police of the
16 reasons therefor and transmit information and evidence from the investigation as shall facilitate
17 the Chief's timely consideration of the matter.

18 (e) DPA shall recommend disciplinary action to the Chief of Police on those complaints
19 that are sustained. The Director, after meeting and conferring with the Chief of Police or ~~his or~~
20 ~~her~~ the Chief's designee, may verify and file charges with the Police Commission against
21 members of the Police Department arising out of sustained complaints; provided, that the
22 Director may not verify and file such charges for a period of 60 days following the transmittal of
23 the sustained complaint to the Police Department unless the Director issues a written
24 determination that the limitations period within which the member or members may be
25 disciplined under Government Code Section 3304, as amended from time to time or any

1 successor provisions thereto, may expire within such 60-day period and (1) the Chief of Police
2 fails or refuses to file charges with the Police Commission arising out of the sustained complaint,
3 (2) the Chief of Police or ~~his or her~~ the Chief's designee fails or refuses to meet and confer with
4 the Director on the matter, or (3) other exigent circumstances necessitate that the Director verify
5 and file charges to preserve the ability of the Police Commission to impose punishment pursuant
6 to Section A8.343.

7 (f) The Director shall schedule hearings before hearing officers when such is requested
8 by the complainant or a member of the Police Department and, in accordance with rules of the
9 Commission, such a hearing will facilitate the fact-finding process. The Board of Supervisors
10 may provide by ordinance that DPA shall in the same manner investigate and make
11 recommendations to the Chief of Police regarding complaints of misconduct by patrol special
12 police officers and their uniformed employees.

13 (g) Nothing herein shall prohibit the Chief of Police or a commanding officer from

15 the Chief or officer, or taking disciplinary or corrective action, otherwise permitted by this
16 Charter, when such is warranted; and nothing herein shall limit or otherwise restrict the

20 ~~—(c) **Duties.** The Commission shall hold public hearings and set policies for the~~

22 ~~and maintenance of the public right of way. In addition, the Commission shall:~~

23 ~~—(1) review and evaluate data regarding the condition of the public right of way,~~

(h) Except as provided in this Article VIII A, the Agency shall be subject to the provisions of this Charter applicable to boards, commissions, and departments of the City and County, including Sections 2.114, 3.105, 4.101, ~~4.103~~, 4.104, 4.113, 6.102, 9.118, and 16.100, ~~and 48.346~~. Sections 4.102, 4.126, and 4.132 shall not be applicable to the Agency.

SEC. 8A.103. SERVICE STANDARDS AND ACCOUNTABILITY.

* * * *

(c) The standards for the Agency with respect to the services provided by the Municipal Railway shall include the following minimum standards for on-time performance and service delivery:

1. On-time performance: at least 85% ~~percent~~ of vehicles must run on-time, ~~where a vehicle is considered on-time if it is no more than one minute early or four minutes late as measured against a published schedule that includes time points~~ with on-time performance determined in accordance with subsection (e); and

2. Service delivery: 98.5% ~~percent~~ of scheduled service hours must be delivered, and at least 98.5% ~~percent~~ of scheduled vehicles must begin service ~~at the scheduled time on~~ time.

(e) The Board of Directors shall adopt Agency rules setting forth the methods by which performance shall be measured with respect to each standard established pursuant to subsections

(c) or (d) above in accordance with industry best practices to enhance the Agency's ability to compare its performance to that of other comparable transit systems. The Agency shall regularly publish reports documenting the Agency's performance for each standard. Each performance report shall note any changes in the rules governing the methods by which performance is measured so as to inform interpretation of performance trends over time. Nothing herein shall prohibit the Agency from using additional performance measures.

(f) ~~The Agency shall issue a Climate Action Plan to the Board of Supervisors and the Commission on the Environment by January 1, 2009, and every two years thereafter. The Agency shall participate in Citywide climate action planning efforts. The plan~~ As part of their participation, the Agency shall describe measures taken and progress made toward the goal of reducing greenhouse gas emissions from San Francisco's transportation sector, as measured by applicable federal, state, and local requirements and standards, and ~~to 80% of 1990 levels by 2012 and shall further address~~ progress toward the following goals:

1. Zero greenhouse gas emissions for Municipal Railway transit vehicles;
2. Lowering energy consumption in Agency facilities and by non-transit vehicles;
3. Maximizing waste reduction in Agency operations;
4. Increasing transit trips and reducing private vehicle trips within the City;
5. Increasing the use of bicycling and walking as alternate forms of transportation;

~~—No later than January 1, 2010, and no less than every ten years thereafter, the Board of Supervisors shall adopt legislation setting goals for reducing greenhouse gas emissions from San Francisco's transportation sector, and other climate action measures set forth above, for periods after 2012.~~

2 **SEC. 8A.104. PERSONNEL AND MERIT SYSTEM.**

4 (k) Upon the expiration of labor contracts negotiated by the Department of Human
5 Resources and approved by the Board of Supervisors, and except for retirement benefits, the
6 wages, hours, working conditions, and benefits of the employees in classifications within the
7 Municipal Railway designated by the Agency as “service-critical” shall be fixed by the Agency
8 after meeting and conferring as required by the laws of the State of California and this Charter,
9 including Sections ~~A8.346~~, A8.404 and A8.409. These agreements shall utilize, and shall not
10 alter or interfere with, the health plans established by the City’s Health Service Board; provided,
11 however, that the Agency may contribute toward defraying the cost of employees’ health
12 premiums. For any job classification that exists both as a “service-critical” classification in the
13 Agency and elsewhere in City service, the base wage rate negotiated by the Agency for that

18 and conditions of employment are set by the Agency, the Agency’s discretion in establishing and

20 part-time transit system personnel based upon service needs is essential to the effective, efficient,
21 and reliable operation of the transit system. In any mediation/arbitration proceeding under
22 Section 8.409-4 with an employee organization representing transit system employees, the
23 employee organization shall have the burden of proving that any restrictions proposed on the
24 Agency’s ability to exercise broad discretion with respect to these matters are justified. ~~To meet~~
25 ~~this burden, the employee organization must prove by clear and convincing evidence that the~~

3 shall not treat the provisions of MOUs for transit system employees adopted prior to the effective
4 date of this provision as precedential in establishing the terms of a successor agreement. The

6 of bargaining under state law.

8 (q) In addition, ~~the voters find that~~ Agency service in the past has been impaired by the
9 existence of side-letters and reliance on "past practices" that have been treated as binding or

24 disclose in writing the contents of such tentative agreement, a detailed analysis of the proposed
25 agreement, a comparison of the differences between the agreement reached and the prior

1 agreement, an analysis of all costs for each year of the term of such agreement, and whether
2 funds are available to cover these costs. Such tentative agreement between the Agency and
3 employee organization shall not be approved by the Agency until ~~45~~14 calendar days after the

8 (c) The Base Amount shall initially be determined by the Controller. Adjustments to the
9 Base Amount shall be made as follows:

10 1. The Base Amount shall be adjusted for each year after fiscal year 2000-2001 by
11 the Controller based on calculations consistent from year to year, by the percentage increase or
12 decrease in aggregate City and County discretionary revenues. In determining aggregate City and
13 County discretionary revenues, the Controller shall only include revenues received by the City
14 which are unrestricted and may be used at the option of the Mayor and the Board of Supervisors
15 for any lawful City purpose. Additionally, in determining aggregate City and County
16 discretionary revenues, the Controller shall not include revenues received by the City under the
17 increased rates in Business and Tax Regulations Code Sections 953.1(g), 953.2(h), 953.3(h),

19 municipal election on November 3, 2020, and shall not include revenues received by the City

22 revenues for a fiscal year shall be corrected by adjustment in the next year's estimate.

18 **SEC. 8A.111. CITIZENS' ADVISORY COUNCIL.**

19 The Agency shall establish a Citizens' Advisory Council of ~~fifteen~~ 15 members which
20 shall consist of one person appointed by each member of the Board of Supervisors and four
21 members appointed by the Mayor. Each member must be a resident of the City and County. No
22 fewer than ~~ten~~ 10 members of the Council must be regular riders of the Municipal ~~Railway~~

6 As set forth in Section 18.116 of this Charter, this Section 8A.111 shall be deemed
7 enacted into ordinance on January 1, 2027, and the City Attorney shall transfer the Section to
8 Division II of the Transportation Code. Thereafter, Section 8A.111 (as enacted into ordinance)
9 may be amended or repealed by resolution of the Agency's Board of Directors as provided in
10 Section 8A.102(b).

12 **SEC. 8A.113. PARKING AND TRAFFIC; GOVERNANCE.**

16 The people of the City and County of San Francisco over many years have invested and
17 continue to invest significant financial resources to develop, improve, and maintain their water,
18 power, and sewer systems. Prudent planning and efficient implementation are critical to
19 sustaining effective, efficient, reliable, and resilient utilities through regular operation and
20 natural disasters such as earthquakes and floods. The people also recognize the importance of
21 protecting the natural environment, promoting water conservation, and supporting the
22 communities that may be impacted by utility operation. Further, the people recognize that utility
23 operations are subject to federal and state laws, and the City and County of San Francisco must
24 meet regulatory mandates through continuous resource investment.
25

1 The Public Utilities Commission operates the Water, Power, and Sewer utilities of the
2 City and County of San Francisco, all of which are invaluable assets of the City and County and
3 each of which is described in the following paragraphs.

4 **Water.** The Water utility provides drinking water to the City and County of San
5 Francisco and portions of the San Francisco Bay Area Region. The Water utility includes the
6 Hetch Hetchy Water and Power system, the Regional Water system, and the system for
7 distributing water throughout the City and County. The Water utility also includes multiple
8 systems to manage, maintain, protect, store, transport, and deliver drinking water from the
9 Hetch Hetchy reservoir in Yosemite National Park and other sources within the Regional and
10 San Francisco water systems.

11 **Power.** The Power utility provides electric power from the hydro- and solar power
12 generation of the Hetch Hetchy Power system. The Power utility includes power generation and
13 storage facilities, power transmission systems, and a renewable energy community choice
14 aggregation service.

15 **Sewer.** The Sewer utility collects, conveys, treats, and discharges wastewater,
16 stormwater, and other surface flows to protect public health and the environment. The Sewer
17 utility includes combined and separate sewer collection, conveyance, treatment, and discharge
18 facilities and infrastructure.

19 The purpose of this Article VIIIB is to ensure the long-term successful stewardship of the
20 utility systems that support the City and County of San Francisco and serve San Francisco's
21 utility ratepayers and wholesale customers.

22 23 **SEC. 8B.121. PUBLIC UTILITIES COMMISSION.**

24 (a) Notwithstanding Charter section 4.112, the Public Utilities Commission shall have
25 exclusive charge of the design, construction, management, supervision, maintenance, extension,

1 expansion, operation, use, and control of all water, ~~clean water and energy~~ power, and sewer
2 infrastructure, facilities, supplies and utilities of the City as well as the real, personal and
3 financial assets, that are under the Commission's jurisdiction or assigned to the Commission
4 under Section 4.132.

5 (b) The Public Utilities Commission may enter into Joint Powers Agreements or other
6 joint, coordinated, or common-use agreements with other public entities in furtherance of the
7 responsibilities of the Commission.

8 (c) Except to the extent otherwise provided in this Article VIII B, the Public Utilities
9 Commission shall be subject to the provisions of Charter sections 4.100 et seq. generally
10 applicable to boards and commissions of the City and County.

11 (d) The General Manager shall be the department head and chief executive of the San
12 Francisco Public Utilities Commission department (SFPUC or department). The General
13 Manager shall have authority over and responsibility for the day-to-day management of the
14 Water, Power, and Sewer utility systems, department operations, personnel, facilities,
15 infrastructure, and real property under the jurisdiction of the Commission. The General
16 Manager shall appoint all subordinate personnel of the department. The General Manager may
17 appoint deputy and/or assistant general managers who shall serve at the pleasure of the General
18 Manager. The General Manager may ~~have the authority to~~ organize and reorganize the
19 department. The General Manager shall adopt rules and regulations governing all matters within
20 the jurisdiction of the department subject to section 4.102 as applicable.

21 (e) Ownership or control of any public utility or any part thereof under the jurisdiction
22 of the Public Utilities Commission may not be transferred or conveyed absent approval by the
23 Public Utilities Commission and approval by a vote of the electors of the City at the election next
24 ensuing not less than 90 days after the adoption of such ordinance, which shall not go into effect
25 until ratified by a majority of the voters voting thereon. Voter approval shall not be required for

Each departmental budget shall describe each proposed activity of that department and the cost of that activity. In addition, each department shall provide the Mayor and the Board of Supervisors with the following details regarding its budget:

1. The overall mission and goals of the department;
2. The specific programs and activities conducted by the department to accomplish its mission and goals;
3. The customer(s) or client(s) served by the department;
4. The service outcome desired by the customer(s) or client(s) of the department's programs and activities;
5. Strategic plans that guide each program or activity;
6. Productivity goals that measure progress toward strategic plans;
7. The total cost of carrying out each program or activity; and

Within 30 days of the Controller's issuance of the combined annual financial report of the City and County, the Controller shall report to the Mayor and Board of Supervisors regarding the extent to which each department in the prior fiscal year has recovered additional revenues measured by the difference between projected and experienced revenues. 25 **SEC. 16.108. CHILDREN AND YOUTH FUND.**

1 (a) **Preamble.**

2 (1) By overwhelmingly reauthorizing the Children's Fund in 2000 with 74% ~~percent~~
3 approval, the people of the City and County of San Francisco found and declared that the
4 Children's Fund (now to be known as the "Children and Youth Fund") is essential in ensuring
5 the health and success of every San Francisco child.

6 (2) The previous investment of the Children and Youth Fund allowed for the
7 Department of Children, Youth, and Their Families to serve over 56,000 youth in FY 2012-2013,
8 focusing on the children with the most need.

9 (3) The Fund successfully stabilized and expanded services for children, youth, and
10 their families, while leveraging other resources.

11 (4) Addressing the level of unmet need among children and youth remains a
12 significant challenge. The needs of San Francisco's children have been increasing:

13 (A) One-third of San Francisco's African American and Latino children live below
14 the poverty line. The number of San Francisco children in poverty has increased by 14% in the
15 past 5 years.

16 (B) The federal poverty level for a family of four is \$23,000; adjusted to San
17 Francisco, it is \$35,000. Self-sufficiency in San Francisco for a family of four is three times that
18 amount, and over half of all families cannot meet the self-sufficiency standard. The Children and
19 Youth Fund provides services that support families and opportunities for children and youth that
20 are essential to meeting their needs and providing pathways out of poverty.

21 (C) State and federal cuts have significantly reduced children and youth services in
22 San Francisco, including funding for child care, youth employment and high need disconnected
23 transitional-aged youth.

24 (5) The reauthorization of the Children and Youth Fund will enable the Department
25 of Children, Youth and Their Families ("DCYF") to build on the previous success of the Fund

1 and strengthen DCYF's capacity for the future, while fostering innovation and improving
2 transparency and accountability.

3 (b) **Fund for Children and Youth Services.** Operative July 1, 2001, there is hereby
4 established a fund to expand children's services, which shall be called the Children and Youth
5 Fund ("Fund"). Monies in the Fund shall be expended or used only to provide services for
6 children and youth as provided in this Section 16.108.

7 * * * *

8 (f) **Eligible Uses.** The City shall only use monies from the Fund for the following
9 purposes:

11 (2) Funding for ~~the Department of Children, Youth and Their Families~~ ("DCYF") and the

15 (h) **Baseline.** The Fund shall be used exclusively to increase the aggregate City
16 appropriations and expenditures for those services for children and Disconnected Transitional-
17 Aged Youth that are eligible to be paid from the Fund (exclusive of expenditures mandated by
18 state or federal law). To this end, the City shall not reduce the amount of such City
19 appropriations for eligible services (not including appropriations from the Fund and exclusive of
20 expenditures mandated by state or federal law) under this section below the amount so
21 appropriated for the Fiscal Year 2000-2001 ("the base year") as set forth in the Controller's
22 baseline budget, as adjusted ("the base amount" or "the Children and Youth Baseline").

23 The Controller shall calculate City appropriations made in fiscal year 2013-2014 for
24 services for Disconnected Transitional-Aged Youth aged 18 through 24 years. Beginning with
25 fiscal year 2014-2015, that amount shall be added to the base amount and adjusted as provided

9 County that are unrestricted and may be used at the option of the Mayor and the Board of
10 Supervisors for any lawful City purpose. ~~Additionally, in determining aggregate City and County~~
11 ~~discretionary revenues, the Controller shall not include revenues received by the City under the~~
12 ~~increased rates in Business and Tax Regulations Code Sections 953.1(g), 953.2(h), 953.3(h),~~
13 ~~953.4(e), 953.5(d), 953.6(f), 953.7(d), and 953.8(i) adopted by the voters at the general~~
14 ~~municipal election on November 3, 2020, and shall not include revenues received by the City~~
15 ~~under Article 36 of the Business and Tax Regulations Code adopted by the voters at the general~~
16 ~~municipal election on November 3, 2020.~~ Errors in the Controller's estimate of discretionary
17 revenues for a fiscal year shall be corrected by an adjustment in the next year's estimate. Within
18 90 days following the end of each fiscal year through Fiscal Year 2040-2041, the Controller shall
19 calculate and publish the actual amount of City appropriations for services for children and
20 Disconnected Transitional-Aged Youth that would have been eligible to be paid from the Fund
21 but are paid from other sources, separately identifying expenditures mandated by state or federal
22 law.

23 (i) **Five-Year Planning Cycle.** The City shall appropriate monies from the Fund
24 according to a five-year planning process (the "Five-Year Planning Cycle"). This process is
25 intended to: (1) increase transparency, accountability, and public engagement; (2) provide time

1 and opportunities for community participation and planning; (3) ensure program stability; and (4)
2 maximize the effectiveness of the services funded. The first year of the Five-Year Planning
3 Cycle shall be Fiscal Year 2026-2027. The Board of Supervisors may reset the starting year of a
4 future Five-Year Planning Cycle at any time by ordinance.

5 (1) **Year 1 – Community Needs Assessment.** During the first year of each Five-
6 Year Planning Cycle (“Year 1”)~~fifth fiscal year beginning with Fiscal Year 2015-20162026-~~
7 ~~2027~~, DCYF shall conduct a Community Needs Assessment (“CNA”) to identify services to
8 receive monies from the Fund. The CNA should include qualitative and quantitative data sets
9 collected through interviews, focus groups, surveys, or other outreach mechanisms to determine
10 service gaps in programming for children, youth, and families. Subject to the budgetary and
11 fiscal provisions of the Charter, DCYF may contract with consultants and outside experts for
12 such services as the department may require to prepare the CNA. DCYF shall undertake a robust
13 community process in every supervisorial district, soliciting input from a diverse cross-section of
14 parents, youth, non-profit organizations, and other key stakeholders to develop the CNA:

15 (A) DCYF shall develop a plan for how to conduct the CNA. The CNA shall
16 include an equity analysis of services and resources for parents, children, and youth. DCYF shall
17 develop a set of equity metrics to be used to establish a baseline of existing services and
18 resources in low-income neighborhoods and disadvantaged communities, compared to services
19 and resources available in the City as a whole. The outreach for the CNA shall create
20 opportunities for parents, youth, nonprofit agencies, and other members of the public, to provide
21 input. By September 1, DCYF shall provide its plan for conducting the CNA to the ~~Oversight~~
22 ~~and Advisory Committee~~ CYF Commission, ~~the Service Provider Working Group~~ Children,
23 Youth, and Their Families Service Provider Advisory Council (“Service Provider Advisory
24 Council”) created in Charter Section 16.108-1(e), the Childcare Planning and Advisory Council

3 ~~2016-2017~~, DCYF shall prepare a Services and Allocation Plan (“SAP”) to determine services
4 eligible to receive monies from the Fund. DCYF shall use the following process to prepare the
5 SAP:

6 (A) DCYF shall prepare a draft SAP in consultation with interested City
7 departments, commissions, and advisory bodies,~~including which may include, but are not limited~~
8 ~~to, the Department of Early Childhood, the First Five Children and Families First Commission~~
9 ~~or any successor body, the Office of Early Care and Education (or any successor entity), the~~
10 Childcare Planning and Advisory Council, the Recreation and Park Commission, the Health
11 Commission, the Human Services Commission, the Youth Commission, the Juvenile Probation
12 Commission, the Adult Probation Department, the Commission on the Status of Women, the

22 (iv) Include capacity-building and evaluation of services as separate funding
23 areas;

24 (v) State how services will be coordinated and have specific amounts allocated
25 towards specific goals, service models, populations and neighborhoods;

1 (vi) Include funding for youth-initiated projects totaling at least 3% ~~percent~~ of
2 the total proposed expenditures from the Fund for the cycle;

3 (vii) Include evaluation data from the previous funding cycle and the details of
4 the Children and Youth Baseline; and,

5 (viii) Incorporate strategies to coordinate and align all services for children
6 funded by all governmental or private entities and administered by the City, whether or not those
7 services are eligible to receive monies from the Fund.

8 (B) The SAP shall include an equity analysis of services and resources for parents,
9 children and youth. Using the equity metrics developed for preparation of the CNA, the SAP
10 shall compare proposed new, augmented, and coordinated services and resources for low-income
11 neighborhoods and disadvantaged communities with services and resources available to the City
12 as a whole.

13 (C) Subject to the budgetary and fiscal provisions of the Charter, DCYF may
14 contract with consultants and outside experts for such services as the department may require to

Nothing in this Section shall limit the authority of the Mayor and the Board of Supervisors to propose, amend, and adopt a budget under Article IX of ~~the~~ this Charter.

5 must come together to align needs with services, coordinate across agencies, and develop a
6 strategy.

7 ~~(e) The Our Children, Our Families Council, comprised of department heads from the~~
8 ~~City and SFUSD, and community stakeholders, will build a platform that will place children and~~
9 ~~families at the center of every policy decision.~~

10 (f) With the renewal of the Children and Youth Fund and the Public Education
11 Enrichment Fund in November 2014, the City must seize this opportunity to develop a long-term
12 Citywide vision, create a set of strategies, coordinate services, and identify shared goals to not
13 only ensure that all children and families already here are able to thrive, but to encourage other
14 families to live here.

15 (g) The percentage of children under the age of 18 in San Francisco has steadily
16 declined. As of 2010, 13.4% ~~percent~~ of the City’s total population was under the age of 18, the
17 lowest percentage of any major city nationwide.

18 (h) Families continue to leave San Francisco, especially those families in the low to
19 moderate income brackets.

20 (i) San Francisco’s children population is declining, with over 10% ~~percent~~ of 1 to 4
21 year olds moving out of the City annually and fewer children moving in.

22 (j) The declining numbers of children and families in the City cost the community
23 financially as less money is spent on the local economy.

24 (k) This measure will put in place a collaborative approach around the following points
25 of unity:

(1) Ensuring equity, and giving priority to children and youth with the highest needs;
(2) Empowering parents, youth, and community stakeholders by giving them a voice in the implementation of this Citywide vision; and,

5 **A8.423 REVISION OF SCHEDULES AND COMPENSATION**

6 In January of each year, or at such other time consistent with the Plan Year set by the
7 Hhealth Service Board, ~~or at such other time consistent with the Plan Year set by the Health~~
8 ~~Service Board~~, at a public hearing, the Health Service Board shall review and determine the
9 adequacy of medical care provided for members of the system and the adequacy of fee schedules
10 and the compensation paid for all services rendered and it may make such revisions therein as it
11 deems equitable but such revisions shall not become effective until approved by ordinance of the
12 Board of Supervisors adopted by three-fourths of its members.

13 Commencing in 1973, the Health Service Board shall, prior to the second Monday in

21 Board shall determine the average contribution made with respect to each employee by said 10

23 Monday in January of each year, or at such other time consistent with the Plan Year set by the
24 Health Service Board, the Health Service Board shall certify to the Board of Supervisors the

3 The Health Service Board shall have the responsibility to obtain and disseminate

7 programs, actuarial expenses and expenses incurred to reduce health care costs, shall be borne by

12 Each plan may make provision for the participation in the benefits of the system by the

16 Francisco Unified School District retired under the San Francisco City and County Employees’

3 after transferring to the State Teachers' Retirement System from the San Francisco City and
4 County Employees' Retirement System. The purpose of empowering the ~~H~~Health ~~s~~Service
5 ~~b~~Board to make provision for participation in the benefits of the system by the aforementioned
6 resigned employees of the City and County and other resigned employees of San Francisco
7 Unified School District is to permit the ~~H~~Health ~~s~~Service ~~b~~Board to have power to treat them the
8 same as it treats resigned teachers and employees of the San Francisco Unified School District.

LEGISLATIVE DIGEST
(Revised 6/22/2026)

[Charter Amendment - Department, Board, Commission, and Advisory Body Updates]

Describing and setting forth a proposal to the voters at an election to be held on November 3, 2026, to amend the Charter of the City and County of San Francisco by 1) requiring or authorizing the Board of Supervisors to amend specified initiative ordinances; 2) transferring from the Charter to the Municipal Code certain commissions and advisory bodies, in some cases with modified functions; 3) requiring that the Commission Streamlining Task Force be convened every ten years; 4) removing the general requirements that boards and commissions develop and keep an annual statement of purpose, appoint an executive secretary, and prepare an annual report; 5) changing the membership qualifications, composition, and member selection process for certain bodies; 6) eliminating, consolidating, and changing the functions and authorities of certain bodies; 7) changing the planning and reporting schedule of the Department of Children, Youth, and Their Families (“DCYF”) and related policy bodies, and changing the names but not the functions of those related policy bodies; 8) specifying that elected members of the Retirement Board, Health Service Board, and Retiree Health Care Trust Fund Board may be removed only for official misconduct; 9) making various changes to departments’ operations and reporting requirements; 10) updating the Public Utilities Commission’s exclusive charge over matters related to water, power, and sewer infrastructure and services; 11) providing that the Board of Supervisors shall approve settlements or dismissals of legal proceedings recommended by the City Attorney by resolution, rather than by ordinance; 12) authorizing the City Administrator to conduct real estate strategic planning and to negotiate and manage acquisitions, leases, and conveyances of City real property; and 13) making clarifying edits, deleting obsolete language, and updating out-of-date references in various sections.

Amendments to Current Law

This Charter amendment would make various changes to the current Charter language in the categories listed below.

1. General Clean-up and Modernizing Amendments. The Charter amendment would delete obsolete language, and make clarifying edits consistent with the intent of current Charter language, in various Charter sections related to the Board of Supervisors, the Mayor, rates, fees and similar charges, the Port Commission, the Building Inspection Commission, the Police Department, the Historic Preservation Commission, the Department of Police Accountability, the Department of Public Works, the Law Library, the Municipal Transportation Agency, refunding bonds, the Health Service System, the Redistricting Board, the Parks,

Recreation, and Open Space Advisory Committee, the Children and Youth Fund, transition provisions, and contractors' working conditions.

2. Board of Supervisors' Modification of Initiative Ordinances. The Charter amendment would:

- Require the Board of Supervisors to amend initiative ordinances to eliminate the Advisory Committee of Street Artists and Crafts Examiners; to adjust membership criteria for the Sunshine Ordinance Task Force; to rename the Citizens' General Obligation Bond Oversight Committee; to rename the Sugary Drinks Distributor Tax Advisory Committee, specify that the Department of Public Health will provide administrative support, and provide for the body's sunset upon expiration of the Sugary Drinks Distributor Tax; to eliminate a specific procedural requirement of the Legacy Business Program; and to move the Refuse Collection and Disposal Ordinance to the Administrative Code.
- Authorize the Board of Supervisors to amend the Official Newspapers initiative ordinance by a two-thirds vote, and to amend or eliminate the Our City Our Home Oversight Committee by a majority vote.

3. Boards, Commissions and Advisory Bodies. The Charter amendment would make the following changes impacting boards, commissions, and advisory bodies:

- Require that the Commission Streamlining Task Force be convened every ten years, without the existing requirements that the Budget and Legislative Analyst prepare a report and the City Attorney prepare a draft Charter Amendment implementing the Task Force's recommendations.
- Remove the general requirement that Boards and Commissions develop and keep an annual statement of purpose, appoint an executive secretary, and prepare an annual report.
- Move to code the Charter sections establishing the Human Services Commission, the Disability and Aging Services Commission, the Abatement Appeals Board, Access Appeals Commission, Code Advisory Committee, any technical boards and advisory committees under the Department of Building Inspection, the Parks, Recreation, and Open Space Advisory Committee, PUC's Citizens' Advisory Council and Rate Fairness Council, and the MTA's Citizens' Advisory Council.
- For the MTA's Citizens' Advisory Council, add a requirement that the Council include both pedestrians and cyclists.

- For the Youth Commission, eliminate language prohibiting compensation or expense reimbursements for commissioners.
- For the Homelessness Oversight Commission, require that two seats be held by people who have personally experienced homelessness, but otherwise make current qualifications for members desirable rather than mandatory.
- For the Asian Art Commission, authorize the Commission members to elect new members and to change the total number of members (not to exceed 20).
- For the Fine Arts Museums Board of Trustees, remove language purporting to authorize the Board to act by majority of members present at the meeting and reduce the maximum number of Trustees.
- Authorize the governing board of the War Memorial to enter into agreements with an outside entity to develop or operate the War Memorial and to raise funds for its support.
- For the Public Utilities Commission ("PUC"), make current qualifications for members desirable rather than mandatory, and add a requirement that one seat be held by a person with experience in labor representation.
- Specify that Retirement Board, Health Service Board, and Retiree Health Care Trust Fund Board elected members may only be removed for official misconduct.
- Eliminate the Sanitation and Streets Commission, the Public Works Commission, and the Dignity Fund Oversight and Advisory Committee Service Provider Working Group.
- Change the name of the Children, Youth, and their Families Oversight and Advisory Committee to the Children, Youth, and their Families Oversight and Advisory Commission without changing its functions; rename the Service Provider Working Group as the Service Provider Advisory Council, without changing its functions; and update the five-year planning cycle to restart in 2026-2027.
- Combine the Our Children, Our Families Council with the Our Children, Our Families Initiative, to be responsible for developing and implementing a five-year plan for supporting children, youth, and families.
- Combine the Dignity Fund Oversight and Advisory Committee and the Advisory Council to the Disability and Aging Services Commission into a new advisory body named the Disability and Aging Services Advisory and Oversight Council. Transfer the new body to code, with changes to its name and composition, and provide for the sunset of the Advisory Council to the Disability and Aging Services Commission.

4. Department Operations and Reporting Requirements. The Charter amendment would make changes impacting departments that include the following:

- Give the City Administrator authority to conduct long-term real estate strategic planning and negotiate and manage acquisitions, leases, and conveyances of real property owned or controlled by, or for the use of, the City, subject to Charter Section 9.118, to the extent consistent with applicable law and Charter provisions, and excluding activities of the Airport, Port, Public Utilities Commission, and Municipal Transportation Agency.
- Remove the requirement that the Planning Department consult with the City Administrator in preparing the General Plan.
- For the Municipal Transportation Authority (“MTA”), codify the MTA’s existing authority over taxi-related functions, fares, fees, and personnel; simplify the standard for the MTA Board to use in determining on-time performance; eliminate the requirement for MTA to issue a separate climate action plan, direct MTA to participate in citywide climate planning efforts, and conform target levels to existing law; eliminate training requirements, eliminate references to the Interdepartmental Staff Committee on Traffic and Transportation; and conform to the current state of the law the language addressing the evidentiary standard for an employee organization to meet in a mediation or arbitration.
- For the Public Utilities Commission department, make general updates; update the PUC’s exclusive charge to encompass design, in addition to construction, management, operation, and use of water, power, and sewer infrastructure, facilities, and associated real, personal, and financial assets.
- Eliminate the requirement that funds received by utilities operated by the PUC be paid into separate funds in the City treasury.
- Change the frequency of the City Administrator’s submission of a report on implementation of the Privacy First Policy from every three to every five years.
- Streamline the responsibilities of the City Services Auditor, and remove the requirement that employees involved in the preparation of audits be designated as confidential employees.
- Move to code the requirement that the Controller assess departments’ compliance with customer service plan requirements.
- Move to code the requirements that each department provide the Mayor and Board of Supervisors mission-driven budget details together with certification of commitment to

perform at a specified level, and that the Controller report departmental savings and revenue gains within 30 days of the annual financial report.

- Remove specific dates for the submission of various plans related to the Park, Recreation and Open Space Fund and update the required contents of the Capital Expenditure Plan.
- Require the Controller and City Administrator to provide administrative, professional, and technical assistance to the Streamlining Task Force, rather than the City Administrator providing administrative assistance and the Controller providing professional and technical assistance.

5. Other Changes. The Charter amendment would make the following other changes:

- Provide that the Board of Supervisors shall approve settlements or dismissals of legal proceedings recommended by the City Attorney by resolution, rather than by ordinance.
- In compliance with a decision from the California Public Employee Relations Board, remove provisions allowing disciplinary action against non-Police and Fire striking employees.
- Authorize the Board of Supervisors, by ordinance, to change the name of any department, board, commission, or other unit of government.

Background Information

This legislative digest reflects changes made by the Rules Committee on June 22, 2026 (Second Draft); including the following:

- Giving the City Administrator authority to conduct long-term real estate strategic planning and negotiate and manage acquisitions, leases, and conveyances of real property owned or controlled by, or for the use of, the City, subject to Charter Section 9.118, to the extent consistent with applicable law and Charter provisions, and excluding activities of the Airport, Port, Public Utilities Commission, and Municipal Transportation Agency.

Dear Ms. Calvillo,

Should the proposed Charter amendment be approved by the voters, in my opinion, it would have a moderate impact on the cost of government, saving \$365,000 to \$450,000 annually. Additional costs and savings are dependent on the decisions that the Mayor and Board of Supervisors make through the normal budget process.

The proposed Charter amendment 1) modifies boards, commissions, and advisory bodies; 2) changes departmental operations and reporting requirements; 3) changes how the Board of Supervisors must approve settlements or dismissals of legal proceedings recommended by the City Attorney; 4) removes provisions allowing disciplinary action against non-Police and Fire striking employees; and 5) makes other edits and changes to the Charter and past voter-approved ordinances. The Charter amendment may reduce required staff time to support boards, commissions, and advisory bodies—freeing staff to work on other government functions.

The proposed Charter amendment creates cost savings ranging from \$365,000 to \$450,000 annually by eliminating the Sanitation and Streets Commission, Public Works Commission, and the Street Artists and Craftsmen Examiners Advisory Committee. The Sanitation and Streets Commission and Public Works Commission shared two full-time staff members with annual costs of \$336,000.

Convening the Commission Streamlining Task Force (CSTF) every ten years would require staff to implement and administer the CSTF, including conducting analyses, writing public reports, and holding public meetings. The proposed Charter amendment removes the existing requirements for the Budget and Legislative Analyst to prepare a report and the City Attorney to prepare a draft Charter amendment implementing the CSTF's recommendations from CSTF's mandate. For context, convening the CSTF in 2025 required approximately 5,900 hours of staff time.

Additional costs and savings are dependent on the decisions that the Mayor and Board of Supervisors make through the normal budget process. For example, the proposed Charter amendment removes the restriction on compensating Youth Commission members which may

lead to future costs, likely ranging from \$5,000 to \$85,000 annually, should policymakers seek compensation for the members. Certain appointive boards and commissions pay stipends to the commissioners on a per meeting basis ranging from \$25 to \$500 per meeting. Other commissioners are paid between \$100 and \$500 per month. Not all commissioners receive stipends. The amount of cost savings attributed to removing the requirement of hiring an executive secretary for commissions cannot be determined at this time as bodies may opt not to fill the position.

The proposed amendment updates commission responsibilities and membership requirements for remaining commissions and boards but will not directly impact the total cost to government. The amount of staff time needed to support commissions and boards may decrease—freeing staff to work on other government functions, although at a level that cannot be determined at this time.

Note that the proposed amendment would change the duties of the Controller's Office, which has prepared this statement.

Dear Members of the Board of Supervisors,

I am writing to respectfully ask that you vote no on the proposed Charter Amendment regarding Department, Board, Commission, and Advisory Body Updates.

These proposed changes would weaken civilian oversight, reduce transparency, and limit meaningful community engagement. San Francisco's commissions exist to ensure residents have a voice in the decisions that affect their communities by providing oversight, accountability, and a direct connection between City government and the people it serves.

As commissioners, we volunteer our time because we care about our communities and believe government works best when it listens to the people it represents. Commissions should have the authority to work with their departments to help establish goals, identify priorities, and advocate for the communities they serve. They should not be reduced to advisory bodies in name only or be subject to political influence that undermines their ability to provide independent oversight. When commissions lose authority, the public loses an important avenue for accountability and civic participation.

I am also concerned by the pattern of proposals that fail to gain public support but continue to return until voter fatigue sets in, and they eventually pass. That approach does not build public trust. Instead, it creates frustration, discourages civic engagement, and leaves residents feeling that their voices no longer matter.

These concerns are even greater when viewed alongside the Mayor's proposed Charter amendments. Together, they would expand the Mayor's authority over hiring and firing department leaders, allow commissioners to be removed without cause by the appointing authority, and increase the Mayor's ability to reorganize departments and shift oversight to deputy mayors.

My concern is that voters will see words like "efficiency" and "streamlining" without fully understanding the impact of these changes. Efficiency should never come at the expense of independent oversight, community representation, or the checks and balances that keep our government accountable. Concentrating more authority in one office while weakening commissions moves San Francisco away from the transparent, participatory government that has long been one of its strengths.

I urge you to vote **no** on the following proposals:

- **Requiring the Commission Streamlining Task Force to convene every ten years without requiring a report from the Budget and Legislative Analyst or a draft Charter Amendment from the City Attorney.** *Those requirements provide essential analysis, transparency, and accountability before significant structural changes are considered.*
- **Removing the requirement that boards and commissions maintain an annual statement of purpose, appoint an executive secretary, and prepare an annual report.** *These are basic governance practices that promote transparency, clarify each body's mission, and help the public understand its work.*

- **Authorizing the Board of Supervisors to change the name of any department, board, commission, or other unit of government by ordinance.** *While this may appear to be an administrative change, these names often reflect the history, purpose, and communities those bodies represent.*

San Francisco has built a strong tradition of public participation through its commissions. They provide residents with a place to ask questions, raise concerns, and help shape public policy. Preserving meaningful civilian oversight ensures that government remains

Eventually the Board of Supervisors made additional changes to the proposed Charter Amendment during the Rules Committee’s June 22 meeting, including:

- Require that the Commission Streamlining Task Force be convened every ten years, without the existing requirements that the Budget and Legislative Analyst prepare a report and the City Attorney prepare a draft Charter Amendment implementing the Task Force’s recommendations.
- Eliminating the requirement that funds received by utilities operated by the PUC be paid into separate funds in the City treasury.
- Authorizing the Board of Supervisors, by ordinance, to change the name of any department, board, commission, or other unit of government.
- Authorizing the Board of Supervisors, by ordinance, to change the name of any department, board, commission, or other unit of government.
- Requiring the Controller and City Administrator to provide administrative, professional, and technical assistance to the Streamlining Task Force, rather than the City Administrator alone providing administrative assistance and both the Controller and City Administrator providing professional and technical assistance

None of the five changes listed above were discussed, or voted on, by the Commission Streamlining Task Force.

Supervisor Raphael Mandelman’s Legislative Aide, Renil Bejoy, finally acknowledged on May 27 that a list of which of the Streamlining Task Force’s recommendations had been deemed by the Board of Supervisors to be “*non-controversial*” vs. “*controversial*” wasn’t located, saying “*No Responsive Records exist*” in response to a records request. Moreover, San Franciscans have no way of knowing how the proposed language in this particular Charter Amendment will interact
