3 **Resolution authorizing the Sheriff's Department to accept and expend a grant**
4 **in the amount of \$397,934 from the Substance Abuse and Mental Health Services**
5 **Administration for providing jail diversion opportunities involving integrated**
6 **mental health and substance abuse treatment for incarcerated women.**

7 WHEREAS, The Substance Abuse and Mental Health Services Administration has
8 made available funding for jail diversion programs; and,

9 WHEREAS, Due to the need for jail diversion opportunities among female
10 Offenders with co-occurring disorders, the Sheriff's Department will provide a program
11 to offer integrated mental health and substance abuse services; and,

12 WHEREAS, The grant identifies non-federal funds of \$142,252; and,

13 WHEREAS, The grant does not include provision for indirect costs for year
14 two, be it

15 RESOLVED, That the grant award notification has been received from the
16 Substance Abuse and Mental Health Services Administration; and, be it

17 FURTHER RESOLVED, That the grant provides for the creation of three
18 positions as follows: 0.5 FTE class 8420, Rehabilitation Services Coordinator at
19 a salary of \$1,373 bi-weekly; 0.5 FTE Health Worker II at a salary of \$909 bi-weekly;
20 0.5 FTE Epidemiologist II at a salary of \$1,514 bi-weekly; and, be it


21 FURTHER RESOLVED, That the Board of Supervisors of the City and County






