3 **Motion appointing Ruslan Gurvits (residency requirement waived), term ending June 6,**
4 **2019, to the Immigrant Rights Commission.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does
7 hereby appoint the hereinafter designated person to serve as a member of the Immigrant
8 Rights Commission, pursuant to the provisions of Administrative Code, Section 5.201, for the
9 term specified:

10 Ruslan Gurvits (residency requirement waived), seat 10, succeeding Melba
11 Maldonado, term expired, must be appointed in accordance with Charter, Section 4.101, and
12 have a demonstrated knowledge of and interest in the health, human service, educational, or
13 employment issues that affect immigrants residing in San Francisco and shall reflect the
14 geographic, ethnic, and sexual orientation population of San Francisco, for the unexpired
15 portion of a two-year term ending June 6, 2019.

16 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 17 1. The membership of the Immigrant Rights Commission has a goal to be
18 representative of the diversity of the City and County of San Francisco.
19 2. Applicant Ruslan Gurvits, who is not a resident of San Francisco, is a person with
20 experience that uniquely qualifies them to serve on the Immigrant Rights
21 Commission.
22 3. The Immigrant Rights Commission has attempted to fill the positions, for which
23 Ruslan Gurvits was nominated, with an individual who is a City resident and who
24 has the specific experience, skills, and qualifications, but has been unable to do so

- 4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco, and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Immigrant Rights Commission at this time; and, be it

FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Ruslan Gurvits, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Charter, Section 4.101, that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
