2 **Resolution commending and honoring Leslie Katz for her distinguished service as**  
3 **Supervisor of the City and County of San Francisco.**

5 WHEREAS, Supervisor Leslie Katz was appointed by Mayor Willie L. Brown, Jr., in  
6 1996, and was elected that same year to serve the people of the City and County of San  
7 Francisco; and,

8 WHEREAS, Supervisor Katz has served this community with a strong sense of ethics;  
9 and,

10 WHEREAS, Supervisor Katz has played an instrumental role in shaping the future of  
11 the City and County's information technology strategies; and,

12 WHEREAS, Supervisor Katz has served on the San Francisco County Transportation  
13 Authority, Peninsula Corridor Study Joint Powers Board, and on the Executive Committee of  
14 the Association of Bay Area Governments; and numerous Board of Supervisors' Standing  
15 Committees; including, but not limited to, as Chair of the Transportation and Land Use  
16 Committee, and as a Member of the Audit and Government Efficiency Committee; and,

17 WHEREAS, Supervisor Katz co-authored the landmark legislation, the Equal Benefits  
18 Ordinance, that has become a model across the nation for states, municipalities, and private  
19 companies to recognize domestic partners and provide them with equal employee benefits;

21 WHEREAS, Supervisor Katz also introduced significant legislation regarding the cable  
22 franchise agreement with Atlantic Telephone & Telegraph (AT&T), and RCN Telecom  
23 Services of California, Inc., addressed pressing transportation issues, E-commerce issues,  
24 and legislation which encouraged bicycle usage; now, therefore, be it




