13 declared to be a part of this motion as if set forth fully herein; and,

14 WHEREAS, As set forth in the Resolution, in order to enable the CFD to finance the  
15 public improvements described therein, Section 6586.5(a)(2) of the California Government  
16 Code requires that this Board of Supervisors hold a public hearing regarding the proposed  
17 CFD financing and make certain findings with respect to the proposed financing; now,  
18 therefore, be it

19 MOVED, That the Board of Supervisors shall convene as a Committee of the Whole at  
20 3:00 p.m. on April 4, 2006 to accept public testimony on the formation of the CFD, the CFD  
21 financing and other matters set forth in the Resolution.


