Resolution authorizing the Municipal Transportation Agency to accept and expend \$540,000 of Traffic Congestion Relief Program funds for improvements to the Geneva Office Building.

WHEREAS, The California Transportation Commission is authorized to make Traffic Congestion Relief Program funds available pursuant to the Traffic Congestion Relief Act of 2000; and,

RESOLVED, That the Board of Supervisors authorizes the Municipal Transportation Agency to accept and expend \$540,000 of Traffic Congestion Relief Program (TCRP) funds from the California Transportation Commission through the Bay Area Rapid Transit District for
