3 **Resolution commending Pets Unlimited and the Pets Are Wonderful Support ("PAWS)**  
4 **for collaboration in hosting this year's Doggone Fun Run on September 14, 2003 at**  
5 **Lindley Meadow in Golden Gate Park.**

7 WHEREAS, Pets Unlimited was founded in 1947 by a group of citizens concerned  
8 about the welfare of San Francisco's stray animals, where they began rescuing dogs from the  
9 City pound and finding homes for them; and,

10 WHEREAS, Over the years, Pets Unlimited was able to purchase a site to provide  
11 veterinary, hospital and shelter services and later was also able to expand the shelter and  
12 launch innovative charity, community and education programs; and,

13 WHEREAS, By 1989, the Pets Unlimited hospital expanded to a 24-hour emergency  
14 facility to meet the growing needs of the community, combined with a substantial growth in  
15 scope for all other programs and services; and,

16 WHEREAS, Since its inception, Pets Unlimited has been instrumental in saving lives of  
17 more than 250,000 animals, and has gone on to earn the reputation as the premier provider of  
18 comprehensive and humane animal treatment in the Bay Area; and,

19 WHEREAS, Through the creation of and efforts by the Pets Unlimited Adoption Center,  
20 each year thousands of pets are saved from either being euthanized or sold for medical  
21 research as a result of staff making weekly rescue trips to shelters in the Bay Area and  
22 surrounding counties to save these pets from a hopeless future; and,

23 WHEREAS, The mission of the Pets Unlimited Adoption Center is to find and rescue as  
24 many injured and neglected pets as possible, provide quality medical treatment and find them  
25 loving homes; and,

1           WHEREAS, Pets Unlimited is a non-profit hospital in San Francisco, is open 24 hours  
2 and 7 days a week and serves as a temporary shelter to animals as they await placement in a  
3 permanent home; and,

4           WHEREAS, For this reason, Pets Unlimited continually partners with other non-profit  
5 animal service providers to raise the necessary funds needed to serve over 40,000 animals in  
6 the coming year; now, therefore, be it

7           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 does hereby commend Pets Unlimited for over 50 years of service and concern for the welfare  
9 of stray animals; and, be it

10          FURTHER RESOLVED, That the Board of Supervisors does hereby commend Pets  
11 Unlimited and PAWS for collaboration in hosting this year's Doggone Fun Run, which will be  
12 held on September 14<sup>th</sup>, 2003 at Lindley Meadow in Golden Gate Park.




