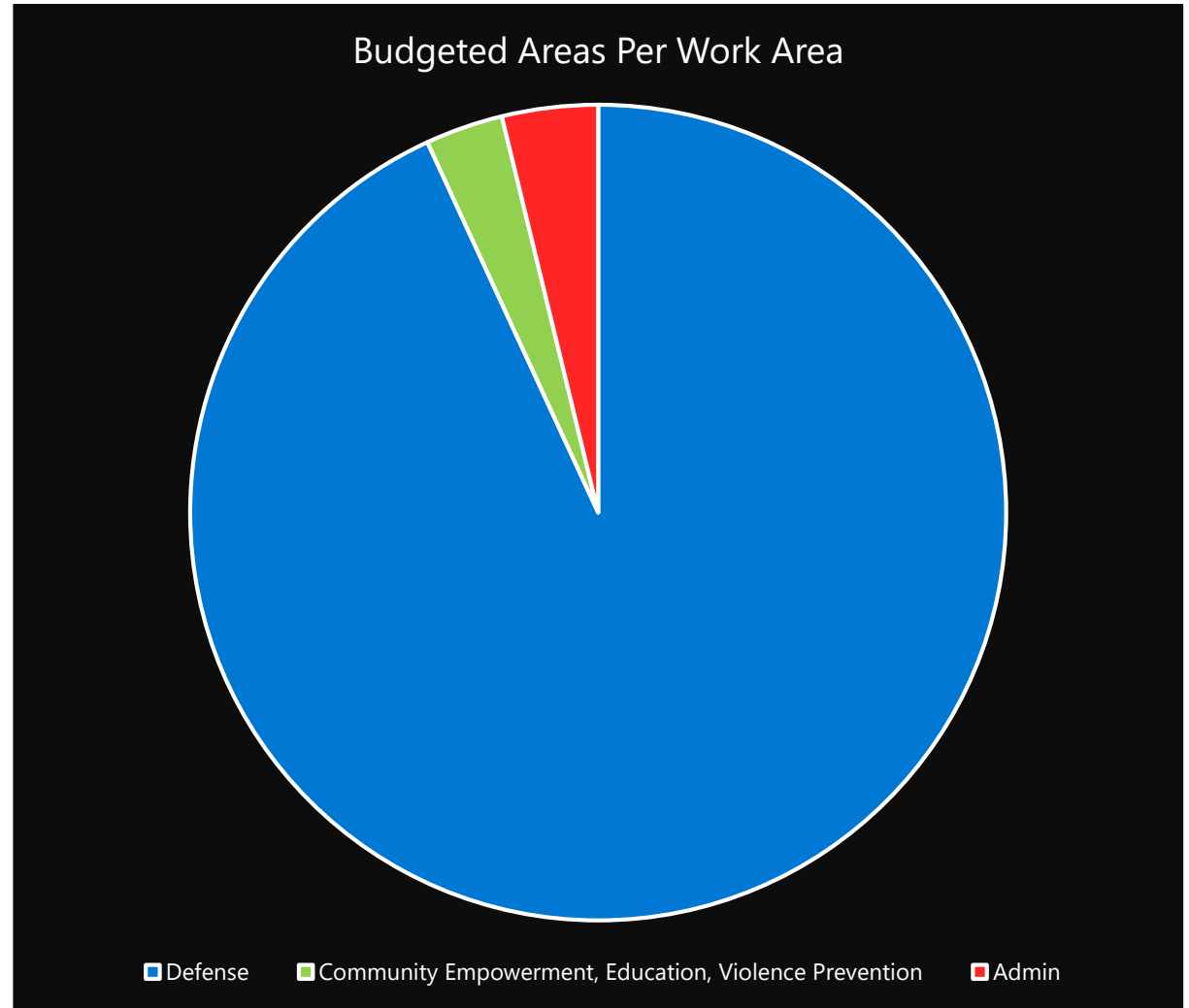

We Defend the Accused

- **93%** of our people-power is devoted to ***holistically defending*** the accused in all stages of misdemeanor, felony, mental health, juvenile, and immigration cases
- **4%** funds administrative functions (HR, Payroll, Finance)
- **3%** funds public education, community empowerment, and violence prevention



Training the Next Generation: Dream Keepers Initiative

- **Litigation Warriors: Internship program** designed for 1 attorney, 1 post bar fellow, and 8 law school or undergrad students. \$90k in funding.
- **Courtwatch: Criminal Defense Informational Workshops** to educate the next generation of public defenders. \$10k in funding.

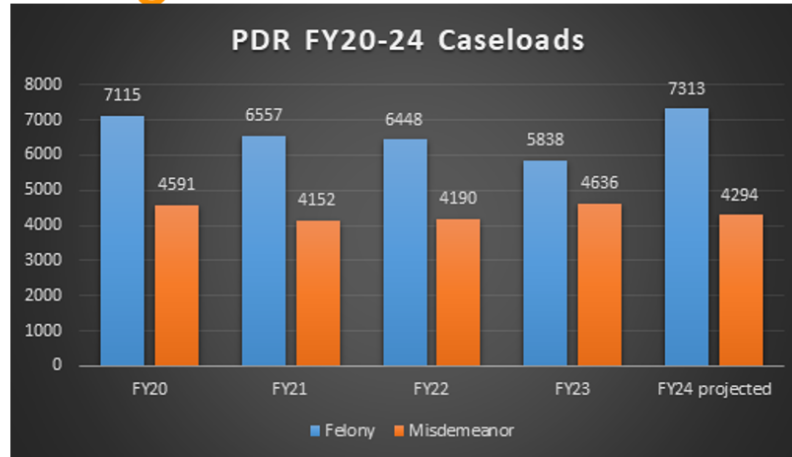


Our Biggest Challenge: Rising Caseloads + Workloads

Last Year We Flagged this “Rising Crisis”

Rising Crisis

Average caseloads for line attorneys



Causes:

- 1) Trial delays/backlog in recent years
- 2) Increase in arrests by the police and felony and misdemeanor filings by the DA
- 3) Drastic reduction in referrals to diversion programs and specialty courts
- 4) Increased workloads due to changes in state law (e.g. Racial Justice Act and Mental Health Diversion) and technological advances (body-worn camera, video surveillance footage and cell phone technology) impacting most cases .

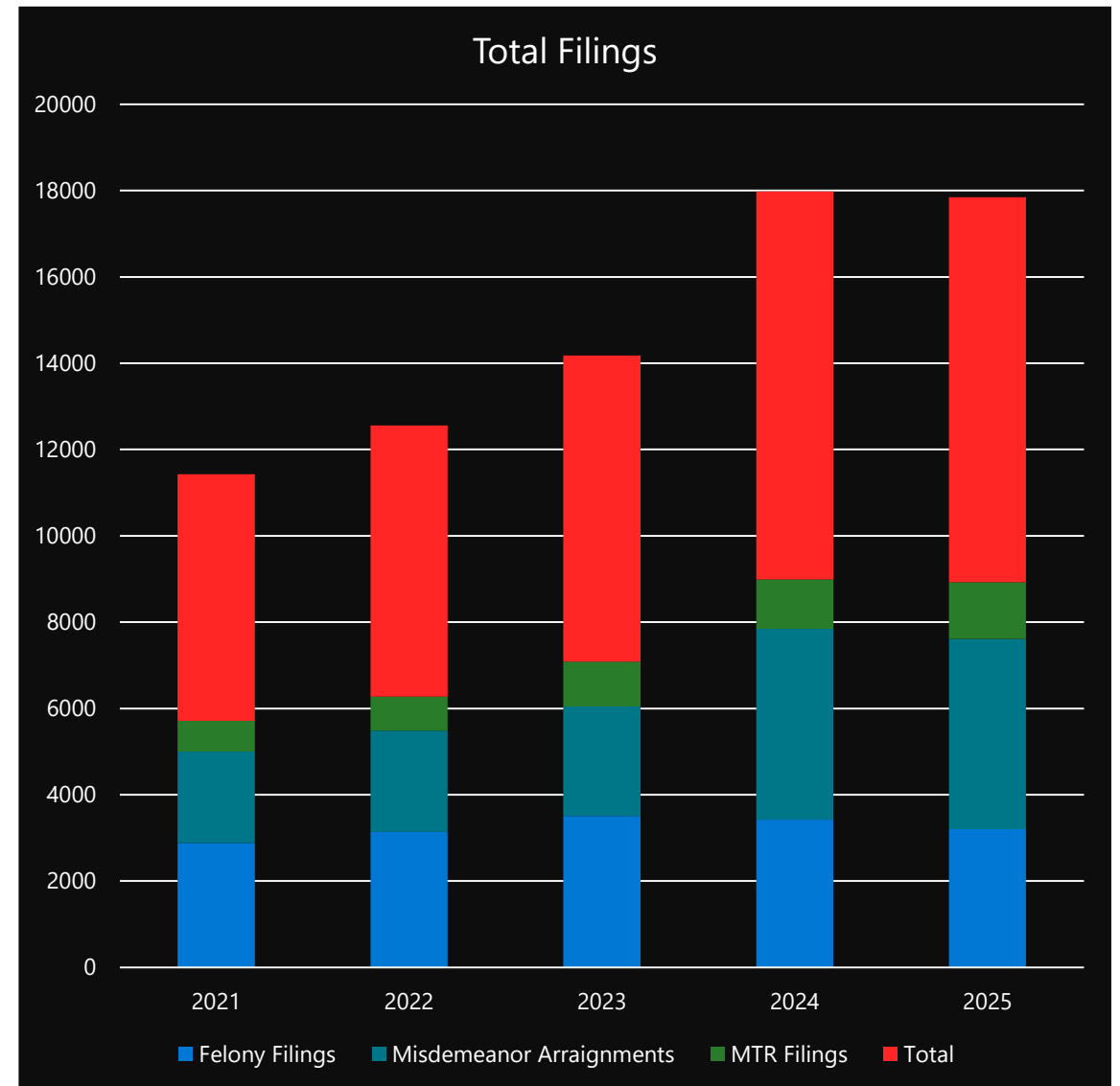

Underpinning this increase, police have brought far more arrests to the district attorney's office under Jenkins, a shift that began almost immediately after she took office, data shows. (Arrests can be affected both by police priorities and a DA's priorities, since there's no use arresting someone who won't be charged in court.)

57% since 2021*

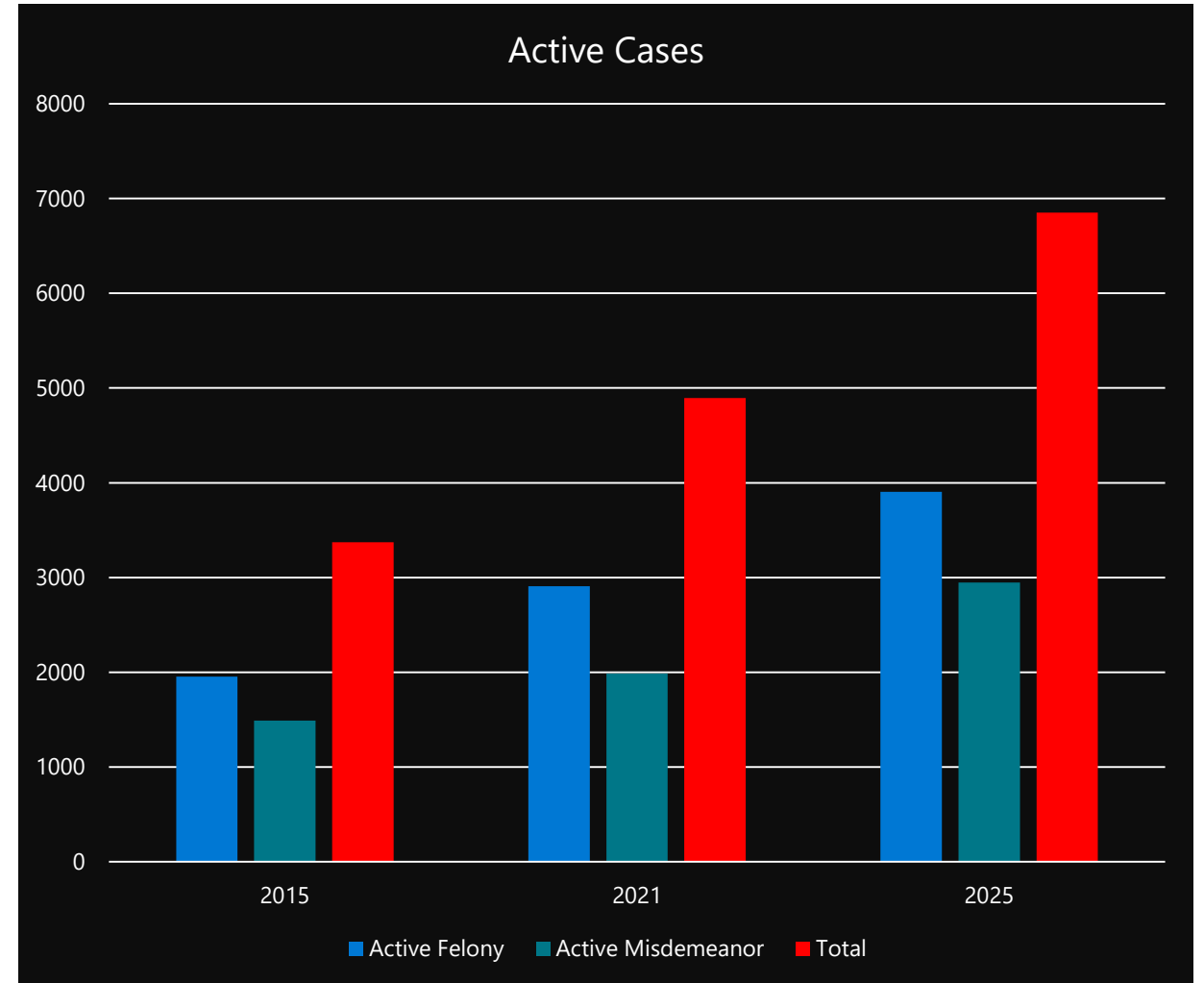

Our Caseloads + Workloads Are Increasing

Active cases have increased by:

- *40% in 5 years*
- *103% in 10 years*

DA Estimates Filing 2,000 *More* Cases Annually

“We anticipate that the police will be arresting more people, and we will need to rise to meet that challenge in charging and seeing cases through to conviction. Estimating an additional 10 arrests a day would result in a 25% increase in annual arrests amounting to approximately **2,000 more cases filed annually.”**

Evidence Our Caseloads + Workloads Are Increasing

We are on track to complete 150 misdemeanor jury trials in 2025:

- Thus far this year **80%** have resulted in acquittals or hung juries

In 2024, our defense teams took 91 felony cases to trial, the most in the history of our office:

- **40%** resulted in acquittals or hung juries
- **30%** resulted in mixed verdicts

Rising Workloads & Complex Cases



+40%

Increase in bail motions filed in 2024 compared to 2021, driven by jail population being at 100%+.



110+

Increase in California Racial Justice Act motions filed during 2024 and 2025 to address racial bias.



+59%

Increase in body-worn camera footage received and reviewed this year, reflecting more labor-intensive defense work.

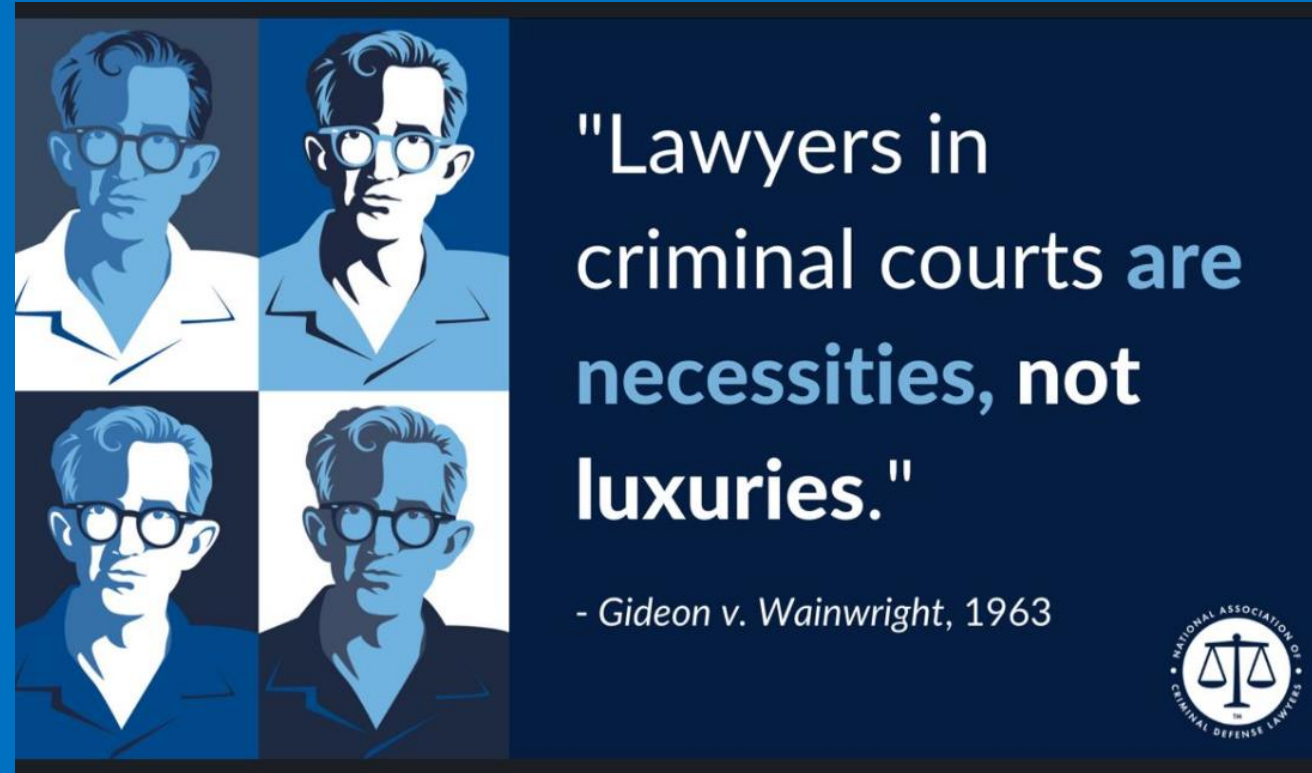
Cases affected by DA-issued Brady notifications concerning misconduct by SFPD officers, adding complexity to defense efforts.

Declaring Unavailable

To ensure we can:

- 1) meet our **Constitutional mandate to provide effective assistance of counsel** and
- 2) give the **appropriate time and attention to each existing client.**

We have **declared unavailable** to accept misdemeanor cases one day a week and select felony cases.



**Clarence Earl Gideon was plaintiff in the landmark US Sup. Ct. case ruling that the 6th Amendment requires attorneys to be appointed to indigent people who are accused.*

Declaring Unavailable Is Grounded in the Law

Under the Penal Code ... a conflict of interest is inevitably created when an appointed counsel is compelled by his or her **excessive caseload to choose between the rights of the various indigent defendants he or she is representing.**

In re Edward S. (2009) 173 Cal.App.4th 387.

If workload prevents a lawyer from providing competent and diligent representation to existing clients, she must not accept new clients.

American Bar Association, Standing Committee on Ethics and Professional Responsibility, Formal Opinion 06-441

Defense providers are obligated to take steps necessary to address excessive workload, which can include notifying the court or other appointing authority that the Provider is **unavailable** to accept additional appointments.

"Overloaded public defense attorneys simply cannot give appropriate time and attention to each client.

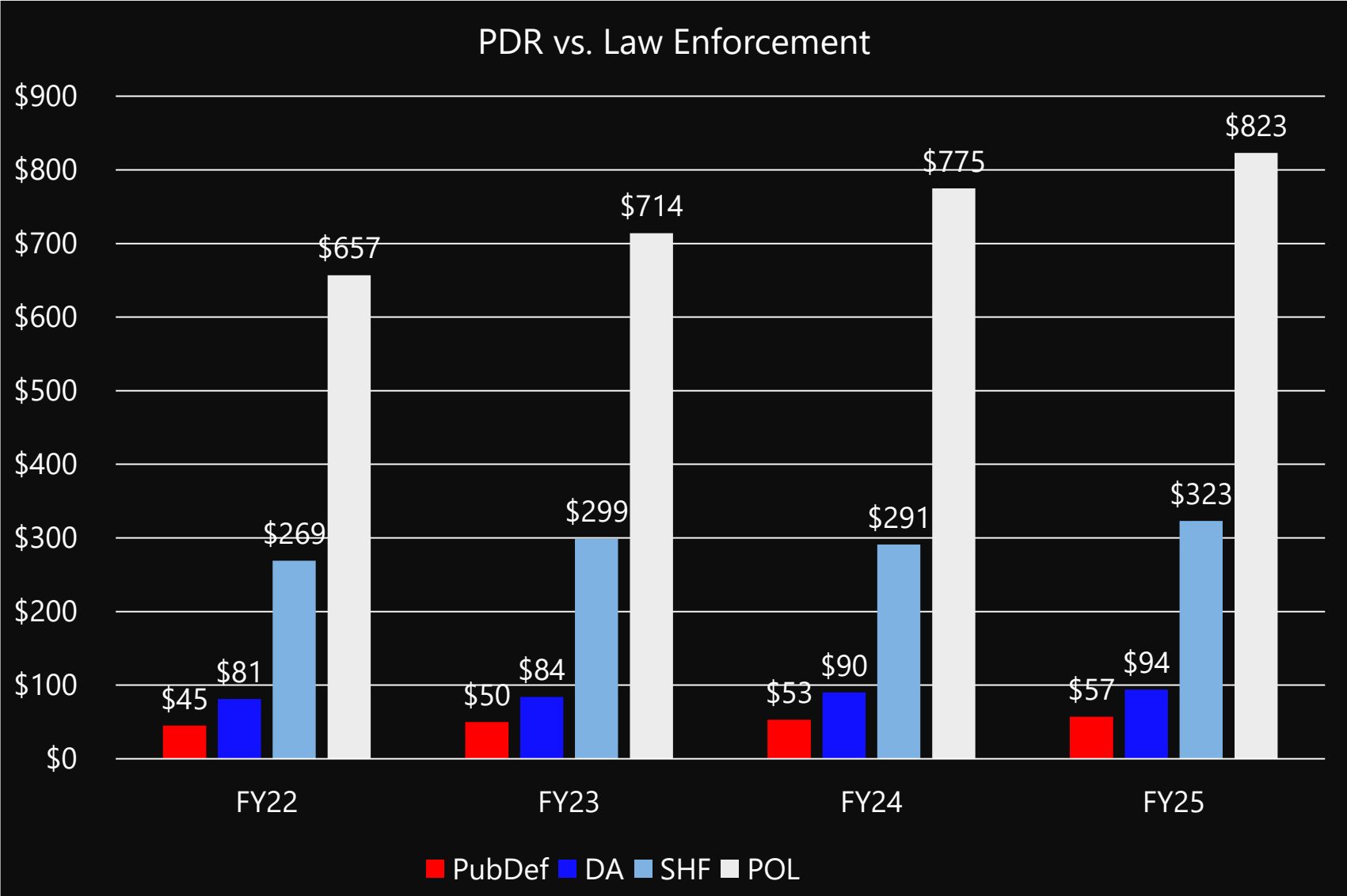
They cannot investigate in a timely manner or fully. They cannot file the motions they should.

Instead, attorneys are forced to triage cases, choosing which cases to focus attention on while allowing others to be resolved without appropriate diligence.

A justice system burdened by triage risks unreliability – denying all people who rely on it – victims, witnesses, defendants, and their families and communities – efficient, equal, and accurate justice."

Disparities in Funding Persist

- *Our budget is 60% of the DA's*
- *Our budget is 2175% less than law enforcement's(DA, Sheriff, and Police)*

Accept + Expend to Bolster Deportation Defense

- Access to immigration lawyers is critical. **Immigrants who are represented in deportation proceedings are *five times* more likely to win their case than those who are unrepresented.**
- We applied for and secured funding for **three 8177 attorney positions and one 8173 paralegal position** from a foundation based in San Francisco, specifically for our Immigration Unit to meet the increasing need for immigration defense.
