2 AUTHORIZING THE DIRECTOR OF AGING AND ADULT SERVICES TO ACCEPT AND  
3 EXPEND A GIFT FROM THE SAN FRANCISCO HOSPITAL COUNCIL, ACTING THROUGH  
4 HEALTH PLUS SERVICES, IN THE AMOUNT OF \$37,000 FOR CREATION OF A LIAISON  
5 PROGRAM BETWEEN THE PUBLIC GUARDIAN AND MEMBER HOSPITALS.

7 WHEREAS, The hospitals of San Francisco are experiencing an increase in patients who require  
8 appointment of a conservator; and,

9 WHEREAS, These hospitals, acting through the San Francisco Hospital Council, desire to  
10 mitigate the use of acute-care beds by patients in need of conservatorship; and,

11 WHEREAS, Other counties in California have been able to reduce acute-care days through  
12 innovative public-private partnerships; now, therefore, be it

13 RESOLVED, That the Director of Aging and Adult Services be hereby authorized to accept and  
14 expend a gift of \$37,000 from the San Francisco Hospital Council, acting through Health Plus Services,  
15 for the purpose of creating a liaison program between member hospitals and the San Francisco Public  
16 Guardian, pursuant to an agreement to be executed between the City and Health Plus Services, copy  
17 attached hereto; and, be it

18 FURTHER RESOLVED, That the Public Administrator-Public Guardian is authorized to create  
19 a Limited-Term position of job code 2588 Health Worker IV to perform this liaison function, subject to  
20 the condition that all costs attendant to this position shall be funded from the proceeds of this gift, copy  
21 of budget attached hereto, and that should this funding be cancelled or withdrawn, then the authorization  
22 for this position shall terminate as well.


