3 **Resolution appointing Alec Lambie, Gordon Huseby, Hayes Miles and David Wilbur**  
4 **terms ending September 4, 2006 to the Assessment Appeals Board #1.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated persons to serve as members of the  
8 Assessment Appeals Board #1, pursuant to the provisions of the Revenue and Taxation  
9 Code, Section 1623, and the San Francisco Administrative Code, Section 2B.1 through 2B.11,  
10 for the term specified:

11 Alec Lambie, succeeding himself, term expired, seat 2, must meet the eligibility criteria  
12 set forth in Section 1624.05 of the California Revenue and Taxation Code as follows: a person  
13 shall not be eligible for nomination for membership on an assessment appeals board unless  
14 he or she has a minimum of five years' professional experience in this state as one of the  
15 following: certified public accountant or public accountant, licensed real estate broker,  
16 attorney, or property appraiser accredited by a nationally recognized professional organization  
17 for a three year term ending September 4, 2006.

18 Gordon Huseby, succeeding Frank Mahoney, III, term expired, seat 5, must meet the  
19 eligibility criteria set forth in Section 1624.05 of the California Revenue and Taxation Code as  
20 follows: a person shall not be eligible for nomination for membership on an assessment  
21 appeals board unless he or she has a minimum of five years' professional experience in this  
22 state as one of the following: certified public accountant or public accountant, licensed real  
23 estate broker, attorney, or property appraiser accredited by a nationally recognized  
24 professional organization for a three year term ending September 4, 2006.

1 Hayes Miles, succeeding himself, term expired, seat 6, must meet the eligibility criteria  
2 set forth in Section 1624.05 of the California Revenue and Taxation Code as follows: a person  
3 shall not be eligible for nomination for membership on an assessment appeals board unless  
4 he or she has a minimum of five years' professional experience in this state as one of the  
5 following: certified public accountant or public accountant, licensed real estate broker,  
6 attorney, or property appraiser accredited by a nationally recognized professional organization  
7 for a three year term ending September 4, 2006.

8 David Wilbur, succeeding Donald Kavanagh, term expired, seat 8, must meet the  
9 eligibility criteria set forth in Section 1624.05 of the California Revenue and Taxation Code as  
10 follows: a person shall not be eligible for nomination for membership on an assessment  
11 appeals board unless he or she has a minimum of five years' professional experience in this  
12 state as one of the following: certified public accountant or public accountant, licensed real  
13 estate broker, attorney, or property appraiser accredited by a nationally recognized  
14 professional organization for a three year term ending September 4, 2006.


