Be it ordained by the people of the City and County of San Francisco:

Section 1. Article 10 of the San Francisco Traffic Code is hereby amended by
10 repealing Sections 175.09 and 175.10, which read as follows:

~~SEC. 175.09. A prima facie speed limit of 30 miles per hour is hereby established on Brazil
12 Avenue between Dublin Street and Mansell Street.~~

~~SEC. 174.10. A prima facie speed limit of 30 miles per hour is hereby established on Persia
14 Avenue between Dublin Street and Mansell Street.~~

15

Section 2. Article 10 of the San Francisco Traffic Code is hereby amended by
16 adding Sections 174.11 and 174.12, to read as follows:

SEC. 174.11. A prima facie speed limit of 25 miles per hour is hereby established on Brazil
18 Avenue between La Grande Avenue and Mansell Street.

SEC. 174.12. A prima facie speed limit of 25 miles per hour is hereby established on Persia
20 Avenue between Dublin Street and Mansell Street.




