6 **College of the Arts, and provide a regulatory scheme for a potential future phased**
7 **expansion of the campus; and making environmental findings, Planning Code, Section**
8 **302, findings, and findings of consistency with the General Plan and the priority**
9 **policies of Planning Code, Section 101.1**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Findings.

15 (a) The Planning Department has determined that the actions contemplated in this
16 Ordinance comply with the California Environmental Quality Act (Public Resources Code
17 Section 21000 et seq.). Said determination is on file with the Clerk of the Board of
18 Supervisors in File No. 111278 and is incorporated herein by reference.

19 (b) Pursuant to Planning Code Section 302, this Board of Supervisors finds that this
20 Ordinance will serve the public necessity, convenience and welfare for the reasons set forth in
21 Planning Commission Resolution No. 18850 and incorporates those reasons herein by
22 reference. A copy of said Resolution is on file with the Clerk of the Board of Supervisors in
23 File No. 111278.

1 (c) This Board of Supervisors finds that this Ordinance is consistent with the Priorities
2 Policies of Section 101.1(b) of the Planning Code for the reasons set forth in Planning
3 Commission Resolution No. 18850 and incorporates said Resolution herein by reference.

4 Section 2. The San Francisco Planning Code is hereby amended by adding Section
5 249.67, to read as follows:

6 **SEC. 249.67. ART & DESIGN EDUCATIONAL SPECIAL USE DISTRICT.**

7 (a) Purpose. The Art & Design Educational Special Use District is intended to facilitate the
8 continued operation of the California College of the Arts campus at 1111 Eighth Street, which is
9 characterized by instruction in industrial arts and/or fine arts, while providing an appropriate
10 regulatory scheme for a potential phased expansion of the campus in the future.

11 (b) Geography. The boundaries of the Art & Design Educational Special Use District are
12 shown on Sectional Map No. SU08 of the Zoning Map. The area includes Parcel numbers 3808/004,
13 3820/002, 3820/003, 39123913/002, and 39123913/003.

14 (c) Controls. All provisions of the Planning Code currently applicable shall continue to apply,
15 including but not limited to the provisions of the PDR-1-D zoning district, except as otherwise provided
16 in this Section.

17 (1) Postsecondary Educational Institutional Uses. Postsecondary educational institutional
18 uses are exempted from use size limitations and shall be permitted as of right. Postsecondary
19 educational institutional uses for the purposes of academic, professional, business or fine-arts
20 education shall have an institutional master plan considered by the Planning Commission pursuant to
21 Section 304.5 of this Code.

22 (2) Student Housing. Student housing, as defined by Section 102.36 of this Code, is permitted
23 subject to the following requirements:

24 (i) For any housing project within this Special Use District, the standards for development,
25 project review, entitlement process, and impact fees of the UMU District shall apply.

1 (ii) The total number of beds on all parcels within the Special Use District shall not exceed
2 750. The number of beds per parcel is not limited, but will be determined by the regulations on the built
3 envelope of buildings, including height, bulk, setbacks, and lot coverage.

4 (3) Temporary Structures. The Zoning Administrator may authorize a temporary structure
5 without a public hearing provided that the structure is occupied by a use that is permitted by right or is
6 a use authorized by this Section 249.67.

7 Section 3. Pursuant to Planning Code Sections 106 and 302(c), and as duly approved
8 by resolution of the Planning Commission, Section Map SU08 of the Zoning Map of the City
9 and County of San Francisco shall designate the following real property as the Art & Design
10 Educational Special Use District:

16 Section 4. Effective Date. This ordinance shall become effective 30 days from the
17 date of passage.

18 Section 5. This section is uncodified. In enacting this Ordinance, the Board intends to
19 amend only those words, phrases, paragraphs, subsections, sections, articles, numbers,
20 punctuation, charts, diagrams, or any other constituent part of the Planning Code that are
21 explicitly shown in this legislation as additions, deletions, Board amendment additions, and
