3 **Resolution authorizing the Purchaser and Director of Office of Contract**  
4 **Administration to execute an agreement with Golden Gate Petroleum for diesel,**  
5 **biodiesel, and gasoline fuel, for an amount not to exceed \$94,000,000 for the term**  
6 **of September 1, 2013, through August 31, 2016, with two one-year options to**  
7 **extend for a total of five years, pursuant to Charter Section 9.118(b).**

9 WHEREAS, The Office of Contract Administration issued Contract Proposal  
10 70883 in May 2013 for diesel, biodiesel, gasoline and propane; and

11 WHEREAS, The Office of Contract Administration intends to award the  
12 primary contract for diesel, biodiesel and gasoline for all City departments to Golden  
13 Gate Petroleum, with an estimated amount of \$94 million during the initial term; and,

14 WHEREAS, The contract will have a term of three years, from September 1,  
15 2013 to August 31, 2016, with two one-year options to extend for a total of five years;  
16 and

17 WHEREAS, Charter Section 9.118(b) requires Board approval by resolution of  
18 contracts estimated to exceed \$10 million; now, therefore, be it

19 RESOLVED, That the Board of Supervisors authorizes the Purchaser and  
20 Director of Office of Contract Administration to award a the contract to Golden Gate  
21 Petroleum, for a not to exceed amount of \$94,000,000, in substantially the form on file  
22 with the Clerk of the Board in such final form as approved by the Purchaser and Director  
23 of Office of Contract Administration and the City Attorney; and, be it

1            FURTHER RESOLVED, That within thirty (30) days of the contract being fully  
2 executed by all parties, the Purchaser and Director of Office of Contract Administration  
3 shall provide the final contract to the Clerk of the Board for inclusion into the official file  
4 (File No. 130688).
