5 **in San Francisco Superior Court, Case No. CGC-22-598779; entitled Debra Crismani v.**
6 **City and County of San Francisco, et al.; the lawsuit involves alleged personal injury on**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Debra Crismani v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-22-598779 by the
13 payment of \$90,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 March 21, 2022, and the following parties were named in the lawsuit: Plaintiff: Debra
16 Crismani; Defendants: City and County of San Francisco and Cultural Integration Fellowship.
