9 WHEREAS, Bay Area counties are experiencing significantly increased aircraft  
10 overflights; and

11 WHEREAS, anticipated population increases in the Bay Area, combined with  
12 continued growth in air cargo traffic and planned expansion of the region's airports, will result  
13 in substantial increases in air traffic in the coming years; and,

14 WHEREAS, adequate aviation planning and oversight by elected officials throughout  
15 the Bay Area, is necessary to avoid unnecessary increases in aircraft noise, reductions in air  
16 quality and other adverse environmental impacts; now, therefore, be it

17 RESOLVED, that San Francisco City and County Supervisors supports the creation of  
18 the FAA Regional Aviation Working Group and its stated objectives; and, be it

19 FURTHER RESOLVED, The Board of Supervisors appoints Supervisor Jake  
20 McGoldrick as San Francisco City and County representative and Supervisor Aaron Peskin  
21 as alternate at the Regional Aviation Work Group.




