WHEREAS, The amount appropriated authorizes an increase to the existing annual amounts under the current Budget and Legislative Analyst Services contract by \$400,000 in Fiscal Years (FYs) 2022-23, 2023-24, 2024-25, and 2025-26 for the current contract term of January 1, 2022, through December 31, 2025; and

WHEREAS, The City has one option to renew the Agreement for a period of six years up to December 31, 2031, and the amount appropriated authorizes an increase to the existing annual amounts under the current Budget and Legislative Analyst Services contract by \$400,000 in Fiscal Years 2026-27, 2027-28, 2028-29, 2029-30, 2030-31, and FY 2031-32 when the City exercises this option to renew; now, therefore, be it

MOVED, That the Board of Supervisors of the City and County of San Francisco authorizes the Clerk of the Board of Supervisors to take all administrative steps to amend the Budget and Legislative Analyst Services contract with Harvey M. Rose Associates, LLC and to increase the annual contract hours and the not to exceed amount using funds appropriated for that purpose by \$1.6 million dollars for the current contract term of January 1, 2022, through December 31, 2025.
