7 Tem Kevin de León on March 2, 2017, to serve on the California Coastal Commission in the
8 North Coast Central seat representing San Francisco, Sonoma and Marin counties through
9 May 20, 2019; and

10 WHEREAS, Supervisor Aaron Peskin seeks reappointment for the four-year term to the
11 North Central Coast seat expiring May 20, 2023; and

12 WHEREAS, Supervisor Aaron Peskin has ably served all three North Central Coast
13 counties during his time on the California Coastal Commission, receiving widespread support
14 from environmental and labor groups as well as a diverse cross-section of coastal
15 stakeholders; and

16 WHEREAS, Supervisor Aaron Peskin brings a unique perspective and set of expertise
17 to the California Coastal Commission through his decades of work on environmental and land
18 use policy; and

19 WHEREAS, Supervisor Aaron Peskin has served diligently with an almost perfect
20 attendance record, availing himself of the support of his alternate only twice; and

21 WHEREAS, Supervisor Aaron Peskin has confirmed his willingness and desire to serve
22 another term, should Senate President Pro Tem Tony Atkins appoint him to the North Central
23 Coast seat of the California Coastal Commission; now, therefore, be it

24 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
25 hereby nominates Supervisor Aaron Peskin for consideration for the North Coast Central seat

1 on the California Coastal Commission, based on his successful track record mediating various
2 land use issues before the Commission, balancing the public's access to coastal beaches with
3 the need to prepare for the environmental impacts of sea-level rise and representing the best
4 interests of stakeholders from throughout the North Central coastal zone; and, be it
