11 WHEREAS, On March 26, 2013, Donald Wiggam filed a complaint of discrimination
12 with the City's Department of Human Resources (DHR/EEO File No. 1708); and

13 WHEREAS, The Office of the Assessor Recorder of the City and County of San
14 Francisco has recommended settlement of said claims by payment of \$125,000; and

16 compromise of said claims by payment of \$125,000.00 is hereby approved.
