

1 [Right-Of-Way Permit]

2 AUTHORIZING THE CITY AND COUNTY OF SAN FRANCISCO, ON BEHALF OF THE  
3 PUBLIC UTILITIES COMMISSION, TO EXECUTE A RIGHT-OF-WAY PERMIT TO  
4 CONSTRUCT, OPERATE AND MAINTAIN A SEWER OVERFLOW TUNNEL AND  
5 ASSOCIATED FACILITIES WITHIN THE BOUNDARIES OF THE GOLDEN GATE  
6 NATIONAL RECREATION AREA, A UNIT OF THE NATIONAL PARK SYSTEM, UNITED  
7 STATES DEPARTMENT OF INTERIOR.

8 WHEREAS, A Right-of-Way permit is required from the United States Department of  
9 Interior, National Park Service, on a long term easement for the operation of the Richmond  
10 Transport Facilities; and,

11 WHEREAS, The subject Right-of-Way permit is companion legislation to File No.  
12 98-1285 ; and,

13 WHEREAS, The term of the subject Right-of-Way permit is fifty (50) years and the  
14 associated cost is \$508,709; and,

15 WHEREAS, The Public Utilities Commission, pursuant to Public Utilities Commission  
16 Resolution No. 98-0194, and the Director of Property have approved the terms and  
17 conditions of the subject Right-of-Way permit; now, therefore, be it

18 RESOLVED, That this Board hereby approves and authorizes the Director of Property  
19 to execute the Right-of-Way permit with the National Park Service, for the purpose of
