3 **Resolution authorizing the Department of Children, Youth and Their Families to accept**
4 **and expend a grant in the amount of \$196,453 from the United States Department of**
5 **Agriculture for the 2005 After-School Snack Pilot Program.**

7 WHEREAS, Approximately 35,000 children in San Francisco are eligible for the free
8 and reduced school lunch program; and,

9 WHEREAS, Hunger impairs a child's ability to learn, grow and stay healthy, and is
10 associated with increased behavior problems including hyperactivity and aggression; and,

11 WHEREAS, The United States Department of Agriculture has created a pilot Year-
12 Round Feeding Program to provide reimbursement funding for sponsors to offer after-school
13 snacks for children; and,

14 WHEREAS, Funding from the pilot Year-Round Feeding Program will enable the City
15 and County of San Francisco's After-School Snack Program to provide children with free
16 snacks through 25 after-school program sites by the end of its first year of operation, providing
17 an average of 1,250 children per day with a nutritious snack during the after-school hours;


19 WHEREAS, The Budget Analyst report prepared for the February 24, 2005 Budget &
20 Finance Committee hearing on childhood nutrition programs listed the pilot Year-Round
21 Feeding Program as an example of an additional federal funding source the City and County
22 of San Francisco should be drawing upon to fund food programs for children; and,

23 WHEREAS, The grant terms prohibit indirect costs; now, therefore, be it


24 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in






