10 WHEREAS, DPH has entered into a prior licensing Agreement with InfoMc as the  
11 principal vendor for mental health billing software known as the cCURA / eCURA  
12 products; and

14 WHEREAS, The Health Commission, and has previously approved the proposed  
15 contract for this system; and

17 WHEREAS, the proposed contract handles over \$49 million dollars of revenue  
18 for the Department, and assists the Department to effectively bill for mental health  
19 services; and

21 WHEREAS, DPH is in the process of transitioning to a new suite of applications  
22 to take over these services; and

24 WHEREAS, the cost of said contract, would not exceed Two Million Nine  
25 Hundred Eighty One Thousand Two Hundred Fifty Dollars (\$2,981,250); the


