WHEREAS, Inducted in the Hall of Fame in 1979, Mays was the ninth player inducted in the first year of eligibility; and.

WHEREAS, Willie Mays currently holds a lifetime contract with the San Francisco Giants as Special Assistant to the President, a position he has held since 1986, and appears at a number of civic and charitable events throughout the Bay Area on behalf of the Giants: now, therefore, be it
