3 AUTHORIZING THE DIRECTOR OF ADMINISTRATIVE SERVICES TO ACCEPT AND
4 EXPEND \$120,000 FROM THE BAY AREA AIR QUALITY MANAGEMENT DISTRICT'S
5 TRANSPORTATION FUND FOR CLEAN AIR; AND AUTHORIZING THE DIRECTOR OF
6 ADMINISTRATIVE SERVICES TO ACCEPT AND EXPEND FUNDS IN FUTURE YEARS
7 THROUGH THIS PROGRAM.

8 WHEREAS, the Bay Area Air Quality Management District ("District")
9 has approved \$120,000 from the Transportation Fund for Clean Air
10 (Vehicle Incentive Program), for the Department of Administrative
11 Services to implement the following clean air vehicle project:

12 CNG Vehicles-City and County of San Francisco, General Operations

13 To fund \$120,000 in incremental costs for 20-30 compressed natural
14 gas and/or other clean fuel vehicles to be purchased by various
15 City departments and one to be purchased by Norcal Waste Systems,
16 Inc. to reduce vehicle emissions and improve air quality; and

17 WHEREAS, the Vehicle Incentive Program provides funding only for
18 the direct costs of vehicle purchases; and

19 WHEREAS, it is anticipated that the Vehicle Incentive Program will
20 be continued in future years, and it is requested that this resolution
21 authorize the Director of Administrative Services to accept and expend
22 funds in future years through this program, provided that the
23 program's terms are not changed; now therefore be it


24 RESOLVED, that this Board of Supervisors hereby authorizes the




