3 **Resolution requesting the office of the Controller of the City and County of San**
4 **Francisco to transfer funds in the account for the Harvey Milk Memorial to the Harvey**
5 **Milk City Hall Memorial Committee.**

7 WHEREAS, The office of the Controller of the City and County of San Francisco has
8 received funds for the purpose of a memorial to Supervisor Harvey Milk in San Francisco City
9 Hall; and

10 WHEREAS, The Harvey Milk City Hall Memorial Committee has convened for the
11 purpose of planning, fundraising, and commissioning a memorial in San Francisco City Hall to
12 commemorate Supervisor Harvey Milk; and,

13 WHEREAS, The Harvey Milk City Hall Memorial Committee is fiscally sponsored by
14 the San Francisco Lesbian, Gay, Bisexual, Transgender Pride Parade Committee, a non-
15 profit organization; and,

16 WHEREAS, The Harvey Milk City Hall Memorial Committee is requesting the use of all
17 funds already donated for the project, amounting to a total of approximately \$3500, for the
18 purpose of reaching the goal of completing the memorial; and,

19 WHEREAS, Those funds are to be used for purposes of startup costs including but not
20 limited to stationary, legal expenses, website and postal box rental; now, therefore, be it

21 RESOLVED, That the Board of Supervisors of the City of San Francisco requests the
22 office of the Controller of the City and County of San Francisco to transfer funds in the
23 account for the Harvey Milk Memorial to the Harvey Milk City Hall Memorial Committee, which
24 has a mailing address of 1800 Market St., Ste. 42, San Francisco, CA 94102; and, be it




