4	Resolution urging the Governor of California to protect Proposition 10 county funding
5	by not re-allocating \$1 billion in Prop 10 funds from local First 5 Commissions
6	reserves.
7	
8	WHEREAS, First 5 exists because voters passed Prop 10, and twice rebuffed efforts to
9	overturn it; and
10	WHEREAS, Protecting Prop 10 funding would ensure that 18,000 children and families
11	in San Francisco, and 2,090,453 children and families in California can continue to access
12	early childhood education programs, health screening and insurance, and family support
13	services that prepare them to enter kindergarten; and,
14	WHEREAS, First 5 San Francisco has invested more than \$9 million dollars annually to
15	fund more than 200 workforce positions throughout the county; and,
16	WHEREAS, First 5 San Francisco funding has allowed 4,300 children to be screened
17	for developmental delays and receive follow up services; and,
18	WHEREAS, First 5 San Francisco funding in partnership with the Department of
19	Children, Youth & Their Families, and the Human Services Agency has provided family
20	resource center services to over 2,000 children and 8,000 parents and caregivers; and,
21	WHEREAS, First 5 funding has provided health insurance premiums for 572 birth to
22	five year olds; and,
23	WHEREAS, First 5 funding has ensured that 4,300 children receive vision, hearing and
24	dental screenings, and 78% of those children have been linked to other health care services;
25	and,

1	WHEREAS, First 5 funding has provided 6,889 children access to infant toddler care
2	and high quality preschool, thereby supporting literacy and school readiness; and,
3	WHEREAS, An independent audit has determined that less funding is available at the
4	local level than is assumed by the Governor; and,
5	WHEREAS, First 5 San Francisco has been fiscally responsible with a long range
6	sustainability plan that ensures funding to support young children and their families for the
7	next 8 years; and,
8	WHEREAS, The Governor's proposal will cause irreparable damage with little funding
9	left to address the needs of children and families who will once again fall through the gaps in
10	the safety net provided by Prop 10 funding; now, therefore, be it
11	RESOLVED, That the San Francisco Board of Supervisors does not support the
12	Governor's budget to re-allocate First 5 County reserves; and, be it
13	FURTHER RESOLVED, That the San Francisco Board of Supervisors will work with
14	First 5 San Francisco Commissioners and Staff to insure programs and services for our
15	youngest San Franciscans are protected and preserved.
