6 WHEREAS, The National Academy of Recording Arts & Sciences 42<sup>nd</sup> annual Grammy  
7 Awards were held on February 23, 2000; and,

8 WHEREAS, Bay Area artist Carlos Santana, nominated for 10 Grammys, won a  
9 record-tying eight Grammys for his 1999 multiplatinum album "*Supernatural*" including Song  
10 of the Year, Record of the Year, and Album of the Year; and,

11 WHEREAS, Michael Tilson Thomas and the San Francisco Symphony received three  
12 Grammys for Best Engineered Album, Classical, Best Classical Album, and Best Orchestral  
13 Performance for their recording "*Stravinsky: The Firebird, The Rite of Spring, Persephone*";  
14 and,

15 WHEREAS, Chanticleer, the only full time classical vocal ensemble in the United  
16 States, received its first Grammy for Best Small Ensemble Performance for its 1999 release  
17 *Colors of Love*; and,

18 WHEREAS, Metallica won a Grammy for Best Hard Rock Performance for the song  
19 "*Whiskey in the Jar*"; and,

20 WHEREAS, Walter Afanasieff won a Grammy for Producer of the Year, Non-Classical;  
21 now, therefore, be it
