

1 [Accept and Expend Grant - The STOP Study - \$166,666]

3 **Resolution authorizing the San Francisco Department of Public Health to accept and**
4 **expend retroactively a grant from the Centers for Disease Control and Prevention in**
5 **the amount of \$166,666, to fund the STOP Study for the period June 15, 2010, through**
6 **June 14, 2011.**

8 WHEREAS, The Centers for Disease Control and Prevention (CDC) has agreed to
9 fund DPH in the amount of \$166,666 for the period of June 15, 2010 through June 14, 2011;
10 and,

11 WHEREAS, The full project period of the grant starts on June 15, 2010 and ends on
12 June 15, 2014, with years two, three and four subject to availability of funds and satisfactory
13 progress of the project; and,

14 WHEREAS, The STOP Study is evaluating HIV screening and partner notification; and,

15 WHEREAS, DPH will subcontract with Public Health Foundation Enterprises, Inc;
16 UCSF/AIDS Health Project; SF AIDS Foundation, Magnet; and Tenderloin Health, and MOUs
17 with DPH's Lab and STD units, and an as-yet to be determined entity in the total amount of
18 \$118,546; for the period of June 15, 2010 through June 14, 2011; and,

19 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH
20 for two existing positions, one Senior Physician Specialist (Job Class #2232) at .05 FTE, and
21 one Health Program Coordinator III (Job Class #2593) at .20 FTE, for the period of June 15,
22 2010 through June 14, 2011; and,

23 WHEREAS, The grant budget includes a provision for indirect costs in the amount of
24 \$6,697; and,

1 WHEREAS, DPH is seeking retroactive approval because the CDC did not send the
2 grant award until June 14, 2010; now, therefore, be it


3 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
4 in the amount of \$166,666 from the CDC; and, be it

5 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
6 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
7 be it

8 FURTHER RESOLVED, That the Controller is directed to designate the positions
9 funded under this agreement as a "G" or grant-funded position which would terminate when
10 the agreement expires; and, be it

11 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
12 agreement on behalf of the City.
