13 **properties within 300 feet of proposed dispensaries; require dispensaries operating**

14 **before April 1, 2005 to obtain a permit within 18 months of the effective date of this**

15 **legislation or cease operation; require a notice that permits for dispensaries are not**

16 **intended to and do not authorize the violation of State or Federal law; and make**

17 **environmental findings and findings of consistency with the priority policies of**

18 **Planning Code Section 101.1 and the General Plan;**

19 **Amending the San Francisco Health Code by adding Sections 3200 through 3220, to:**

20 **set medical marijuana possession guidelines; require a permit, business license, and**

21 **business registration certificate for a medical cannabis dispensary; set out the**

22 **application process for a medical cannabis permit; set out operating requirements for**

23 **medical cannabis dispensaries; and set out the administrative process for imposing**

24 **penalties and/or permit suspension or revocation for violations;**

2 **an infraction for double parking in front of a medical cannabis dispensary and set the**
3 **fine at \$100; and,**

5 **Section 1, and by adding Sections 1.177 and 249.17, to authorize the Department of**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. **Findings.** The Board of Supervisors of the City and County of San
14 Francisco hereby finds and determines that:

15 (a) Pursuant to Planning Code Section 302, the Board of Supervisors finds that this
16 ordinance will serve the public necessity, convenience and welfare.

17 (b) Pursuant to Planning Code Section 101.1, the Board of Supervisors finds that this
18 ordinance is consistent with the Priority Policies of Section 101.1(b) of the Planning Code and
19 with the General Plan and hereby incorporates a report containing those findings as if fully set
20 forth herein. A copy of said report is on file with the Clerk of the Board of Supervisors in File
21 No. _____.

22 (c) This ordinance constitutes permanent controls to address the proliferation of
23 medical cannabis dispensaries and its passage terminates the efficacy of Urgency Ordinance
24 0098-05, the Interim Moratorium on Medical Cannabis Dispensaries.

SEC. 790.141 MEDICAL CANNABIS DISPENSARY.

A medical cannabis dispensary shall be as defined by Section 3201(f) of the San Francisco

Health Code provided that:

(a) the medical cannabis dispensary has applied for a permit from the Department of Public

Health pursuant to Section 3204 of the San Francisco Health Code;

(b) if medical cannabis is smoked on the premises, the medical cannabis dispensary is located not less than 1,000 feet from an elementary or secondary school, public or private, or a community clubhouse, neighborhood center or other community cultural center;

(c) if medical cannabis is smoked on the premises the dispensary shall provide adequate ventilation within the structure such that doors and/or windows are not left open for such purposes resulting in odor emission from the premises;

(d) if medical cannabis is not smoked on the premises, the medical cannabis dispensary is located not less than 500 feet from an elementary or secondary school, public or private, or a community clubhouse, neighborhood center or other community cultural center;

1 (e) regardless of whether medical cannabis is smoked on the premises the medical cannabis
2 dispensary is located not less than 500 feet from an institution for the treatment of addictive diseases;

3 (f) no alcohol is sold or distributed on the premises for on or off-site consumption;

4 (g) upon acceptance of a complete application for a building permit for a medical cannabis
5 dispensary the Planning Department shall cause a notice to be posted on the proposed site and shall
6 cause written notice to be sent via U.S. Mail to all properties within 300 feet of the subject lot in the
7 same Assessor's Block and on the block face across from the subject lot as well as to all individuals or
8 groups which have made a written request for notification of regarding specific properties, areas or
9 medical cannabis dispensaries;

10 (h) all building permit applications shall be held for a period of 30 calendar days from the date
11 of the mailed notice to allow review by residents, occupants, owners of neighborhood properties and
12 neighborhood groups; and

13 (i) after this 30 day period, all requests for Planning Commission review of a building permit

24 **SEC. 890.131. MEDICAL CANNABIS DISPENSARY.**

1 A medical cannabis dispensary shall be as defined by Section 3201(f) of the San Francisco
2 Health Code provided that:

3 (a) the medical cannabis dispensary has applied for a permit from the Department of Public
4 Health pursuant to Section 3204 of the San Francisco Health Code;

5 (b) if medical cannabis is smoked on the premises, the medical cannabis dispensary is located
6 not less than 1,000 feet from an elementary or secondary school, public or private, or a community
7 clubhouse, neighborhood center or other community cultural center;

8 (c) if medical cannabis is smoked on the premises the dispensary shall provide adequate
9 ventilation within the structure such that doors and/or windows are not left open for such purposes
10 resulting in odor emission from the premises;

11 (d) if medical cannabis is not smoked on the premises, the medical cannabis dispensary is
12 located not less than 500 feet from an elementary or secondary school, public or private, or a
13 community clubhouse, neighborhood center or other community cultural center;

14 (e) regardless of whether medical cannabis is smoked on the premises the medical cannabis
15 dispensary is located not less than 500 feet from an institution for the treatment of addictive diseases;

16 (f) no alcohol is sold or distributed on the premises for on or off-site consumption;

17 (g) upon acceptance of a complete application for a building permit for a medical cannabis
18 dispensary the Planning Department shall cause a notice to be posted on the proposed site and shall

20 Section 4. The San Francisco Health Code is hereby amended by adding Article 32,
21 Sections 3200 through 3220, to read as follows:

22 **SEC. 3200. TITLE.**

23 *This Article may be cited as the "Medical Cannabis Act."*

1 **SEC. 3201. DEFINITIONS.**

2 For the purposes of this Article:

3 (a) "Cannabis" means marijuana and all parts of the plant Cannabis, whether growing or not;
4 the seeds thereof; the resin extracted from any part of the plant; and every compound, manufacture,
5 salt, derivative, mixture, or preparation of the plant, its seeds or resin. It includes marijuana infused in
6 foodstuff. It does not include the mature stalks of the plant, fiber produced from the stalks, oil or cake
7 made from the seeds of the plant, any other compound, manufacture, salt, derivative, mixture, or
8 preparation of the mature stalks (except the resin extracted there from), fiber, oil, or cake, or the
9 sterilized seeds of the plant are incapable of germination.

10 (b) "City" means the City and County of San Francisco.

11 (c) "Convicted" means having pled guilty or having received a verdict of guilty, including a
12 verdict following a plea of nolo contendere, to a crime.

13 (d) "Director" means the Director of Public Health or any individual designated by the
14 Director to act on his or her behalf, including but not limited to inspectors.

15 (e) "Excessive profits," means the receipt of consideration of a value substantially higher than
16 the reasonable costs of operating the facility.

17 (f) "Medical cannabis dispensary" means any association, cooperative, or collective of four or
18 more qualified patients with a valid identification card, or primary caregivers with a valid
19 identification card that facilitates the lawful distribution of medical cannabis.

20 (g) "Medical Cannabis Identification Card" or "Identification Card" means a document issued
21 by the State Department of Health Services pursuant to California Health and Safety Code Sections
22 11362.7 et seq. or the City pursuant to Health Code Article 28 that identifies a person authorized to
23 engage in the medical use of marijuana and the person's designated primary caregiver, if any, or
24 identifies a person as a primary caregiver for a medical marijuana patient.

1 (h) "Permittee" means the owner, proprietor, manager, or operator of a medical cannabis
2 dispensary or other individual, corporation, or partnership who obtains a permit pursuant to this
3 Article.

4 (i) "Primary caregiver" shall have the same definition as California Health and Safety Code
5 Section 11362.7 et seq., and as may be amended, and which defines "primary caregiver" as a
6 individual, designated by a qualified patient or by a person with an identification card, who has
7 consistently assumed responsibility for the housing, health, or safety of that patient or person, and may
8 include a licensed clinic, a licensed health care facility, a residential care facility, a hospice, or a home
9 health agency as allowed by California Health and Safety Code Section 11362.7(d)(1-3).

10 (j) "Qualified patient" shall have the same definition as California Health and Safety Code
11 Section 11362.7 et seq., and as may be amended, which states that a "qualified patient" means a person
12 who is entitled to the protections of California Health and Safety Code Section 11362.5, but who does
13 not have a valid medical cannabis identification card. For the purposes of this Article, a "qualified
14 patient who has a valid identification card" shall mean a person who fulfills all of the requirements to
15 be a "qualified patient" under California Health and Safety Code Section 11362.7 et seq. and also has
16 a valid medical cannabis identification card.

17
18 **SEC. 3202. MEDICAL MARIJUANA GUIDELINES.**

19 Pursuant to the authority granted under Health and Safety Code section 11362.77, the City and
20 County of San Francisco enacts the following medical marijuana guidelines:

21 (a) A qualified patient, person with a valid identification card, or primary caregiver may
22 possess no more than one pound of dried marijuana per qualified patient. In addition, a qualified
23 patient or primary caregiver may also maintain no more than twelve (12) mature or twenty-four (24)
24 immature marijuana plants per qualified patient.

1 (b) If a qualified patient, person with an identification card, or primary caregiver has a
2 doctor's recommendation that this quantity does not meet the qualified patient's medical needs, the
3 qualified patient, person with an identification card, or primary caregiver may possess an amount of
4 marijuana consistent with the patient's needs.

5 (c) Only the dried mature processed flowers of female cannabis plant or the plant conversion
6 shall be considered when determining allowable quantities of marijuana under this section.

7
8 **SEC. 3203. PERMIT REQUIRED FOR MEDICAL CANNABIS DISPENSARY.**

9 Except for research facilities, it is unlawful to operate or maintain, or to participate therein, or
10 to cause or to permit to be operated or maintained, any medical cannabis dispensary without first
11 obtaining a permit pursuant to this Article.

12
13 **SEC. 3204. APPLICATION FOR MEDICAL CANNABIS DISPENSARY PERMIT.**

14 (a) Every applicant for a medical cannabis dispensary permit shall file an application with the
15 Director upon a form provided by the Director and pay a non-refundable permit application fee of
16 \$7,396.00 to cover the costs to all City departments of investigating and processing the application and
17 any applicable surcharges, exclusive of filing fees for appeals before the Board of Appeals.

18 (b) The permit application form shall provide clear notice to applicants that the Fire Code
19 includes a requirement, among others that may apply, that an establishment obtain a place of assembly
20 permit if it will accommodate 100 or more persons based on its square footage.

21 (c) The applicant for a medical cannabis dispensary permit shall set forth, under penalty of
22 perjury, the following on the permit application:

23 (1) The proposed location of the medical cannabis dispensary;

1 (2) The name and residence address of each person applying for the permit and any other
2 person who will be engaged in management or operation of the medical cannabis dispensary;

3 (3) A unique identifying number from at least one government-issued form of identification,
4 such as a social security card, a state driver's license or identification card, or a passport for of each
5 person applying for the permit and any other person who will be engaged in management or operation
6 of the medical cannabis dispensary;

7 (4) Written evidence that each person applying for the permit and any other person who will be
8 engaged in management or operation of the medical cannabis dispensary is at least 18 years of age;

9 (5) All felony convictions of each person applying for the permit and any other person who will
10 be engaged in management or operation of the medical cannabis dispensary;

11 (6) Whether cultivation of medical cannabis shall occur on the premises of the medical
12 cannabis dispensary;

13 (7) Whether smoking of medical cannabis shall occur on the premises of the medical cannabis
14 dispensary;

15 (8) Whether food will be prepared, dispensed or sold on the premises of the medical cannabis
16 dispensary; and

17 (9) Proposed security measures for the medical cannabis dispensary, including lighting and
18 alarms, to insure the safety of persons and to protect the premises from theft.

19 (e) If the applicant is a corporation, the applicant shall set forth the name of the corporation
20 exactly as shown in its articles of incorporation, and the names and residence addresses of each of the
21 officers, directors and each stockholder owning more than 10 percent of the stock of the corporation. If
22 the applicant is a partnership, the application shall set forth the name and residence address of each of
23 the partners, including limited partners. If one or more of the partners is a corporation, the provisions
24 of this Section pertaining to a corporation apply.

1 (f) The Director is hereby authorized to require in the permit application any other information
2 including, but not limited to, any information necessary to discover the truth of the matters set forth in
3 the application.

4 (g) Each person applying for the permit and any other person who will be engaged in
5 management or operation of the medical cannabis dispensary shall submit with the permit application
6 a signed waiver authorizing the San Francisco Police Department to perform a thorough and complete
7 criminal and employment background check.

8
9 **SEC. 3205. REFERRAL TO OTHER DEPARTMENTS.**

10 (a) Upon receiving a completed medical cannabis dispensary permit application and permit
11 application fee, the Director shall immediately refer the permit application to the City's Planning
12 Department, Department of Building Inspections, Police Department and Fire Department.

13 (b) Said departments shall inspect the premises proposed to be operated as a medical cannabis
14 dispensary and confirm the information provided in the application and shall make separate written
15 recommendations to the Director concerning compliance with the codes that they administer.
16 Specifically, the Police Department shall perform a thorough and complete criminal and employment
17 background check on each person applying for the permit and any other person who will be engaged in
18 management or operation of the medical cannabis dispensary. The Department of Building Inspections
19 shall, in consultation with the Police Department, approve the security measures for the medical
20 cannabis dispensary, including lighting and alarms, to insure the safety of persons and to protect the
21 premises from theft. Departments' written approval, rejection and/or recommendations regarding the
22 permit shall be delivered to the Director.

23
24 **SEC. 3206. NOTICE OF HEARING ON PERMIT APPLICATION.**
25

1 (a) After receiving written approval of the permit application from other City Departments as
2 set out in Section 3205, the Director shall fix a time and place for a public hearing on the application,
3 which date shall not be more than 45 days after the Director's receipt of the written approval of the
4 permit application from other City Departments.

5 (b) No fewer than 10 days before the date of the hearing, the permit applicant shall cause to be
6 posted a notice of such hearing in a conspicuous place on the property at which the proposed medical
7 cannabis dispensary is to be operated. The applicant shall comply with any requirements regarding
8 the size and type of notice specified by the Director. The applicant shall maintain the notice as posted
9 the required number of days.

10
11 **SEC. 3207. ISSUANCE OF MEDICAL CANNABIS DISPENSARY PERMIT.**

12 (a) Within 14 days following a hearing, the Director shall either issue the permit or mail a
13 written statement of his or her reasons for denial thereof to the applicant.

14 (b) In recommending the granting or denying of such permit and in granting or denying the
15 same, the Director, shall give particular consideration to the capacity, capitalization, complaint history
16 of the applicant and any other factors that in their discretion he or she deems necessary to the peace
17 and order and welfare of the public.

18 (c) No medical cannabis dispensary permit shall be issued if the Director finds:

19 (1) That the applicant has provided materially false documents or testimony; or

20 (2) That the applicant has not complied fully with the provisions of this Article; or

21 (3) That the operation as proposed by the applicant, if permitted, would not have complied with
22 all applicable laws, including, but not limited to, the Building, Planning, Housing, Police, Fire, and
23 Health Codes of the City, including the provisions of this Article and regulations issued by the Director
24 pursuant to this Article; or

1 (4) That the permit applicant or any other person who will be engaged in management or
2 operation of the medical cannabis dispensary has been convicted of a violent felony within State of
3 California or a crime that would have constituted a violent felony if committed within the State of
4 California. However, the Director may issue a medical cannabis dispensary permit to any individual
5 convicted of such a crime if the Director finds that the conviction occurred at least five years prior to
6 the date of the permit application or more than three years have passed from the date of the
7 termination of a penalty for such conviction to the date of the permit application and, that no
8 subsequent felony convictions of any nature have occurred; or

9 (5) That a permit for the operation of a medical cannabis dispensary, which permit had been
10 issued to the applicant or to any other person who will be engaged in management or operation of the
11 medical cannabis dispensary, has been revoked, unless more than five years have passed from the date
12 of the revocation to the date of the application; or

13 (6) That the City has revoked a permit for the operation of a business in the City which permit
14 had been issued to the applicant or to any other person who will be engaged in the management or
15 operation of the medical cannabis dispensary unless more than five years have passed from the date of
16 the application to the date of the revocation.

17 (d) The Director shall notify the Police Department of all approved permit applications.

18 (e) The permit shall contain the following language, "Issuance of this permit by the City and
19 County of San Francisco is not intended to and does not authorize the violation of State or Federal
20 law."

21
22 **SEC. 3208. OPERATING REQUIREMENTS FOR MEDICAL CANNABIS DISPENSARY.**

23 (a) Medical cannabis dispensaries shall meet all the operating criteria for the dispensing of
24 medical cannabis as is required pursuant to California Health and Safety Code Section 11362.7 et seq.,
25

1 by this Article, and by the Director's administrative regulations for the permitting and operation of
2 medical cannabis dispensaries.

3 (b) Medical cannabis dispensaries shall be operated only as collectives or cooperatives in
4 accordance with California Health and Safety Code Section 11326.7 et seq. All patients or caregivers
5 served by a medical cannabis dispensary shall be members of that medical cannabis dispensary's
6 collective or cooperative.

7 (c) The medical cannabis dispensary shall receive only compensation for actual expenses,
8 including reasonable compensation incurred for services provided to qualified patients with a valid
9 identification card or primary caregivers with a valid identification card to enable that person to use or
10 transport marijuana pursuant to California Health and Safety Code Section 11362.7 et seq., or for
11 payment for out-of-pocket expenses incurred in providing those services, or both. Sale of medical
12 cannabis for excessive profits is explicitly prohibited. Each medical cannabis dispensary shall
13 maintain records demonstrating that it complies with the requirements of this paragraph. Each
14 medical cannabis dispensary shall make these records available for inspection, examination, and
15 copying by the Department upon request by the Department. Such records shall not include patient
16 records or materials identifying individual patients.

17 (d) Medical cannabis dispensaries shall sell or distribute only cannabis manufactured and
18 processed in the State of California that has not left the State before arriving at the medical cannabis
19 dispensary.

20 (e) It is unlawful for any person or association operating a medical cannabis dispensary under
21 the provisions of this Article to permit any breach of peace therein or any disturbance of public order
22 or decorum by any tumultuous, riotous or disorderly conduct, or otherwise, or to permit such
23 dispensary to remain open, or patrons to remain upon the premises, between the hours of 12 a.m. and 7
24 a.m. the next day.

25

1 (f) Medical cannabis dispensaries may not dispense more than one pound of dried marijuana
2 per qualified patient with a valid identification card or primary caregiver with a valid identification
3 card per visit to the medical cannabis dispensary. Medical cannabis dispensaries may not maintain
4 more than twelve (12) mature or twenty-four (24) immature marijuana plants per qualified patient with
5 a valid identification card or primary caregiver with a valid identification card. Medical cannabis
6 dispensaries shall use medical cannabis identification card numbers to ensure compliance with this
7 provision. If a qualified patient with a valid identification card or a primary caregiver with a valid
8 identification card has a doctor's recommendation that this quantity does not meet the qualified patient
9 with a valid identification card's medical needs, the qualified patient with a valid identification card or
10 the primary caregiver with a valid identification card may possess and the medical cannabis
11 dispensary may dispense an amount of dried marijuana and maintain a number of mature and/or
12 immature marijuana plants consistent with those needs. Only the dried mature processed flowers of
13 female cannabis plant or the plant conversion shall be considered when determining allowable
14 quantities of marijuana under this section.

15 (g) No medical cannabis shall be smoked, ingested or otherwise consumed in the public right of
16 way within fifty (50) feet of a medical cannabis dispensary. Any person violating this provision shall be
17 deemed guilty of an infraction and upon the conviction thereof shall be punished by a fine of \$100.
18 Medical cannabis dispensaries shall post a sign near their entrances and exits providing notice of this
19 policy.

20 (h) Any cultivation of medical cannabis on the premises of a medical cannabis dispensary must
21 be conducted indoors.

22 (i) All sales and dispensing of medical cannabis shall be conducted on the premises of the
23 medical cannabis dispensary. However, delivery of cannabis to qualified patients with valid
24 identification cards and primary caregivers with a valid identification card outside the premises of the
25

1 medical cannabis dispensary is permitted if the person delivering the cannabis is a qualified patient
2 with a valid identification card or a primary caregiver with a valid identification card who is a member
3 of the medical cannabis dispensary.

4 (j) The medical cannabis dispensary shall not hold or maintain a license from the State
5 Department of Alcohol Beverage Control to sell alcoholic beverages, or operate a business that sells
6 alcoholic beverages. Nor shall alcoholic beverages be consumed on the premises or on in the public
7 right of way within fifty feet of a medical cannabis dispensary.

8 (k) In order to protect confidentiality, the medical cannabis dispensary shall maintain records
9 of all qualified patients with a valid identification card and primary caregivers with a valid
10 identification card using only the identification card number issued by the State or City pursuant to
11 California Health and Safety Code Section 11362.7 et seq. and City Health Code Article 28.

12 (l) The medical cannabis dispensary shall provide litter removal services twice each day of
13 operation on and in front of the premises and, if necessary, on public sidewalks within hundred (100)
14 feet of the premises.

15 (m) The medical cannabis dispensary shall provide adequate security on the premises,
16 including lighting and alarms, to insure the safety of persons and to protect the premises from theft.

17 (n) Signage for the medical cannabis dispensary shall be limited to one wall sign not to exceed
18 ten square feet in area, and one identifying sign not to exceed two square feet in area; such signs shall
19 not be directly illuminated.

20 (o) The medical cannabis dispensary shall provide the Director, the chief of police and all
21 neighbors located within fifty (50) feet of the establishment with the name, phone number and facsimile
22 number of an on-site community relations staff person to whom one can provide notice if there are
23 operating problems associated with the establishment. The medical cannabis dispensary shall make
24

25

1 every good faith effort to encourage neighbors to call this person to try to solve operating problems, if
2 any, before any calls or complaints are made to the police department or other City officials.

3 (p) Medical cannabis dispensaries may sell or distribute cannabis only to members of the
4 medical cannabis dispensary's collective or cooperative and only to those members with a medical
5 cannabis identification card.

6 (q) It shall be unlawful for any medical cannabis dispensary to employ any person who is not at
7 least 18 years of age.

8 (r) It shall be unlawful for any medical cannabis dispensary to allow any person who is not at
9 least 18 years of age on the premises during hours of operation unless that person is a qualified patient
10 with a valid identification card or primary caregiver with a valid identification card.

11 (s) Medical cannabis dispensaries that display or sell drug paraphernalia must do so in
12 compliance with California Health and Safety Code §§ 11364.5 and 11364.7.

13 (t) Medical cannabis dispensaries shall maintain all scales and weighing mechanisms on the
14 premises in good working order. Scales and weighing mechanisms used by medical cannabis
15 dispensaries are subject to inspection and certification by the Director.

16 (u) Medical cannabis dispensaries that prepare, dispense or sell food must comply with and are
17 subject to the provisions of all relevant State and local laws regarding the preparation, distribution and
18 sale of food.

19 (v) The medical cannabis dispensary shall meet any specific, additional operating procedures
20 and measures as may be imposed as conditions of approval by the Director in order to insure that the
21 operation of the medical cannabis dispensary is consistent with protection of the health, safety and
22 welfare of the community, qualified patients with a valid identification card and primary caregivers
23 with a valid identification card, and will not adversely affect surrounding uses.

1 **SEC. 3209. PROHIBITED OPERATIONS.**

2 All medical cannabis dispensaries operating in violation of California Health and Safety Code
3 Sections 11362.5 and 11326.7 et seq., or this Article are expressly prohibited. No entity that
4 distributed medical cannabis prior to the enactment of this Article shall be deemed to have been a
5 legally established use under the provisions of this Article, and such use shall not be entitled to claim
6 legal nonconforming status for the purposes of permitting.

7
8 **SEC. 3210. DISPLAY OF PERMIT.**

9 Every permit to operate a medical cannabis dispensary shall be displayed in a conspicuous
10 place within the establishment so that the permit may be readily seen by individuals entering the
11 premises.

12
13 **SEC. 3211. SALE OR TRANSFER OF PERMITS.**

14 (a) Upon sale, transfer or relocation of a medical cannabis dispensary, the permit and license
15 for the establishment shall be null and void unless another permit has been issued pursuant to this
16 Article; provided, however, that upon the death or incapacity of the permittee, the medical cannabis
17 dispensary may continue in business for six months to allow for an orderly transfer of the permit.

18 (b) If the permittee is a corporation, a transfer of 25 percent of the stock ownership of the
19 permittee will be deemed to be a sale or transfer and the permit and license for the establishment shall
20 be null and void unless a permit has been issued pursuant to this Article; provided, however, that this
21 subsection shall not apply to a permittee corporation, the stock of which is listed on a stock exchange in
22 this state or in the City of New York, State of New York, or which is required by law to file periodic
23 reports with the Securities and Exchange Commission.

1 **SEC. 3212. RULES AND REGULATIONS.**

2 (a) The Director shall issue rules and regulations regarding the conduct of hearings
3 concerning the denial, suspension or revocation of permits and the imposition of administrative
4 penalties on medical cannabis dispensaries.

5 (b) The Director may issue regulations governing the operation of medical cannabis
6 dispensaries. These regulations shall include, but need not be limited to:

7 (1) A requirement that the operator provide patients and customers with information regarding
8 those activities that are prohibited on the premises;

9 (2) A requirement that the operator prohibit patrons from entering or remaining on the
10 premises if they are in possession of or are consuming alcoholic beverages, or are under the influence
11 of alcohol;

12 (3) A requirement that the operator require employees to use protective gloves when handling
13 cannabis;

14 (4) A description of the size and type of notice of hearing to be posted in a conspicuous place
15 on the property at which the proposed medical cannabis dispensary is to be operated and the number of
16 days said notice shall remain posted; and

17 (5) A description of the size and type of sign posted near the entrances and exits of medical
18 cannabis dispensaries providing notice that no medical cannabis shall be smoked, ingested or
19 otherwise consumed in the public right of way within fifty (50) feet of a medical cannabis dispensary
20 and that any person violating this policy shall be deemed guilty of an infraction and upon the
21 conviction thereof shall be punished by a fine of \$100.

22 (c) Failure by an operator to do either of the following shall be grounds for suspension or
23 revocation of a medical cannabis dispensary permit: (1) comply with any regulation adopted by the
24 Director under this Article, or (2) give free access to areas of the establishment to which patrons have
25

1 access during the hours the establishment is open to the public, and at all other reasonable times, at the
2 direction of the Director, or at the direction of any City peace, fire, planning, or building official or
3 inspector for inspection with respect to the laws that they are responsible for enforcing.

4
5 **SEC. 3213. INSPECTION AND NOTICES OF VIOLATION.**

6 (a) The Director may inspect each medical cannabis dispensary regularly and based on
7 complaints, but in no event fewer than two times annually, for the purpose of determining compliance
8 with the provisions of this Article and/or the rules and regulations adopted pursuant to this Article. If
9 informal attempts by the Director to obtain compliance with the provisions of this Article fail, the
10 Director may take the following steps:

11 (1) The Director may send written notice of noncompliance with the provisions of this Article to
12 the operator of the medical cannabis dispensary. The notice shall specify the steps that must be taken
13 to bring the establishment into compliance. The notice shall specify that the operator has 10 days in
14 which to bring the establishment into compliance.

15 (2) If the Director inspector determines that the operator has corrected the problem and is in
16 compliance with the provisions of this Article, the Director may so inform the operator.

17 (3) If the Director determines that the operator failed to make the necessary changes in order
18 to come into compliance with the provisions of this Article, the Director may issue a notice of violation.

19 (b) The Director may not suspend or revoke a permit issued pursuant to this Article, impose an
20 administrative penalty, or take other enforcement action against a medical cannabis dispensary until
21 the Director has issued a notice of violation and provided the operator an opportunity to be heard and
22 respond as provided in Section 3216.

23 (c) If the Director concludes that announced inspections are inadequate to ascertain
24 compliance with this Article (based on public complaints or other relevant circumstances), the Director
25

1 may use other appropriate means to inspect the areas of the establishment to which patrons have
2 access. If such additional inspection shows noncompliance, the Director may issue either a notice of
3 noncompliance or a notice of violation, as the Director deems appropriate.

4 (d) Every person to whom a permit shall have been granted pursuant to this Article shall post a
5 sign in a conspicuous place in the medical cannabis dispensary. The sign shall state that it is unlawful
6 to refuse to permit an inspection by the Department of Public Health, or any City peace, fire, planning,
7 or building official or inspector, conducted during the hours the establishment is open to the public and
8 at all other reasonable times, of the areas of the establishment to which patrons have access.

9 (e) Nothing in this Section shall limit or restrict the authority of a police officer to enter
10 premises licensed or permitted under this Article (i) pursuant to a search warrant signed by a
11 magistrate and issued upon a showing of probable cause to believe that a crime has been committed or
12 attempted, (ii) without a warrant in the case of an emergency or other exigent circumstances, or (iii) as
13 part of any other lawful entry in connection with a criminal investigation or enforcement action.

14
15 **SEC. 3214. VIOLATIONS AND PENALTIES.**

16 (a) Any person who or dispensary that violates any provision of this Article or any rule or
17 regulation adopted pursuant to this Article may, after being provided notice and an opportunity to be
18 heard, be subject to an administrative penalty not to exceed \$1,000 for the first violation of a provision
19 or regulation in a 12-month period, \$2,500 for the second violation of the same provision or regulation
20 in a 12-month period, and \$5,000 for the third and subsequent violations of the same provision or
21 regulation in a 12-month period.

22 (b) The Director may not impose an administrative penalty or take other enforcement action
23 under this Article against a medical cannabis dispensary until the Director has issued a notice of
24

1 violation and provided the operator an opportunity to be heard and respond as provided in Section
2 3216.

3 (c) Nothing herein shall prohibit the District Attorney from exercising the sole discretion vested
4 in that officer by law to charge an operator, employee, or any other person associated with a medical
5 cannabis dispensary with violating this or any other local or state law.

6
7 **SEC. 3215. REVOCATION AND SUSPENSION OF PERMIT.**

8 (a) Any permit issued for a medical cannabis dispensary may be revoked, or suspended for up
9 to 30 days, by the Director if the Director determines that:

10 (1) the operator or any employee has violated any provision of this Article or any regulation
11 issued pursuant to this Article;

12 (2) the operator has violated any other local law, or any State law;

13 (3) the operator has engaged in any material misrepresentation when applying for a permit;

14 (4) the medical cannabis dispensary is being managed, conducted, or maintained without
15 regard for the public health or the health of patrons;

16 (5) the operator has refused to allow any duly authorized City official to inspect the premises
17 or the operations of the medical cannabis dispensary;

18 (6) based on a determination by another City department, including the Department of Building
19 Inspections, the Fire Department, the Police Department, and the Planning Department, that the
20 medical cannabis dispensary is not in compliance with the laws under the jurisdiction of the
21 department.

22 (b) The Director may not suspend or revoke a permit issued pursuant to this Article or take
23 other enforcement action against a medical cannabis dispensary until the Director has issued a notice
24

1 of violation and provided the operator an opportunity to be heard and respond as provided in Section
2 3216.

3 (c) Notwithstanding paragraph (b), the Director may suspend summarily any medical cannabis
4 dispensary permit issued under this Article pending a noticed hearing on revocation or suspension
5 when in the opinion of the Director the public health or safety requires such summary suspension. Any
6 affected permittee shall be given notice of such summary suspension in writing delivered to said
7 permittee in person or by registered letter.

8 (d) If a permit is revoked, no application for a medical cannabis dispensary may be submitted
9 by the same person for three years.

10
11 **SEC. 3216. NOTICE AND HEARING FOR ADMINISTRATIVE PENALTY AND/OR**
12 **REVOCAION OR SUSPENSION.**

13 (a) If the Director determines that a medical cannabis dispensary is operating in violation of
14 this Article and/or the rules and regulations adopted pursuant to this Article, he or she shall issue a
15 notice of violation to the operator of the medical cannabis dispensary.

16 (b) The notice of violation shall include a copy of this Section and the rules and regulations
17 adopted pursuant to this Article regarding the conduct of hearings concerning the denial, suspension or
18 revocation of permits and the imposition of administrative penalties on medical cannabis dispensaries.
19 The notice of violation shall include a statement of any informal attempts by the Director to obtain
20 compliance with the provisions of this Article pursuant to Section 3213(a). The notice of violation shall
21 inform the operator that:

22 (1) The Director has made an initial determination that the medical cannabis dispensary is
23 operating in violation of this Article and/or the rules and regulations adopted pursuant to this Article;
24 and

1 (2) The alleged acts or failures to act that constitute the basis for the Director's initial
2 determination; and

3 (3) That the Director intends to take enforcement action against the operator, and the nature of
4 that action including the administrative penalty to be imposed, if any, and/or the suspension or
5 revocation of the operator's permit; and

6 (4) That the operator has the right to request a hearing before the Director within fifteen (15)
7 days of receipt of the notice of violation in order to allow the operator an opportunity to show that the
8 medical cannabis dispensary is operating in compliance with this Article and/or the rules and
9 regulations adopted pursuant to this Article.

10 (c) If no request for a hearing is filed with the Director within the appropriate period, the
11 initial determination shall be deemed final and shall be effective fifteen (15) days after the notice of
12 initial determination was served on the alleged violator. The Director shall issue an Order imposing
13 the enforcement action and serve it upon the party served with the notice of initial determination.
14 Payment of any administrative penalty is due within 30 days of service of the Director's Order. Any
15 administrative penalty assessed and received in an action brought under this Article shall be paid to
16 the Treasurer of the City and County of San Francisco. The alleged violator against whom an
17 administrative penalty is imposed also shall be liable for the costs and attorney's fees incurred by the
18 City in bringing any civil action to enforce the provisions of this section, including obtaining a court
19 order requiring payment of the administrative penalty.

20 (d) If the alleged violator files a timely request for a hearing, within fifteen (15) days of receipt
21 of the request, the Director shall notify the requestor of the date, time, and place of the hearing. The
22 Director shall make available all documentary evidence against the medical cannabis dispensary no
23 later than fifteen (15) days prior to the hearing. Such hearing shall be held no later than forty-five (45)
24
25

1 days after the Director receives the request, unless time is extended by mutual agreement of the affected
2 parties.

3 (e) At the hearing, the medical cannabis dispensary shall be provided an opportunity to refute
4 all evidence against it. The Director shall conduct the hearing. The hearing shall be conducted
5 pursuant to rules and regulations adopted by the Director.

6 (f) Within twenty (20) days of the conclusion of the hearing, the Director shall serve written
7 notice of the Director's decision on the alleged violator. If the Director's decision is that the alleged
8 violator must pay an administrative penalty, the notice of decision shall state that the recipient has ten
9 (10) days in which to pay the penalty. Any administrative penalty assessed and received in an action
10 brought under this Article shall be paid to the Treasurer of the City. The alleged violator against
11 whom an administrative penalty is imposed also shall be liable for the costs and attorney's fees
12 incurred by the City in bringing any civil action to enforce the provisions of this section, including
13 obtaining a court order requiring payment of the administrative penalty.

14
15 **SEC. 3217. APPEALS TO BOARD OF APPEALS.**

16 (a) Right of Appeal. The final decision of the Director to grant, deny, suspend, or revoke a
17 permit, or to impose administrative sanctions, as provided in this Article, may be appealed to the Board
18 of Appeals in the manner prescribed in Article I of the San Francisco Business and Tax Regulations
19 Code. An appeal shall stay the action of the Director.

20 (b) Hearing. The procedure and requirements governing an appeal to the Board of Appeals
21 shall be as specified in Article I of the San Francisco Business and Tax Regulations Code.

22
23 **SEC. 3218. BUSINESS LICENSE AND BUSINESS REGISTRATION CERTIFICATE.**

1 (a) Every medical cannabis dispensary shall be required to obtain a business license from the
2 City in compliance with Article 2 of the Business and Tax Regulations Code.

3 (b) Every medical cannabis dispensary shall be required to obtain a business registration
4 certificate from the City in compliance with Article 12 of the Business and Tax Regulations Code.

5
6 **SEC. 3219. DISCLAIMERS AND LIABILITY.**

7 By regulating medical cannabis dispensaries, the City and County of San Francisco is assuming
8 an undertaking only to promote the general welfare. It is not assuming, nor is it imposing on its
9 officers and employees, an obligation for breach of which it is liable in money damages to any person
10 who claims that such breach proximately caused injury. To the fullest extent permitted by law, the City
11 shall assume no liability whatsoever, and expressly does not waive sovereign immunity, with respect to
12 the permitting and licensing provisions of this Article, or for the activities of any medical cannabis
13 dispensary. To the fullest extent permitted by law, any actions taken by a public officer or employee
14 under the provisions of this Article shall not become a personal liability of any public officer or
15 employee of the City. This Article (the "Medical Cannabis Act") does not authorize the violation of
16 state or federal law.

17
18 **SEC. 3220. SEVERABILITY.**

19 If any provision of this Article or the application of any such provision to any person or
20 circumstance, shall be held invalid, the remainder of this Article, to the extent it can be given effect, or
21 the application of those provisions to persons or circumstances other than those to which it is held
22 invalid, shall not be affected thereby, and to this end the provisions of this Article are severable.

1 Section 5. The San Francisco Traffic Code is hereby amended by amending Sections
2 53 and 132, to read as follows:

3 **SEC. 53. DOUBLE PARKING.**

4 A vehicle parked in violation of Section 22500 (h) of the Vehicle Code of the State of
5 California by being stopped, parked, or left standing on the roadway side of any vehicle
6 stopped, parked, or standing at the curb or edge of a highway, except for a schoolbus when
7 stopped to load or unload pupils in a business or residence district where the speed limit is 25
8 miles per hour or less, shall be cited by the appropriate authority as a violation of the statute.

9 Any person violating Section 22500(h) shall be deemed guilty of an infraction and upon
10 the conviction thereof shall be punished by a fine of not less than \$50 nor more than \$100.

11 (a) No person shall stop, park, or leave standing any vehicle such that any portion of
12 the vehicle is within a Municipal Railway bus route on restricted streets. The restricted streets
13 are Chestnut Street, Union Street, Clay Street, Stockton Street, Mission Street, Geary Street,
14 Polk Street, Sacramento Street, Clement Street, Fillmore Street, Haight Street, Irving Street,
15 9th Avenue, 16th Street, and 24th Street. No person shall stop, park, or leave standing in any
16 portion of a Municipal Railway bus route on such street his or her vehicle between the hours
17 of 6:00 a.m. to 9:00 a.m. and from 4:00 p.m. to 7.00 p.m. Any person violating this Section
18 shall be subject to a fine of \$100.00. The Department of Parking and Traffic shall install signs
19 and otherwise alert motorists where and when this prohibition shall take effect and the
20 applicable fine. This section shall not apply to vehicles engaged in emergency services
21 including, but not limited to, fire engines, police vehicles, ambulances, or public utility vehicles
22 while such vehicles are operating, maintaining, or repairing facilities of the public utility or are
23 being used in connection with providing public utility service.

24
25

1 (b) No person shall stop, park, or leave standing any vehicle such that any portion of the
2 vehicle is stopped, parked, or standing in front of a legally permitted medical cannabis dispensary in
3 violation of California Vehicle Code section 22500(h). Any person violating this sub-section shall be
4 subject to a fine of \$100.00. The Department of Parking and Traffic shall install signs and otherwise
5 alert motorists where and when this prohibition shall take effect and the applicable fine. This sub-
6 section shall not apply to vehicles engaged in emergency services including, but not limited to, fire
7 engines, police vehicles, ambulances, or public utility vehicles while such vehicles are operating,
8 maintaining, or repairing facilities of the public utility or are being used in connection with providing
9 public utility service.

10 **SEC. 132. PENALTY SCHEDULE.**

11 Pursuant to California Vehicle Code Section 40203.5, violation of any of the following
12 subsections of the San Francisco Traffic Code (TC), Police Code (PC) or the California
13 Vehicle Code (VC) shall be punishable by the fines set forth below.

21 Section 6. The San Francisco Business and Tax Regulation Code is hereby amended
22 by amending Section 1, and by adding Sections 1.177 and 249.17, to read as follows:

23 **SEC. 1. DESIGNATING DEPARTMENTS FOR ISSUANCE OF PERMITS.**

24 Permits shall be issued for the location and conduct of the businesses, enterprises or
25 activities, enumerated hereinafter in Sections 1.1 to ~~1.76~~ 1.77, inclusive, by the department or

1 office authorized by Sections 1.1 to ~~1.76~~ 1.77, inclusive, and Section 2 of this Article to issue
2 each such class of permit, and subject to the approval of other departments and offices of the
3 City and County, where specifically designated in any such case; provided that permit or
4 license fees as required by ordinance shall be collected by the Tax Collector as provided in
5 Section 3 of this Article.

7 **SEC. 1.77. MEDICAL CANNABIS DISPENSARIES.**

8 *For the establishment, maintenance and operation of medical cannabis dispensaries - by the*
9 *Department of Public Health.*

10
11 **SEC. 249.17. MEDICAL CANNABIS DISPENSARY LICENSE FEE.**

12 *Every person, firm or corporation engaged in operating a medical cannabis dispensary shall*
13 *pay an annual license fee of \$2,182.00 to the Tax Collector to cover the costs of annual inspections,*
14 *enforcement and other costs to the City.*

15
16 **Section 7. Promotion of the General Welfare.** By regulating medical cannabis
17 dispensaries, the City and County of San Francisco is assuming an undertaking only to
18 promote the general welfare. It is not assuming, nor is it imposing on its officers and
19 employees, an obligation for breach of which it is liable in money damages to any person who
20 claims that such breach proximately caused injury. To the fullest extent permitted by law, the
21 City shall assume no liability whatsoever, and expressly does not waive sovereign immunity,
22 with respect to the permitting and licensing provisions of this Article, or for the activities of any
23 medical cannabis dispensary. To the fullest extent permitted by law, any actions taken by a
24 public officer or employee under the provisions of this Article shall not become a personal
25

1 liability of any public officer or employee of the City. This ordinance does not authorize the
2 violation of state or federal law.

3
4 Section 8. **Severability.** If any provision of this ordinance or the application thereof to
5 any person or circumstances is held invalid or unconstitutional, such invalidity or
6 unconstitutionality shall not affect other provisions or applications of this ordinance which can
7 be given effect without the invalid or unconstitutional provision or application. To this end, the
8 provisions of this ordinance shall be deemed severable.
