3 **Resolution authorizing the Department of Public Health, Balboa Teen Health**
4 **Center (the "Contractor"), to enter retroactively into an independent contractor**
5 **services agreement in the amount of \$19,302 with the OMI/Excelsior**
6 **Neighborhood Beacon Center/Urban Services YMCA of San Francisco (the**
7 **"Client") to provide health services to Beacon Center participants; retroactive to**
8 **July 1, 2000.**

10 WHEREAS, the Client has requested that the Contractor, enter into a services
11 agreement to provide health services to the Client's participants; and,

12 WHEREAS, The Contractor has agreed to participate in this agreement; and,

13 WHEREAS, the Client has agreed to reimburse the Contractor in the amount of
14 \$19,302 under the terms of this agreement; and,

16 WHEREAS, As a condition of receiving the funds, the Client requires the
17 Contractor to enter into an agreement (the "Agreement"), a copy of which is on file with
18 the Clerk of the Board of Supervisors in File No. 010002; and,

19 WHEREAS, The Contractor proposes to maximize use of available grant funds
20 on program expenditures by not including indirect costs in the Agreement budget; now,
21 therefore, be it

23 **RESOLVED**, That the Board of Supervisors hereby waives inclusion of indirect
24 costs in the Agreement budget; and be it



5 the Agreement on behalf of the City; and, be it


6 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of




