2 **Resolution authorizing the Sheriff's Department to accept and expend a grant in the**  
3 **amount of \$15,000 from the State of California Controller's Office for funding**  
4 **technology-related acquisitions to enhance public safety.**

6 WHEREAS, In the 2002-2003 State budget, the State of California Controller's Office  
7 has made funding available through the California Law Enforcement Equipment Program  
8 (CLEEP) to ensure that all California's front-line peace officers have the resources they need  
9 in order to effectively fight crime and maintain order in the community; and,

10 WHEREAS, The grant will be used for funding new or updated technology-related  
11 acquisitions to enhance public safety; and,

12 WHEREAS, The San Francisco Sheriff's Department will use the grant to equip 41  
13 computers with licenses for Microsoft Office and Norton Anti-Virus software; and,

14 WHEREAS, The grant does not require matching funds; and,

15 WHEREAS, the Sheriff's Department proposes to maximize use of available grant  
16 funds on program expenditures by not including indirect costs in the grant budget; now,  
17 therefore, be it

18 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
19 the grant budget; and, be it


20 FURTHER RESOLVED, That a grant award notification has been received from the  
21 State of California; and, be it


22 FURTHER RESOLVED, That the City & County of San Francisco will adhere to the  
23 requirements of the State of California Controller's Office regarding the California Law


1 Enforcement Equipment Program (CLEEP) and all conditions specified in the grant




