1	[Resolution opposing Article 23 of the Basic Law in Hong Kong.]

3	Resolution opposing the proposed Article 23 legislation in Hong Kong.
4	
5	WHEREAS, On September 24, 2002, The Hong Kong Government published
6	proposals to implement Article 23 of the Basic Law, with the aim of enacting the relevant
7	legislation by July 2003; and,
8	WHEREAS, Article 23 of the Basic Law states: The Hong Kong Special Administrative
9	Region shall enact laws on its own to prohibit any act of subversion, secession, sedition,
10	subversion against the Central People's Government, or theft of state secrets, to prohibit
11	foreign political organizations or bodies from conducting political activities in the region, and to
12	prohibit local political organizations or bodies from establishing ties with foreign political
13	organizations or bodies; and,
14	WHEREAS, The Hong Kong government is not a republican form of government
15	democratically elected by the people it purports to govern; and
16	WHEREAS, Article 23 contains overbroad and vague language which could invoke
17	criminal prosecution and philosophical persecution based on expression of personal opinions
18	which, once passed into law, would seriously threaten an individual's fundamental rights of
19	freedom of information, belief, expression and peaceful association; and,
20	WHEREAS, Approximately 70% of the civic demonstrations in Hong Kong are from
21	union based organizations who often rely on freedom of association and peaceful assembly to
22	achieve their goals, it is likely that, with the implementation of Article 23, the very existence of
23	a union could be seen as a form of "sedition" and "subversion"; and,
24	WHEREAS, The vague and ambiguous wording of Article 23 could limit freedom of
25	thought, scholarly teaching and open discussion of ideas of the people of Hong Kong; and,

1	WHEREAS, The adoption of Article 23 could create a heavy-handed political
2	environment and seriously impact the investment and business environment in Hong Kong by
3	damaging Hong Kong's position, reputation, and prosperity as the most envied port of free
4	trade in the international market; and,
5	WHEREAS, When President Jiang Zemin of China first described the Falun Gong as
6	an "evil cult", the Chinese People's Congress immediately established the so-called "anti-cult
7	laws" which have been used as the basis to persecute its practitioners and will likely use the
8	same pretext under Article 23 to begin persecution of Falun Gong practitioners in Hong Kong;
9	and,
10	WHEREAS, On December 15, 2002, approximately 60,000 Hong Kong citizens took to
11	the streets in opposition to Article 23, and were joined philosophically by a dozen San
12	Francisco Bay Area organizations including the San Francisco Hong Kong Young People
13	Leadership Association, the Society of Hong Kong and Chinese Affairs-University of California
14	Berkeley, the Alliance of Hong Kong Chinese in the United States, the Asian Pacific American
15	Labor Alliance (APALA)- San Francisco Chapter, the San Francisco Freedom Forum, and
16	Chinese Democracy Education Foundation by holding a series of events unanimously
17	opposed to Article 23; and,
18	WHEREAS, These aforementioned organizations appeal to Chinese Nationals and
19	expatriates and other concerned people in San Francisco and the Bay Area to show their
20	concern regarding Article 23; now therefore, be it,
21	RESOLVED, That the City and County of San Francisco reaffirm our belief that
22	freedom of speech, the right to organize and peacefully assemble are essential rights of all
23	people; and be it,

FURTHER RESOLVED, That the City of San Francisco cautions that the adoption of

Article 23 abridges these rights; and be it,
