3 **Resolution approving the award and execution of San Francisco Municipal Railway**  
4 **Contract Number CCO 05-914, Municipal Transportation Quality Review, to**  
5 **Nelson\Nygaard Consulting Associates, to conduct the Quality Review required under**  
6 **Charter Section 8A.107, for a total contract amount not to exceed \$50,000 and for a**  
7 **term of two years, with an option to extend up to an additional two years to cover the**  
8 **next review period.**

10 WHEREAS, Under City Charter Section 8A.107, every two years the Municipal  
11 Transportation Agency (MTA) must contract with a nationally recognized management or  
12 transportation consulting firm with offices in San Francisco for an independent evaluation of  
13 the quality of Muni's operations; and

14 WHEREAS, MTA issued a Request for Proposals on March 9, 2005 and received one  
15 written proposal on April 6, 2005; and

16 WHEREAS, Nelson\Nygaard's proposal was responsive, and the firm was determined  
17 to be qualified to perform the review based on its auditing experience, familiarity with transit  
18 operations, and superior approach to reporting the audit results; and

19 WHEREAS, On July 19, 2005, the MTA Board of Directors approved the award and  
20 execution of a contract with Nelson\Nygaard Consulting Associates for performance of the  
21 Municipal Transportation Quality Review, Resolution No. 05-177, a copy of which is on file with  
22 the Clerk of the Board of Supervisors in File No. 060058 , which is hereby declared to be a  
23 part of this resolution as if set forth fully herein; and

24 WHEREAS, City Charter Section 8A.107 requires that the contract also be approved by  
25 the Controller and the Board of Supervisors; and

1           WHEREAS, The Controller approved the contract on August 4, 2005; now therefore be  
2 it

3           RESOLVED, That the Board of Supervisors approves the award and execution of  
4 Municipal Railway Contract No. CCO 05-914, Municipal Transportation Quality Review, with  
5 Nelson\Nygaard Consulting Associates, for a total contract amount not to exceed \$50,000,  
6 and for a term of two years, with an option to extend up to an additional two years to cover the  
7 next review period.




