3 **Resolution authorizing the Recreation And Park Department to accept and expend a**
4 **grant in the amount of \$50,000 from the California Integrated Waste Management Board**
5 **(CIWMB) for the installation of recycled-content materials and equipment in Alamo**
6 **Square.**

8 WHEREAS, It is in the best interest of the City and County of San Francisco to
9 promote waste prevention, reuse and recycling throughout the City and to reduce the amount
10 of material that is landfilled; and,

11 WHEREAS, The voters of California passed the Safe Neighborhood Parks, Clean
12 Water, Clean Air, and Coastal Protection Bond Act of 2000 (Villaraigosa-Keeley Act). This
13 act authorized the California Integrated Waste Management Board to establish a grant
14 program to: (1) Assist local agencies in meeting the state and federal accessibility standards
15 relating to public playgrounds; and (2) Conserve resources and develop markets for
16 recycled-content materials and equipment; and,

17 WHEREAS, The California Integrated Waste Management Board has been delegated
18 the responsibility for the administration of the program within the State, setting up necessary
19 procedures governing program applications; and,

20 WHEREAS, The CIWMB does not allow use of grant funds on indirect costs; now,
21 therefore, be it


22 RESOLVED, That the Board of Supervisors hereby authorizes the General Manager of
23 the Recreation and Park Department to accept and expend a grant in the amount of \$50,000
24 from the California Integrated Waste Management Board to fund projects relating to the


1 installation of recycled-content materials and equipment in Alamo Square located in the City
2 and County of San Francisco; and, be it


3 FURTHER RESOLVED, That Board of Supervisors hereby waives inclusion of indirect


