3 **Resolution urging the San Francisco Redevelopment Agency Commission to move it's**
4 **regularly scheduled meeting time from Tuesday to Monday.**

6 WHEREAS, The San Francisco Redevelopment Agency Commission meets every
7 Tuesday at 4:00 PM; and,

8 WHEREAS, The Board of Supervisors passed motion M02-159 which amended Rule
9 6.2 of the Board of Supervisors Rules of Order by scheduling regular meetings of the Board
10 of Supervisors on Tuesdays at 2 pm, instead of Mondays at 2 pm, effective the week of
11 February 2, 2003; and,

12 WHEREAS, KPOO, 89.5 fm, broadcasts live both the regularly scheduled meetings of
13 the San Francisco Board of Supervisors and the San Francisco Redevelopment Agency; and,

14 WHEREAS, KPOO receives funding from the San Francisco Redevelopment Agency
15 for broadcasting the agency's Commission hearings but does not receive funding by the
16 Board of Supervisors to broadcast it's meetings; and,

17 WHEREAS, Because of the Board's rule change, KPOO will no longer be able to
18 broadcast live the weekly meetings of the Board of Supervisors; and,

19 WHEREAS, Many members of the public, especially those involved in housing and
20 land-use issues, have an interest in issues before both the San Francisco Board of
21 Supervisors and the San Francisco Redevelopment Agency and often need to attend both of
22 their meetings; now, therefore, be it

23 RESOLVED, That the San Francisco Board of Supervisors urges the San Francisco
24 Redevelopment Agency Commission to move it's regularly scheduled meetings from
25 Tuesdays to Mondays.
