11 **Act; and making findings of consistency with the General Plan and the priority policies**  
12 **of Planning Code Section 101.1.**

16 Be it ordained by the People of the City and County of San Francisco:

17 Section 1. Findings. The Board of Supervisors of the City and County of San Francisco  
18 hereby finds and determines that:

19 (a) Pursuant to Planning Code Section 302, this Board of Supervisors finds that this  
20 ordinance approving a zoning map amendment in connection with a project sponsored by  
21 Habitat for Humanity for a proposed rezoning of 23 undeveloped parcels to create 12 building  
22 sites to develop 12 single-family dwellings for families earning no more than 60% of the area  
23 median income (the "Project") will serve the public necessity, convenience and welfare for the  
24 reasons set forth in Planning Commission Resolution No. 16798 recommending approval of  
25 this Zoning Map amendment, and incorporates such reasons by this reference thereto. A

3 (b) Pursuant to Planning Code Section 101.1, this Board of Supervisors finds that this  
4 ordinance is consistent with the priority policies of Section 101.1(b) of the Planning Code and  
5 the General Plan and hereby adopts the findings of the Planning Commission, as set forth in  
6 Planning Commission Resolution No. 16799, and incorporates said findings by this reference  
7 herein. A copy of said resolution is on file with the Clerk of the Board of Supervisors in File  
8 No. 040974.

9 (c) On May 27, 2004, the Planning Commission reviewed and considered the  
10 Mitigated Negative Declaration for the Project ("Neg Dec") and, by Motion No. 16798, found  
11 that the contents of the Neg Dec and the procedures through which the Neg Dec was  
12 prepared, publicized, and reviewed complied with the provisions of the California  
13 Environmental Quality Act ("CEQA"), the CEQA Guidelines, and Chapter 31 of the San  
14 Francisco Administrative Code. A copy of said motion is on file with the Clerk of the Board of  
15 Supervisors in File No. 040974.

16 (d) The Board of Supervisors hereby certifies that it has reviewed and considered the  
17 Neg Dec and the concurs with the Planning Commission's findings and conclusions in Motion  
18 No. 16798. The Board finds that the Neg Dec reflects the City's independent judgment and  
19 analysis and, on the basis of the whole record before it, finds that the Neg Dec is adequate  
20 and complete, and there is no substantial evidence that the Project would have a significant  
21 impact on the environment, and adopts the Neg Dec. Any and all documents referenced  
22 herein have been made available to and reviewed by the Board of Supervisors and may be  
23 found either in the files of the City Planning Department, as the custodian of records at 1660  
24 Mission Street in San Francisco, or in File No. 040974 with the Clerk of the Board of  
25 Supervisors at 1 Dr. Carlton B. Goodlett Place, San Francisco.

1 (e) On May 27, 2004, the Planning Commission held a duly noticed public hearing and  
2 in Resolution No. 16798, the Planning Commission recommended zoning map amendments  
3 associated with the Project. Said amendments and the Zoning Map change, a copy of which  
4 are on file with the Clerk of the Board of Supervisors in File No. 040974, are incorporated  
5 herein by reference as though fully set forth.

6 Section 2. Amendment of Sheet 12 of the Zoning Map. The following change in height  
7 district and adjustment of the boundary between this height district and the OS District, as  
8 shown on the Zoning Map attached hereto at Attachment 1, are hereby adopted as an  
9 amendment to Zoning Map Sheet 12 of the City and County of San Francisco:




