Dear SF Supervisors and staff,

I am a long-time San Francisco resident and an attorney, very recently retired from 36 years of death penalty defense work. I write to urge you all to support Supervisor Fielder's resolution calling on Governor Newsom to commute all death sentences.

The death penalty system is broken in myriad ways. One example of that is that literally hundreds of death-sentenced people in this state have been waiting 10, 15, or even 20 years for appointment of habeas corpus counsel to investigate and present any arguable claims on state habeas corpus, a proceeding to which they are entitled under California law. There is no realistic prospect of such counsel being appointed in the foreseeable future because there is no funding for such representation, which is very costly. Even if such funding were allocated, the number of attorneys qualified and willing to take these cases is small, and it would take decades to appoint counsel for all those currently unrepresented. These individuals are stuck in limbo, yet they remain sentenced to death, with the knowledge that a change in governor could mean the resumption of executions. No-one should have to live under sentence of death with no prospect of judicial review.

The prosecution of a capital case clogs up the courts at every level, slowing down justice for other litigants. The cost of putting and keeping someone on death row far exceeds the cost of keeping someone in prison for life. That money could be spent so much more profitably on other things.

Please support Supervisor Fielder's resolution and urge Governor Newsom to commute all death sentences.
