4 **and County of San Francisco.**

6 WHEREAS, Dr. Rolland and Kathryn Lowe, have provided lifelong support and
7 leadership in Chinatown and San Francisco through community service, philanthropy and
8 mentorship; and

9 WHEREAS, Dr. Rolland Lowe has dedicated his career to encouraging physicians to
10 work within their communities to become advocates for patients; providing high-quality
11 healthcare to low-income residents and tirelessly mentored young doctors until his retirement;
12 and

13 WHEREAS, Dr. Rolland Lowe is an extraordinary leader in philanthropy by
14 institutionalizing individual donor support towards Chinatown by utilizing his influence to
15 benefit the collective of non-profits in Chinatown; and

16 WHEREAS, Dr. Rolland Lowe has served as a board member for the Chinese Culture
17 Foundation for over 20 years, acting as the board president three separate times; was
18 instrumental in creating the Foundation's endowment through the generosity of his family; has
19 been a visionary leader which resulted in the establishment of the "Friends of Chinese Culture
20 Center;" and

21 WHEREAS, Kathryn Lowe has been an active voice and community supporter and has
22 served on the boards of Chinese for Affirmative Action, Chinese Hospital Auxiliary, and
23 Square and Circle Club; has been a lifelong outspoken proponent of social justice and

1 WHEREAS, Kathryn Lowe has encouraged, supported, and enabled her husband, Dr.
2 Rolland Lowe, to provide community service, philanthropy, and mentorship to the residents of
3 Chinatown; and

4 WHEREAS, Dr. Rolland and Kathryn Lowe are game changers who generously invest
5 their time and resources to nurture many non-profit leaders and address the concern of future
6 viability of services; have been forward thinking in the public sector's support of non-profits;
7 have had tremendous impact on Chinatown and San Francisco; now, therefore, be it

8 RESOLVED, That the San Francisco Board of Supervisors do hereby proclaim that the
9 pedestrian bridge linking the Chinese Culture Center to Portsmouth Square, as the "Dr.
10 Rolland and Kathryn Lowe Community Bridge" in the City of San Francisco to recognize Dr.


