Subject: Approval of Amendment No. 2 to the Rental Car Center Operations Lease Agreements with The Hertz Corporation; Avis Budget Car Rental, LLC; EAN-Northern California, LLC; DTG Operations, Inc.; and Fox Rent A Car, Inc.

Dear Ms. Calvillo:

Pursuant to Section 9.118 of the City Charter, I am forwarding for the Board of Supervisors' approval Amendment No. 2 to Lease Agreements with The Hertz Corporation; Avis Budget Car Rental, LLC; EAN-Northern California, LLC; DTG Operations, Inc.; and Fox Rent A Car, Inc. This Amendment was approved by the Airport Commission Resolution Nos. 13-0088, 13-0089, 13-0090, 13-0091, and 13-0092.

This Amendment (1) allows for the early termination of the Leases under certain circumstances; (2) approves the co-location of family brands during the 2014 reallocation of space; (3) approves the exclusion of toll collection charges from the definition of Gross Revenues; (4) revises the Space and Structure Rent calculations; and (5) authorizes the Airport Director to approve subleasing requests between on-Airport operators at his or her discretion.
