

1 [Establishing Monthly Contribution Amount.]

3 **Resolution establishing monthly contribution amount to Health Service Trust Fund.**

5 WHEREAS, Pursuant to Section A8.423 of Appendix A to the City Charter, the Health  
6 Service Board (the "HS Board") is required to conduct a survey of the ten counties in the State  
7 of California, other than the City and County of San Francisco, having the largest populations  
8 to determine the average contribution made by each such county toward the providing of  
9 health care plans, exclusive of dental or optical care, for each employee of such county; and

10 WHEREAS, Pursuant to such Charter Section, the HS Board is required to certify to  
11 the Board of Supervisors "the average contribution" (as such term is defined in such Charter  
12 Section) as determined by such survey; and

13 WHEREAS, According to the California Department of Finance, the ten most populous  
14 counties in the State of California other than San Francisco (in descending order of  
15 population) are: Los Angeles, San Diego, Orange, Santa Clara, San Bernardino, Riverside,  
16 Alameda, Sacramento, Contra Costa and Fresno (collectively, the "Survey Counties"); and

17 WHEREAS, Under the survey of each of the Survey Counties which was completed on  
18 January 9, 2003, (a copy of which is on file with the Clerk of the Board of Supervisors in File  
19 No. 030031, which is hereby declared to be a part of this resolution as if set forth fully herein,  
20 the HS Board has determined that "the average contribution" is the sum of Two Hundred  
21 Eighty-One Dollars and Twenty-One Cents (\$281.21); and;

22 WHEREAS, Pursuant to such survey, the HS Board has certified "the average  
23 contribution" to the Board of Supervisors as required under Section A8.423 of Appendix A to  
24 the City Charter; now, therefore, be it

1 RESOLVED, That the certification by the HS Board of "the average amount" is hereby  
2 accepted and shall constitute the monthly amount to be contributed to the Health Service  
3 Trust Fund for Fiscal Year 2003-2004 pursuant to the Charter.


