2 ADDING SECTION 32.6.20 TO THE SAN FRANCISCO TRAFFIC CODE, REGARDING
3 PARKING REGULATIONS ON A PORTION OF 7th STREET.


4 Note: This entire section is new.

5 Be it ordained by the people of the City and County of San Francisco:

6 Section 1. Article 3 of the San Francisco Traffic Code is hereby amended by adding
7 Section 32.6.20 thereto to read as follows:

8 **SEC. 32.6.20. PARKING CONTROL, PORTION OF 7th STREET; PENALTIES FOR**
9 **VIOLATION.** No person shall stop, park, or leave standing any vehicle, whether attended or
10 unattended, on the east side of 7th Street, from Bryant Street to 80 feet southerly (80-foot
11 zone), except official City-owned vehicles displaying a valid permit issued by the Enforcement
12 Division of the Department of Parking and Traffic authorizing parking in such zones. The
13 permit exceptions under this Section shall not apply when parking prohibition regulations for
14 street-cleaning purposes are in effect. Violation of this Section is an obstruction to the free use
15 of property and a nuisance within the meaning of Division 4, Part III of the Civil Code of
16 California relating to nuisance and the abatement thereof.


